





Preface

THIS STUDY IS QUITE AN AMBITIOUS PROJECT: To retrace the long and complex history of the Aristotelian conceptual distinction between distributive and corrective justice from antiquity to the present day. True, for many centuries Aristotle's works on ethics have laid rather dormant, but their revival in medieval times constituted a major event in the Latin Christian world. Thus. Aristotle's Nicomachean Ethics became an important source in scholasticism. No wonder that Aristotle's analysis of the notion of justice as one of the cardinal virtues attracted the attention of the scholastics and provoked protracted discussions and controversies. A vast literature was the result. a literature which is of no easy access to the contemporary scholar. Not only many works have remained in manuscripts, dispersed in libraries all over the Christian world, but also many of the printed works are rare books guarded in a great number of libraries. A taste of the richness of that literature one can get from the recent important work of David A. Lines, *Aristotle's* Ethics in the Italian Renaissance (ca. 1300-1650): The Universities and the Problem of Moral Education (Leiden 2002), where the list of Latin works on the Nicomachean Ethics in Italy alone comprises more than 170 items. If we add other countries, like Spain, France, Belgium and Germany, the numbers would go into many more hundreds. I, therefore, had to limit the scope of the studied literature. The result was a concentration on the printed books that were accessible to me. This criterion inevitably caused a certain amount of arbitrariness. However, I am convinced I have succeeded in giving a genuine and rather complete picture of the scholastic literature. This sentiment is based upon the fact that the discussions of some of the late scholastics refer in great detail to the whole relevant literature. By studying them, it is highly probable that very little has been overlooked, and most likely nothing of importance. The same appears to be true for the rich postscholastic literature.

The work on this project extended over many years and I owe thanks to a great number of persons and institutions. First, I would like to thank the

Introduction

ARISTOTLE IN THE FIFTH BOOK of his Nicomachean Ethics analyzes the notion of justice as a virtue. Justice as complete virtue is called by him legal or universal justice; justice as partial virtue is called particular justice. Inside the notion of particular justice, Aristotle makes the seminal distinction between distributive justice and corrective justice. The idea is that there are basically two different situations that require two different kinds of justice. In a very general and simplistic way, one could say that the difference is between a situation where justice is oriented towards creating a new state of affairs (distributive justice), and one where its purpose is to restore a certain equilibrium (corrective justice). Aristotle defines some characteristic features that make the difference between the two kinds of particular justice: distributive justice follows a geometric proportion according to the respective merits of the recipients; the transactional equality under corrective justice is according to an arithmetical proportion. As a result, the latter treats the litigants as equal, whatever their prior virtues and merits may have been. On the contrary, under distributive justice, the prior merits of the parties are at the basis of their original rights.

In this book we retrace the history of this distinction between corrective and distributive justice: its interpretation and use from antiquity to the present day. Our endeavor is what in German is called "Begriffsgeschichte", the history of concepts. It assumes that the meaning of terms is imbedded in cultures. In our context, we will map throughout the ages the fundamental controversies about the understanding and significance of the distinction, and, most importantly, the different and changing purposes of its use.

Two important restrictions on the scope of our scholarly enterprise: First, we take the text of Aristotle as transmitted to the later ages. Hence, we are not concerned with the complex, manifold and controversial textual and philological questions of Aristotle's work. Neither do we deal with the philosophical sources of the author nor, more specifically, with the relationship to Plato's work. These topics have been treated extensively by experts of classic

literature and philosophy. Second, we retrace the history of the use of the conceptual distinction in its formal dimensions without going into the substance of the respective notions of justice. Thus, e.g. the concept of merit is central to distributive justice, but in Aristotle's own understanding its substance varies with the different forms of the political regime. The same phenomenon exists in relation to corrective justice: the restoration of a disrupted equilibrium is conditioned upon the unjustness of the disruption. However, the basis of that unjustness must be found in a substantive value system that transcends the formal concept of corrective justice. We will describe the modern attempts to integrate form and substance, but we will reserve judgment on the validity of the substance of justice as such.

As a matter of fact, the amazing modern revival of the Aristotelian distinction—especially in the U.S. tort scholarship—is at the origin of our idea to inquire into its history. Starting in the 1970s, the classic distinction "conquered" the minds of American legal scholars and literally hundreds of papers, a symposium, and many chapters in books, were dedicated to the topic. The vigor of this trend is not yet abating. We thought that a look into the work and the minds of earlier generations might deepen our understanding of the modern concerns. Moreover, we might even learn something about the very nature of the distinction and its inherent problems. The results of the historical enquiry went far beyond our expectations. It turned out that Aristotle's conceptual idea has occupied the most brilliant philosophical, legal, and theological minds for generations.

In the light of the enormous amount of relevant literature—and as stated in the Preface—we limited ourselves to the printed books, but the problem arose of how to proceed in presenting the vast historical material. The option is between a topical and a chronological arrangement. We found the first possibility impractical because of its complexity. Moreover, in many instances the author's basic viewpoint directly influences his conclusions in relation to a variety of topics. We chose, therefore, the chronological order that has the great advantage of placing the views of the individual authors into a given historical period. A certain disadvantage of this way lies in the inevitable repetitiousness of topical issues. However, it is outweighed by the integral description of the individual scholar's outlook. In some instances, we deviated slightly from the strict chronological sequence in order to describe related views in proximity.


We didn't apply any prior selection among the very great number of authors dealing with the Aristotelian notions of justice, but presented in the book all of those whose work we could find in the libraries. As mentioned in the Preface, we didn't succeed in finding all the books—some of which are mentioned by past authors—but we believe that at least all the important ones are treated in our work.

The manifold views are presented in a neutral, objective way. The result of our scholarly endeavor is, therefore, somewhat encyclopedical. We intended to bring before the reader the immense richness of past literature, that to a great part is practically inaccessible, and leave it to him to evaluate the content and, if appropriate, to draw conclusions in relation to contemporary discussions. The reader will find plenty of criticism in the writings of the authors. However, some central themes of scholasticism are hardly relevant anymore for most of the modern readers, such as the problem of whether Divinity is subject to corrective or distributive justice. We limited our own few critical comments to some views of contemporary authors in tort law.

The book is divided into seven chapters. Five of them are chronologically linked: The Starting Point: Aristotle's Classification of Justice; High Scholastics; Late Scholastics; Post-Scholastic Writers; and The Modern Use of Aristotle's Forms of Justice. Two chapters deal with specific issues: A Special Theological Problem: Divine Justice; and Jewish Commentators. These two chapters are equally internally arranged according to a chronological order. The five chapters indicate a hiatus of more than one thousand years between Aristotle's *Ethics* and medieval commentators. None of the ancient commentaries has been preserved.

In the appendix we deal with the iconography of the two kinds of justice as depicted by the famous fourteenth-century fresco cycle of Ambrogio Lorenzetti in the Palazzo Pubblico of Siena, Italy. We believe that our research may help to resolve one of the problems that arose from Lorenzetti's inclusion of punishment in the representation of distributive justice. The appendix deals also with miniatures in two fourteenth-century illustrated manuscripts of Oresme's translation into French of Aristotle's *Nicomachean Ethics* that was presented to the French King Charles V.

May we add a personal note: The discourse with all these outstanding scholars of past times was for us a wonderful intellectual experience. It taught us modesty toward our own mental capacities.



The Starting Point

Aristotle's Classification of Justice

ARISTOTLE'S FAMOUS ANALYSIS of the notion of justice in the Fifth Book of his *Nicomachean Ethics* remains unsurpassed.¹ It has exercised an enormous influence throughout the ages and remains relevant to this very day.² Aristotle's starting point is the concept of virtue: justice can be a complete virtue or a partial one. Justice as complete virtue is called by him the legal or universal justice; justice as partial virtue is called particular justice.³ The distinction between these two virtue-related notions of justice can be better illustrated by referring to their opposites: manifold vices, such as lasciviousness, cowardice, and anger; hence, universal justice is reached by overcoming these different vices. Particular justice, on the other hand, means the

overcoming of a particular vice, namely that of desiring more than what belongs to oneself (*pleonexia*).⁴ The outcome of that vice is inequality; hence, particular justice is the justice of equality (*iustitia aequalitatis*).⁵ It has been suggested that the Aristotelian basic distinction between universal (legal) justice and particular justice may have its origin in the ancient dual divinities of Themis and Dike, one representing the divine-royal commandments, the other the law immanent in humanity.⁶ On the other hand, it is noteworthy that Aristotle in defining the "legal" justice does not elaborate on the specific content of that general law and its relationship to ethics. He seems to emphasize the mental attitude and the habit of abiding by the law of the state as the basis of all virtue, without examining the inherent value of the specific legal system. The latter may, indeed, be only incompletely just and, therefore, of merely hypothetical (relative) value.⁷

Inside the notion of particular justice, Aristotle makes the seminal distinction between distributive justice and corrective justice, which is the topic of this essay. The terms "distributive" and "corrective" have come down to us through the medieval Latin translations of Aristotle's *Nicomachean Ethics*, especially through the influential commentary on that book by the great scholastic philosopher and theologian Thomas Aquinas (1225–1274).

Aristotle himself used for distributive justice the Greek term "dianemetic." The concept of corrective justice is more complex. Aristotle uses the terms of "diorthotic" and "epanorthotic." In Latin, this kind of justice has received a great number of translations, among them: *iustitia regulativa, directiva, correctiva, correctiva, commutativa, commutatrix, rectificativa, emendativa,* and *iustum in corrigendo.* Hugo Grotius (1583–1645) called it *iustitia expletrix,* whereas for the other (distributive) form of justice he used the term *attributrix.* The corresponding notion in other European languages reflects generally these traditional translations, but one finds also some modern ideas like "interactive justice."

For the better understanding of later manifold uses and interpretations of the Aristotelian distinction concerning the forms of justice, it is vital to give first a short description of Aristotle's ideas on this topic as expressed in his *Nicomachean Ethics*.

Let us quote the basic relevant passages concerning the said distinction:

Particular justice on the other hand, and that which is just in the sense corresponding to it, is divided into two kinds. One kind is exercised in the distribution of honour, wealth, and the other divisible assets of the community, which may be allotted among its members in equal or unequal shares. The other kind is that which supplies a corrective principle in private transactions. This Corrective Justice again has two sub-divisions,

corresponding to the two classes of private transactions, those which are voluntary and those which are involuntary. Examples of voluntary transactions are selling, buying, lending at interest, pledging, lending without interest, depositing, letting for hire; these transactions being termed voluntary because they are voluntarily entered upon. Of involuntary transactions some are furtive, for instance, theft, adultery, poisoning, procuring, enticement of slaves, assassination, false witness; others are violent, for instance, assault, imprisonment, murder, robbery with violence, maiming, abusive language, contumelious treatment.¹⁴

Describing in more detail the idea and form of distributive justice, he says:

It follows therefore that justice involves at least four terms, namely, two persons for whom it is just and two shares which are just. And there will be the same equality between the shares as between the persons, since the ratio between the shares will be equal to the ratio between the persons; for if the persons are not equal, they will not have equal shares; it is when equals possess or are allotted unequal shares, or persons not equal equal shares, that quarrels and complaints arise. This is also clear from the principle of "assignment by desert." All are agreed that justice in distribution must be based on desert of some sort, although they do not mean the same sort of desert; democrats make the criterion free birth; those of oligarchical sympathies wealth or in other cases birth; upholders of aristocracy make it virtue. ¹⁵

Thus the just involves four terms at least, and the ratio between the first pair of terms is the same as that between the second pair. For the two lines representing the persons and shares are similarly divided; then, as the first term is to the second, so is the third to the fourth; and hence, by alternation, as the first is to the third, so is the second to the fourth; and therefore also, as the first is to second, so is the sum of the first and third to the sum of the second and fourth. Now this is the combination effected by a distribution of shares, and the combination is a just one, if persons and shares are added together in this way. The principle of Distributive Justice, therefore, is the conjunction of the first term of a

proportion with the third and of the second with the fourth; and the just in this sense is a mean between two extremes that are disproportionate, since the proportionate is a mean, and the just is the proportionate. This kind of proportion is termed by mathematicians geometrical proportion; for a geometrical proportion is one in which the sum of the first and third terms will bear the same ratio to the sum of the second and fourth as one term of either pair bears to the other term. Distributive justice is not a continuous proportion, for its second and third terms, a recipient and a share, do not constitute a single term. ¹⁶

The notion of corrective justice appears to be more complex:

The remaining kind is Corrective Justice ($\delta\iota o\rho\theta\omega\tau\iota\kappa d\nu$), which operates in private transactions, both voluntary and involuntary. This justice is of a different sort from the preceding. For justice in distributing common property always conforms with the proportion we have described since when a distribution is made from the common stock, it will follow the same ratio as that between the amounts which the several persons have contributed to the common stock; and the injustice opposed to justice of this kind is a violation of this proportion. But the just in private transactions, although it is equal in a sense (and the unjust the unequal), is not the equal according to geometrical but according to arithmetical proportion. For it makes no difference whether a good man has defrauded a bad man or a bad one a good one, nor whether it is a good or a bad man that has committed adultery; the law looks only at the nature¹⁷ of the damage, treating the parties as equal, and merely asking whether one has done and the other suffered injustice, whether one inflicted and the other has sustained damage. Hence the unjust being here the unequal, the judge endeavours to equalize it: inasmuch as when one man has received and the other has inflicted a blow, or one has killed and the other been killed, the line representing the suffering and doing of the deed is divided into unequal parts, but the judge endeavours to make them equal by the penalty or

loss he imposes, taking away the gain. For the term "gain" is used in a general way to apply to such cases, even though it is not strictly appropriate to some of them, for example to a person who strikes another, nor is "loss" appropriate to the victim in this case; but at all events the results are called "loss" and "gain" respectively when the amount of the damage sustained comes to be estimated. Thus, while the equal is a mean between more and less, gain and loss are at once both more and less in contrary ways, more good and less evil being gain and more evil and less good loss; and as the equal, which we pronounce to be just, is, as we said, a mean between them, it follows that Justice in Rectification (ἐπανορθωτικὸν) will be the mean between loss and gain. ¹⁸

We shall pause here for a moment in order to point out, and comment upon, some of the central issues of the Aristotelian text.

The distinction between the two forms of justice seems to be an original idea of Aristotle. There might be a certain affinity with Plato's observation on two kinds of justice in the distribution of goods between the members of the *polis*, one distribution by lot and the other on the basis of geometric equality. However, whereas in Plato's view, the former kind is one of inferior justice, in Aristotle's conception both forms of justice, distributive as well as corrective justice, are equally implementing the idea of strict equality. In other words, distributive and corrective justice are equally appropriate to achieve justice, though each in a different way as required by the different basic situation. ²⁰

In Aristotle's conception, distributive justice is based, as mentioned in the quotation above, on desert, merit ($\acute{\alpha}\xi \acute{\alpha}$, axia). The author explicitly mentions a variety of criteria, each according to the different political system: freedom (democracy), wealth or nobility (oligarchy), and virtue (aristocracy). It is noteworthy that Aristotle identifies here democracy with the merit of freedom, whereas in his *Politics*, ²¹ he founds democracy on the absolute equality of all citizens, and hence a distributive justice based on numerical equality. In any event, it clearly follows that Aristotle's concept of distributive justice is a purely formal one, since the "merit" at its basis differs according the political system. ²²

The concept of corrective justice appears to be much more complex. Aristotle distinguishes between two transactional relationships, one voluntary and the other involuntary.²³ In both, the form of corrective justice is applicable. It has been noted that the term "corrective" is better suited to involuntary transactions than to voluntary ones.²⁴ In fact, some scholastics used for the general description of the two forms of (corrective) justice the Latin term of *iustitia directiva*.²⁵ However, the most common Latin term throughout the ages was *iustitia commutativa*.

Aristotle describes a number of important distinctive features of corrective justice as compared to distributive justice: First, the different nature of equality. In relation to distributive justice the equality is a "geometric" proportion between four terms, being based on a criterion of respective

merit. Thus, the ratio of the merits between two persons should be proportional to the ratio of the distributed goods among them. The equality in the framework of corrective justice is an "arithmetic proportion" between supposedly two terms. Corrective justice's aim is to restore the original positions of both the person who suffered the loss and the person who gained the profit at the other's expense. Aristotle describes the "correctively just" as the arithmetic mean between the part of the earner and the part of the loser.²⁶

A second distinctive feature of corrective justice is that the law considers only the extent of the damage caused; it, therefore, treats the litigant parties as equal, whatever their prior virtues and merits may have been.²⁷ This approach contrasts with that of distributive justice, where the prior respective merits of the parties are at the basis of their original rights.

Let us return to an additional, important passage of Aristotle, discussing the relationship between justice and retribution, called by him *antipeponthos* (ἀντιπεπονθὸς). The scholastics have translated the latter term literally into the Latin *contrapassum*²⁸; modern scholars prefer to use the term of reciprocity. ²⁹ Aristotle states:

The view is also held by some that simple Reciprocity is Justice. This was the doctrine of the Pythagoreans, who defined the just simply as "suffering reciprocally with another." Reciprocity however does not

coincide either with Distributive or with Corrective Justice . . . For in many cases Reciprocity is at variance with Justice: for example, if an officer strikes a man, it is wrong for the man to strike him back: and if a man strikes an officer, it is not enough for the officer to strike him, but he ought to be punished as well. Again, it makes a great difference whether an act was voluntary or involuntary [done with or without the consent of the other party]. But in the interchange of services Justice in the form of Reciprocity is the bond that maintains association: reciprocity, that is, on the basis of proportion, not on the basis of equality.³⁰

As we shall see later, this passage created considerable difficulties of interpretation. Thus, the example of the officer who hits another man or is hit by him seemed to contradict Aristotle's own assumptions about the nature of commutative justice. Indeed, one of the major problems concerned the exact relationship of retribution (punishment) to the other two forms of justice. Not surprisingly, a number of conflicting solutions have been advanced throughout the ages: (1) retribution makes part of distributive justice; (2) it is part of corrective justice; (3) it is a third form of justice; (4) it is a distinct idea

that can be applied to the basic two forms of particular justice. The controversy has not been resolved until this very day. 31

A final comment on the formal character of the Aristotelian distinctions of distributive and commutative justice³²: Hans Kelsen claimed, in a critical analysis of Aristotle's notions of justice, that their formal essence constitutes an ideological basis for justifying the existing, substantive legal order.³³ Against this critique it has been argued that Aristotle's philosophical approach was fundamentally one of practical hermeneutics, based upon a common sense view of human society. It had no aspiration whatsoever to rationally define universal ethical rules in the Kantian spirit.³⁴

High Scholastics

THE RELATIVELY FEW EARLY GREEK COMMENTATORS On Aristotle's *Ethics*, whose writings were preserved,³⁵ did not add much to the distinction between the two forms of justice. Unfortunately, the commentary of Aspasius (ca. 100–150) on the relevant Book Five of the *Nicomachean Ethics* has not been preserved³⁶; the same is true for Eustratius (ca. 1050–1120).³⁷ The other authors, whose writings came down to later generations, basically relied on the original text of Aristotle.³⁸ Of some influence in relation to Aristotle's distinction of justice, is the commentary of Michael of Ephesus (eleventh to twelfth centuries).³⁹

After the important rediscovery of Aristotle's writings by Arab philosophers in the early medieval era, ⁴⁰ these authors, equally, repeated the former's view about the two forms of justice without much further analysis. ⁴¹ A good example is the important Arab philosopher Averroes (Ibn Rushd) (1126–1198), who wrote the *Middle Commentary on Aristotle's Nicomachean Ethics*. ⁴² In relation to our topic, this author basically restated the thoughts of Aristotle. One short comment of his is nevertheless noteworthy. It concerns the abovementioned example of the officer who hits a citizen or is hit by him. Averroes notes the apparent contradiction in Aristotle's work about the nature of equality in retribution, namely the taking into account of a person's prior status. His answer is that the difference in the solution is a result of the different measure of damage. ⁴³

The situation changed dramatically in the Christian West in the twelfth and thirteenth centuries in the wake of the Latin translations of Aristotle's *Ethics* as well as those of some Arabic commentaries.⁴⁴ The reception of Aristotle's works constituted, indeed, a major event in Western thought creating the central intellectual movement of scholasticism. It put into focus the vexing problem of the relationship between theology and philosophy. Among the manifold issues dealt with by the scholastics, we find also

the notion of justice. The scholastics went into the moral and theological foundations of justice on the background of the classical definitions, among them the more formal Aristotelian concepts. The relationship between the universal (or legal) justice and the particular justice became also an important topic for scholastic and post-scholastic scholars. However, given the limited framework of this work, we will concentrate on the specific use of the Aristotelian distinction between distributive and commutative justice.

This brings us to an incidental remark concerning the place of Roman law in our specific context. In Justinian's *Digesta* there is a famous definition of justice in the name of Ulpian: "*Constans e perpetua voluntas ius suum cuique tribuens*." There exists an age-old, fundamental controversy among scholars as to what extent Roman jurisprudence and law in general, and this definition in particular, were influenced and inspired by Aristotle's writings and by Greek philosophy. Be that as it may, the fact remains that this traditional Roman law definition did not use the Aristotelian bipartite division of particular justice. Hence, Roman law as such did not contribute anything to the understanding of the distinction between distributive and corrective justice. As we will see in the later developments, the reaction of Roman law jurists to the Aristotelian distinction moved from its positive identification with Ulpian's definition, through indifference to open hostility.

Returning to the early scholastics, foremost mention must be made of the German Dominican scholar Albertus Magnus (1206–1280), who was one of the first authors to write an extensive commentary on Aristotle's *Nicomachean Ethics*.⁴⁹ He dealt with the problem of the exact relationship between the two

notions of (particular) justice. In this context he referred to Cicero's general definition of justice that equally mentioned dignity, but as a common element of justice; the author distinguished this more general notion of dignity from the specific use made by Aristotle's analysis.⁵⁰ Moreover, Albertus Magnus discussed a number of additional traditional definitions of justice.⁵¹ Another major concern of that author was the relationship between justice and virtue. He specifically referred to the argument that denied justice of constituting a virtue, since the mean of justice related to things, whereas the mean of virtue concerned persons. The author's answer is significant: Nothing prevents the medium of a thing to be also the medium in relation to persons. This is the situation in respect of justice. The mean of our actions is that of our passions. In the case of commutative justice, the mean is not conceived to be different in relation to different persons, except where the damage itself varies, and not because of the person's condition. Thus, where a prince has been hit, the whole community suffers, because he is a public person; this would not be true where a private person had been hit. Correspondingly, when a prince hits somebody, there is less shame than if another person had hit him, because the prince, in view of his jurisdiction, has a kind of justice mixed in, which the other person has not.52

However, in spite of a number of important clarifications, Albertus Magnus basically followed Aristotle's way of expounding the distinction between commutative and distributive justice.⁵³

A deeper and more critical analysis of the Aristotelian distinction was undertaken by the most eminent disciple of Albertus Magnus, the Dominican Thomas Aquinas (1225–1274), the dominant figure of scholasticism whose decisive influence lasted for centuries. In his major work, the *Summa Theologiae*, Thomas, in responding to specific questions, expounds more analytically the distinction between the two forms of justice.⁵⁴ In relation to distributive justice, the author notes that here common property is distributed to the individual according to the latter's excellence (*principalitas*) in

the community.⁵⁵ The mean according to distributive justice is not determined according to the equality between things, but according to the proportion between things and persons.⁵⁶ However, Aquinas observes that distribution of common goods is sometimes made not from goods belonging to the state, but to a single family; in the latter case, the distribution of the common goods can be made by the authority of a private person.⁵⁷

In this context, however, it had been remarked that Aristotle, in discussing retribution (ἀντιπεπονθὸς), apparently contradicted himself. He criticized, on the one hand, the Pythagorean principle of retribution because it did not take into account the social status of the wrongdoer and that of the injured person (ordinary man and officer). On the other hand, in his earlier discussion of corrective justice, Aristotle emphasized that the law looks only at the nature of the damage, treating the parties as equal.

Thomas Aquinas, both in his major work *Summa Theologiae*⁵⁸ and in his *Commentary on the Nicomachean Ethics*, referred to this apparent contradiction in Aristotle. In his *Commentary*, Thomas Aquinas, after stating the problem, ⁵⁹ suggested—probably influenced by his teacher Albertus Magnus⁶⁰—that the

solution was to be found in the nature of the damage. Corrective justice (called by Thomas as mentioned: *iustitia commutativa*) was directed in cases of injuries toward the compensation of the damage. However, in case of personal injury, this damage might differ according to the social status of the injured person. Hence, equal compensation (retribution) in all cases of this kind would be wrong. Thomas mentioned in this context that hitting a superior officer implied, in addition, damage to the state. However, where there was damage to exterior things, equal compensation would be just, since the damage was independent of the person involved.⁶¹

In the *Summa Theologiae* the relevant question posed was the following: Apparently the dignity of a person is relevant both in distributive justice and in corrective justice, since in the latter, the punishment is more severe for a person who hits a prince than for one who hits an ordinary person. How can this be explained on the background of Aristotle's distinction between geometric and arithmetic proportion, the latter being the characteristic feature of corrective justice?⁶² The answer given is that in relation to acting and suffering, the quantification of the thing [damage] differs, whereas in distributive justice the position of the person as such is taken into account.⁶³

A special article is dedicated to the relationship between retribution (*contrapassum*) and the two forms of justice. The question posed is the following: Why should retribution not be considered the common principle of both forms of justice, since both refer to the merits of persons? Hence, why does Aristotle claim that there is no identity between justice and retribution? The answer given is the following: Retribution in corrective justice has different forms. One has to distinguish the causing of injuries to another person from voluntary transactions. But in both cases, the leading principle is equal retribution according to the circumstances. In case of wrongful acts, the punishment has to take into account the fact that injury has been caused not only to a private person, but also to the state by menacing the latter's protective security. In voluntary transactions, the retribution has to be made by a proportionate measure effectuated through money. In this way, retribution is commutative justice.

However, retribution does have no place in distributive justice. In the latter, equality is not measured according to the proportion between things, or according to the proportion between the suffering and the act, whence it is called "contrapassum"; but it is measured according the proportion between things and persons. ⁶⁷ Thomas adds that where a person receives compensation for his services to the community, it is commutative justice and not distributive justice. In the latter, a person does not receive benefits according to his expenditures, but according to his status in proportion to that of another person. ⁶⁸

Another objection raised in the *Summa Theologiae* against the Aristotelian distinction related to restitution is the following way:

Restitution is repayment of something taken away. Now something may be taken away from a man not only in commutation but also in distribution, as when, in distributing, one gives a man less than his due. Therefore restitution is not more an act of commutative than of distributive justice. ⁶⁹

The answer given to that objection is the following:

Compensation is made by the distributor to the man to whom less was given than his due, by comparison of thing with thing, when the latter receives so much the more according as he received less than his due: and consequently it pertains to commutative justice.⁷⁰

In summary, a number of things have to be noted in relation to Thomas Aquinas's interpretation of the Aristotelian distinction. Retribution (*contrapassum*, *antipeponthos*) is at the basis of corrective (commutative) justice. However, retribution is not a simple equal measure, as assumed by the Pythagoreans, but a proportionate measure, adapted to the circumstances that determine the specific quantum of damage. It includes punishment for misdeeds, the measure of which takes into account the violation of the public interest in the individual's security. In voluntary transactions, the tool that determines the proportional value of things is money. Here, Thomas Aquinas, in his *Commentary* on Aristotle's *Ethics*, adds: "But this one standard which truly measures all things is demand." This includes all commutable things inasmuch as everything has a reference to human need. Articles are not valued according to the dignity of their nature, otherwise a mouse, an animal endowed with sense, should be of greater value than a pearl, a thing without life. But they are priced according as man stands in need of them for its own use."

Finally, distributive justice's function is to distribute common goods exclusively according the respective status of citizens.

It is highly possible that the brief mentioning of "contrapasso" by Dante Alighieri (1265–1321) in his *Divine Comedy*⁷³ evokes the Aristotelian and scholastic concept of retribution in the context of divine justice.⁷⁴

Another important figure of High Scholasticism is the Franciscan scholar Johannes Duns Scotus (ca. 1265–1308), who did not hesitate to contest a number of Thomas Aquinas's theological and philosophical assumptions. In relation to the Aristotelian distinction, it is interesting to note that in one place Duns Scotus affirms that punitive justice has to be distinguished from commutative justice, since it is exercised neither for the sake of the punished nor for that of the punisher, but for the sake of the law and furthermore for that of the public good. However, in another place Duns Scotus affirms, when dealing with divine justice, that commutative justice has to do with punishment and reward, so that rewards are dealt out as if in compensation for merits and punishments for sins. He adds that commutative justice

cannot be in God in an unqualified sense with respect to creature, since there cannot be equality between them in an unqualified sense. But in a way there can be equality according to proportion, as between a master and his slave. For it is fitting for a generous master to reward his slave with a greater good than the slave can actually deserve, and yet his doing so is still in keeping with proportion: just as the slave does what is his to do, the master repays him with what is his to give; and the same is true in punishing him less than he deserves.

Distributive justice, on the other hand, can be in God in an unqualified sense, since in an unqualified sense he can give natures the perfections that are due to or suitable for them in accordance with the levels [of goodness] that make them perfect [after their kind].⁷⁸

Later commentators have made an effort to reconcile the two passages.⁷⁹ Among them the Polish Franciscan scholar Marianus Costenus deserves special mention.⁸⁰ He argues that only commutative justice is a real and proper kind of particular justice, since both distributive and vindictive justice cannot be counted as veritable kinds of justice. Distributive justice concerns the distribution of common goods according to a geometric proportion.

However, the individual citizens don't have a strict right to these goods. Likewise, the dignity of persons is not an object of justice, but merely of the virtues of deference and respect. Thomas Aquinas teaches that favoritism (acceptio personarum) is the opposite of distributive justice; but according to him the rendering of reverence and honor is not a kind of strict justice, but belongs to what he calls "potential" parts of justice. Duns Scotus, when dividing justice into legal, commutative, distributive, and vindictive justice, emphasizes the aspect of the "other-directness" (ad alterum) of these virtues. He intends, therefore, to use the term justice in its wide sense—like he does

in relation to friendship, obedience, and goodness—and not justice in its strict sense. Hence, distributive justice is not a proper kind of justice.⁸¹

The same is true for vindictive justice. ⁸² Vindictive justice may be directed toward the good of the revenging person, then it constitutes an act of charity against oneself; or it may be directed toward the good of another person, then it may be an act of friendship. As a result, vindication may be an act of different virtues. If it concerns the common good, then it enters the category of "legal justice," since its immediate objective is the preservation of the law.

The author then quotes the above-mentioned apparently contrary statement of Duns Scotus, where the latter qualifies punishment as a kind of commutative justice. Costenus relies on Duns Scotus's wording of "quasi commutando," affirming that accordingly vindication is not a proper act of commutative justice, but merely by a kind of imitation. In conclusion: Vindictive justice is not a specific kind of particular justice; the only real kind of particular justice is commutative justice, since it is based upon a strict duty-right relationship. At the contract of the particular justice is commutative justice, since it is based upon a strict duty-right relationship.

It seems that Duns Scotus's view on punitive justice being part of distributive justice was accepted by a great number of later scholastics and scholars. Thus, in a general commentary on Aristotle's *Nicomachean Ethics* made by scholars of the Coimbrian school, it is assumed, without further discussion, that punitive and remunerative justice fall into the category of distributive justice. ⁸⁵

Interestingly, a different view on the classification of punitive justice was voiced by Fra Domenico Cavalca (ca. 1270–1342), the Italian Dominican writer of spiritual treatises in the vernacular. In his famous *Lo Specchio della Croce*, ⁸⁶ he considers vindictive justice to be a third kind of justice besides commutative and distributive justice. ⁸⁷ He affirms that on the cross Christ demonstrated all three forms of justice. ⁸⁸



Another influential High Scholastic scholar is the French philosopher and scientist Johannes Buridanus (Jean Buridan) (ca. 1300–ca. 1358) who dared to deny the difference of kind (*species*) between commutative and distributive justice. ⁸⁹ In his view, the difference resided merely in the matter (*in materia*); moreover, he was of the opinion that distributive justice and commutative justice are two forms of the same virtue.

Finally, it is noteworthy that the Neapolitan Post-Glossator, Lucas de Penna (ca. 1323–ca. 1390), though familiar with Aristotle and Aquinas, used the distinction between the two kinds of justice merely in order to classify their negatives, the acts of injustice that constitute their violations. Thus, among the vices opposed to distributive justice, he enumerates a series of acts that fall under the heading of *acceptio personarum* (favoritism), such as unjust judgment, unjust accusation, false testimony, and unconscientious legal arguments. Another kind of acts that oppose distributive justice are those that run counter to religion, such as superstition, idolatry, invocation of demons, perjury, and sacrilege. Violations of commutative justice are damages caused by means of involuntary transactions, such as homicide, mutilation, theft, and robbery, as well as damages caused by unjust judgments; similar violations can also occur in connection with voluntary transactions, such as damages caused by fraud and usury.

Late Scholastics

BETWEEN THE FIFTEENTH AND SEVENTEENTH CENTURIES a great number of scholastics wrote commentaries on the influential works of Thomas Aquinas, who remained the dominant figure in Western religious thought. Other important scholastic works were dedicated to moral theology and ethics, as well as to general philosophical problems. The latter bore witness to the lasting overwhelming position of Aristotle's works. Many of these late scholastics expounded the Aristotelian concept of justice and especially the distinctions between commutative and distributive justice.

We shall proceed by describing the different scholastic views in relation to that topic in a basically chronological order. In spite of the manifold and variegated opinions, it is, however, possible to point out some major general tendencies of these important works. This we shall do in a few preliminary remarks.

One major concern of these scholastics was to defend Thomas Aquinas's view on the essential character of the Aristotelian distinction against the mentioned contrary opinion of Buridanus.⁹² In relation to the distinction itself, one strong new tendency was to enhance it by means of an additional element: the intensity of the right and the duty. Accordingly, only under commutative justice there was a perfect duty-right relationship; distributive justice created a much weaker claim against the distributor. On the other hand, the emphasis upon the intensity of the relationship implied a weakening of the geometric-arithmetic elements that were so prominent in the

traditional approach. Moreover, the very dichotomous character of the distinction was considerably weakened: many scholars saw no problem in defining certain legal situations as a combination of the two forms of justice.

Furthermore, many late scholastics followed Thomas Aquinas's specific interpretations of Aristotle's views. Thus, as noted above, many scholars adopted Aquinas's explanation of Aristotle's apparent contradiction between the essence of commutative justice and the example of the hitting of the prince, as given in the discussion of retribution (*contrapassum*). 93

Let us start with Dominican Archbishop of Florence, Antoninus Florentinus (1389–1459), who, in his *Summa theologica*, followed closely in the steps of Thomas Aquinas by maintaining the distinction between distributive and commutative justice. He has summary work, he often paraphrases the statements of Aquinas. Thus, in discussing distributive justice, he emphasizes the practical insights of Aquinas. He repeats almost literally the opinion of Aquinas, that when electing a person to a public office, the better one should be preferred. However, legally it suffices to elect a good one, even if there might be a better one. In that case, the election cannot be impugned in court, since otherwise every election would entail litigation (*calumnia*). Nevertheless, in respect of the conscience of the electors, the better person should be elected to the office. More original and influential is the work of the Spanish Dominican scholar Francisco de Vitoria (ca. 1483–1546). In relation to the Aristotelian distinction, he concluded that a debt under corrective justice is stricter than one under distributive justice. He stated:

If Petrus owes me ten ducats, the debt is that he renders me the equal amount. Yet in distributive justice not so much is owed. Given that I am suitable for a certain office, then when the King does not give it to me, he does not cause me as much injustice as if it had been mine . . . Equally, note that it is possible that a debt occurs in distributive justice as well as in commutative justice, nevertheless a greater debt is in commutative justice; hence if here a mistake is made a greater injustice is done. 97

Another important Spanish Dominican scholar was Domingo de Soto (1494–1560), who elaborated in a lengthy discussion the distinction between the two forms of justice on the background of the works of Aristotle and Thomas Aquinas. He maintained, against Buridanus, that the two forms differed in their essence (*specie*). In his view, commutative justice is based upon a real and proper debt; distributive justice merely a kind of a debt. Moreover, they differ also in relation to their object, their notion of equality and their form. Finally, they consist in two different virtues. Thus, distributive justice takes into account the prior position of the parties. The author gives the following example: the stomach is a common member of the body, but it

does not distribute an equal amount of food to the feet as to the eyes, nor the same to the liver as to the spleen; but each according to its nature and dignity. ⁹⁹ Vindictive justice necessarily makes part of commutative justice, since under it neither goods nor evils are distributed, but punishment is meted out in equivalence of the crime. ¹⁰⁰

Another staunch defender of Thomism was the Spanish Dominican scholar Domingo Báñez (1528–1604), professor of theology at the University of Salamanca. ¹⁰¹ In his commentary on Aquinas's *Summa*, after a rather lengthy discussion of the general notion of justice, he shortly summarizes the conclusions on the two different kinds of particular justice. ¹⁰² Thus in distributive justice, the mean is according to the proportion between things and persons: the more dignity a person has in the state, the greater is his part of benefits. In commutative justice, the equality is between things: one owes the other person as much as one has received from him. ¹⁰³

The author equally rejects Buridan's view that declared the difference between the two kinds of justice to be merely accidental and not *in specie*. Buridan's view runs counter Aristotle and the schools of both philosophers and theologians. ¹⁰⁴ The specific differences between the two kinds of justice are the following: distributive justice functions between state and citizen, the whole versus the part; commutative justice constitutes the order between citizens, i.e., between the individual parts of the community. The foundation of the obligation is different. ¹⁰⁵ Moreover, according to the opinion of all, the violation of commutative justice entails a duty of restitution; in relation to distributive justice the opinions of jurists and theologians are divided as to the existence of a duty of restitution.

Finally, the opposite vices of the two kinds of justice are different: The opposite of distributive justice is *acceptio personarum* (favoritism); the opposite of commutative justice is injustice without a specific denomination. ¹⁰⁶ It is true that sometimes in commutative justice the dignity of a person is taken into account. This occurs in personal injury cases but, contrary to distributive justice, not always and not formally and directly for the purpose of distributing common goods. In situations of distributive justice, the greater the number of worthy people is, the less each of them will obtain from the public goods to be distributed.

Commutative justice is concerned with equality; hence the purpose of taking into account an injured person's dignity is to adequately compensate him for his injury. As a result, the fact that there is a plurality of worthy people in the state does not detract from the amount of compensation to be paid to the individual injured person. ¹⁰⁷

In relation to vindictive justice, the author equally follows closely in the steps of Aquinas. The exercise of vindication by a judge falls under the heading of commutative justice, since the judge is duty-bound not only to care for the common good, but equally for the good of the individual citizen, namely to preserve him from injury. Moreover, the judge receives contributions and income not only from the state but also from the individual citizens in order to ward off injuries from the latter. Should the judge neglect his duty of protecting the citizens from theft and robbery, he will under commutative justice be liable to pay them compensation for the damages.

A dignitary, whose reputation has been blemished by others, has a duty under commutative justice to claim judicial vindication if he cannot recover otherwise his good reputation. He is obliged under commutative justice to exercise his public function, but cannot do it as long as he is in bad repute. Hence, he is under a commutative-justice-duty to claim vindication. He can legally be forced by his subjects to claim judicial revenge and punishment. However, a claim by a private person for judicial vindication is not based upon a legal duty, but merely upon a moral one. 109

The above-mentioned argument of de Vitoria¹¹⁰ was further developed, under the influence of Aquinas's work, by the Flemish Jesuit theologian Leonardus Lessius (1554–1623).¹¹¹ In his view, where, e.g., a person or a body has a perfect right to receive a certain amount of money according to a proportion determined by law, by custom, or by a donator's disposition, then by the same act the two forms of justice coincide. Thus, where the person, having that right under strict law, receives less than the proportion due to him, there is a concomitant violation of both commutative and distributive justice. ¹¹² On the other hand, where something is distributed according to a proportion, without the recipient having a right to it under strict law, then distributive justice does not include commutative justice. Hence, the violation of the proportion by the distributor is not a wrong obliging restitution under corrective justice; it is a nevertheless a sin against distributive justice. ¹¹³

The topic of the Aristotelian distinction between commutative and distributive justice was dealt with extensively by another, most influential, Spanish Jesuit scholar, Francisco Suárez (1548–1617), who was a contemporary of Lessius. In his work dealing with questions of justice and law, ¹¹⁴ after stating six traditional distinctions between the two forms of justice, ¹¹⁵ he adduces

in a rather nominalistic, critical way, a number of counterarguments. ¹¹⁶ Thus, even in the basic situation of commutative justice, such as the payment of a debt, there can be cases where a distributive principle is applied.

This happens where there is a multitude of creditors and the debtor has insufficient funds: payment is made proportionally. On the other hand, where there is only one candidate for distribution, the situation becomes one of commutative justice. Nevertheless, Suárez maintains the fundamental difference between the two forms of justice by emphasizing less the difference in the objectives of justice (distribution versus restitution) and more the legal character of the claim. Remaining in the scholastic tradition, he considers the claim in distributive justice to be imperfect and therefore weaker than that of commutative justice that is necessarily based upon a strict right. 119

In a special section, the author deals with classification of revenge (*vindicatio*). ¹²⁰ In his view, revenge makes part of the traditional forms of justice. If it is applied by a judicial authority, then it constitutes commutative justice, since the judge is duty bound to exercise penal jurisdiction in the framework of his assumed judicial task. The idea of a contractual or administrative judicial duty as an additional basis of commutative justice seems to be an original contribution of Suárez, since the traditional scholastic view referred the commutative dimension of revenge exclusively to the required equivalence between crime and punishment. ¹²¹ In Suárez's view, the role of commutative

justice in the case of private revenge is essentially limited to the prevention of excess.

The elements of the Aristotelian distinction are elaborated in great detail by Suárez in a special work dedicated to the question of divine justice. ¹²² His starting point is the following definition of commutative justice: The constant and perpetual will to give everybody his own full right, i.e., what is his specific property or what morally is its equivalent. ¹²³

The definition intentionally omits the arithmetic proportion, that according to the traditional view distinguishes commutative justice from distributive justice, the latter applying a geometric proportion. In Suárez's opinion, the two proportions are not mutually exclusive. Thus, in commutative justice situations, sometimes a geometric proportion is applied, as in the case of a plurality of creditors facing insufficient funds of the debtor.

Moreover, in these cases, the prior debts might be preferred over posterior ones, which again is not a simple arithmetic proportion. Equally, in situations of distributive justice, where there is only one benefit to be granted or one single candidate to the benefit, no geometric proportion is applied, but rather an arithmetic one. The argument that in case of one candidate, there is nevertheless a comparison to all those who don't have equal merits—this argument is not convincing, since in commutative justice situations it could

equally be argued that the creditor is compared to all those who don't have any right, in order to be paid by preference. ¹²⁴ As a result, the two forms of justice cannot be distinguished according to different proportions. ¹²⁵

However, this does not entail the conclusion that Buridan is correct in denying the essence of the Aristotelian distinction. As a matter of fact, the vice of unjust preference (acceptio personarum) does not run counter to commutative justice, but it is contrary to distributive justice; this is a sign that the two forms of justice are different. However, in Suárez's opinion the distinction is based upon the nature of the right that constitutes the object of justice. The object of commutative justice is the full right of property or its moral equivalence. On the other hand, where something is due to a citizen from the common goods of the state on the basis of his dignity and in proportion to it, that right of the citizen is not in the nature of property, since the goods were never in his ownership. Hence, the benefits are not owed to him on the basis of a prior right. The duty arising from a prior right is, therefore, much stronger. As a result, its violation gives rise to a duty of restitution, contrary to a right based on mere dignity. 126 Where a number of persons have an equal measure of dignity, none of them has a specific right to the benefit. However, after the benefit has been given to one of them, a right of property is acquired; depriving the person of that property would now be against commutative justice. Hence, the great difference existing between a full property right (ius in re propria) and the right to obtain a common good (ius ad rem communem).127

This difference between the natures of the rights is sufficient to establish the distinction between commutative and distributive justice. 128 The emphasis

upon the basis and the nature of the right is relevant in an additional context: the relation to dignity. It is wrong to assume that only distributive justice is concerned with a person's dignity. The violation of a person's dignity or reputation engenders a claim to compensation under commutative justice, since dignity here is based upon an existing proper and strict right. The situation is generally different where the issue is the granting of honor to a person. Thus, a person does not have a duty, as such, to enhance the reputation of another by his acts. In rare cases, however, there might be a duty under commutative justice to honor a person whose specific right to it is based upon a special authority or power.¹²⁹

The ideas of Suárez are basically repeated in the work of another contemporary, Portuguese Jesuit scholar Fernandus Rebellus (1548–1608).¹³⁰ This author equally insists, against the opinion of Buridanus, that the two forms of justice are different in species. On the other hand, the violation, by the person charged with distribution, of his duty to distribute, creates a duty of compensation under commutative justice. In his discussion of punitive justice, the author mentions the opinions of Duns Scotus, Thomas Aquinas, Caietanus, and De Soto. He remarks that judicial administration of punitive justice implies a number of different kinds of justice: As far as the judge exercises his official function, he falls under a duty of contractual, commutative justice; as far as he punishes the offender in order to restore the inequality between the latter and the victim, he applies commutative-punitive justice; as far as he is concerned with the public interest (*bonum commune*), he applies legal (universal) justice.

As far as the punishment is intended to serve the proportion between the pain and the fault of the delinquents, it is not unreasonable to assert with Duns Scotus that punishment belongs to distributive justice. A delict creates a duty toward the victim, but equally one toward the community. However, the duty toward the victim is stricter than that toward the community. The victim asks for satisfaction that equals the measure of the offense, hence he demands commutative justice. On its part, the community, by punishing the offender, distributes goods; those, though being evils for the offender, are, as

Aristotle teaches, remedies for the evils. ¹³¹ Moreover, as the distribution of goods among citizens is not based upon a strict right against the state, so the contrary duty of the delinquents toward the state to suffer the punishment is of a similar kind. ¹³²

It is interesting to note that the view concerning the distributive-justice-character of punishment seems to have been commonly accepted by scholars of the Coimbrian School in Portugal. Thus, in a general commentary on Aristotle's *Nicomachean Ethics*, first published by the Jesuit College of Coimbra in the last decade of the sixteenth century, it is stated that distributive justice has to be divided into a remunerative and a punitive part: the latter orders to inflict upon delinquents punishments according to a geometrical proportion.¹³³

Another important Spanish Jesuit scholar, Luis de Molina (1535–1600), starts with the traditional distinction between a quantitative (arithmetic) equality in commutative justice and a proportional (geometric) equality in distributive justice. ¹³⁴ But he notes that sometimes in the framework of commutative justice an image of distributive justice is created. Thus, where partners invested different sums into the enterprise, the profits are divided proportionally according to the rate of investment. However, this is basically a simple arithmetic equality according to commutative justice based upon the contract of partnership. ¹³⁵ Relying on Aquinas, Molina explains that the state, when entering transactions with individual citizens, is subject to commutative justice. Thus, the state is duty-bound under commutative justice to pay salary to its soldiers, judges, and public officers. ¹³⁶

The author then relates to the mentioned argument of Buridanus (ca. 1300–ca. 1358), claiming that there is no difference between the two forms of justice, since the violation of distributive justice creates a debt based

upon commutative justice. ¹³⁷ Molina's answer is that the violation of distributive justice creates a new debt, one of restitution that is naturally based upon the idea of arithmetic equality. ¹³⁸ Moreover, the judge in exercising his judicial function is fulfilling a commutative duty toward his employer, the state. A violation of that duty entails a commutative duty of compensating the ensuing damage. ¹³⁹

In relation to vindictive justice, Molina remarks that, as far as the punishment is measured according to the extent of the wrong, it makes part of the arithmetical proportion of commutative justice; but, as far as it merely punishes the offender without compensating the victim, it is not achieving perfect commutative justice. ¹⁴⁰

The Spanish Augustinian scholar Petrus de Aragon (1545–1592), professor of theology at the University of Salamanca, equally rejects, in his commentary on Aquinas, the view of Buridanus. ¹⁴¹ In relation to vindictive justice, he considers it to fall under commutative justice, since there is a simple equality between guilt and punishment. In addition, vindictive justice is ruled also by legal justice (*iustitia legalis*), since punishing delinquents enables the state to be governed in peace and calmness. ¹⁴² Distributive justice is generally based upon a geometric proportion according to the varying merits of the recipients.

However, it may happen that, given enough resources, the individual recipient will get a reward that is arithmetically equal to his merit. This will occur on the day of the Last Judgement, where the divine rewards, to be

distributed by divine grace, are inexhaustible. ¹⁴³ In relation to retaliation (*contrapassum*), the author distinguishes between retaliation in kind—like eye for eye—and a proportionally quantified retribution that can be made by monetary compensation. ¹⁴⁴

The German Lutheran scholar Joannes Magirus (d. 1596) in his extensive commentary on the *Nicomachean Ethics*, 145 specifies that the arithmetic proportion may be applicable even in the framework of distributive justice; namely, where the merits of the persons involved are identical, then under the very principle of geometric proportion, the arithmetic one is applied. The same is true in relation to punishment for equal crimes. 146

Gregorius de Valentia (ca. 1550–1603) is another important Jesuit scholar who deals with the Aristotelian distinction on the basis of Thomas Aquinas's *Summa*.¹⁴⁷ He claims that the rejection of the notion of strict reciprocity (*contrapassum* or *retaliatio*) in commutative justice is based upon the idea that things are not universally equal, since their value depends upon the concrete circumstances, i.e., upon their evaluation according to the individual market.¹⁴⁸ He equally rejects the above mentioned opinion of Buridanus, according to which there is no specific difference between commutative and distributive justice.¹⁴⁹

Another Spanish Jesuit scholar who discussed at length the various approaches to the Aristotelian distinction was Luisius Turrianus (Luis de Torres) (1562–1655), professor of theology at the Complutense University (Alcalá de Henares). The author starts the discussion on the validity of the distinction with the negative view of Buridanus. He admits the force of the latter's arguments, although the common opinion of scholars accepts the essential nature of the traditional distinction. The author is critical of a number of arguments aimed at justifying the distinction. Thus, he rejects the distinction based upon the stricter nature of commutative justice. In his view, a strict right of restitution is given also in the framework of distributive justice. The act of restitution assumedly grounded in the difference between a strict *ius in re* (commutative justice) and a weaker *ius ad rem* (distributive justice).

Finally, some scholars assume that the difference lies in the measure of the mental effort to implement or violate the respective kinds of justice.¹⁵¹ Thus, distributive justice is much easier to realize, as well as to violate, than commutative justice requirements. The author rejects this attempt of justifying the essential nature of the distinction. In his view, the only rationale lies in the different kinds of equality: commutative justice is based upon an arithmetic equality of things; distributive justice upon a geometric, proportional equality.¹⁵² The author follows basically the approach of Gabrielis Vasquez (1549-1604), who was critical of the views of Francisco Suárez (1548-1617). Thus, where there is only one benefit to distribute, or, especially, where there is one single candidate for the benefit, the situation becomes one of commutative justice, since there is no geometric proportion.¹⁵³ On the other hand, in case of a debtor's insolvency toward a plurality of creditors, the proportional, partial payment of debts is an application of both forms of justice. 154 However, where the debtor fully pays the differently sized debts of creditors, it remains a commutative justice situation, since payment is not based upon a comparison between the creditors, but exclusively on the

respective measure of the individual debt.¹⁵⁵ The duty under distributive justice may also arise from a binding contract.¹⁵⁶ In agreement with Vasquez, and contrary to the view of Suárez, the creditor is obliged, under commutative justice, to accept in payment of his debt what is judged according to the rules of justice as equivalent. There might be, however, a difference between a contractual and delictual debt. Thus, e.g., where a horse has been stolen, the owner has a right to demand its specific restitution—if feasible—and cannot be obliged to accept any equivalent substitute.¹⁵⁷

The Bishop of Antwerp, Joannes Malderus (1563–1633), in his commentary on Thomas Aquinas, is rather closely following the ideas of the latter. ¹⁵⁸ In his view, the allocation of a benefit to a single person of merit still falls under distributive justice. ¹⁵⁹ Distributive justice differs in kind (*specie*) from commutative justice, like music and geometry differ from arithmetic, since the latter's object is much simpler.

Moreover, in order to fall under distributive justice, it is not enough that common goods are distributed. Thus, payment out of public money of a strict debt owed by the state, such as for a lease or the payment of soldiers according to merit, is not distributive justice but commutative justice. ¹⁶⁰ Relying on Suárez's *Iustitia Dei*, the author objects to the view that any claim of distributive justice necessarily arises out of commutative justice. This would cancel the very distinction between the two forms of justice. ¹⁶¹ Finally, he observes that sometimes in a certain matter, both kinds of justice may occur. ¹⁶²

The Jesuit scholar Thomas Sanchez of Cordoba (1550–1610) states that if a person prefers his less needy friend in giving charity, it is a sin against charity, but not against distributive justice. ¹⁶³ Similarly, if a person invites all citizens to a meal, except his enemy, it is a sin (*scandalum*), but again not against justice. ¹⁶⁴

The Flemish theologian Johannes Wiggers (1571–1639), professor at the Catholic University of Louvain (Leuven), bases his conclusions on the writings of Thomas Aquinas. The author's starting point is the validity of the distinction between distributive and commutative justice. The distribution of common goods, of public offices and charges is primarily the function of public officials; commercial transactions are generally made between private persons. Commutative justice concerns the equality between the exchanged things; distributive justice relates to the parity between proportions, taking into account the condition of persons. 166

However, sometimes the state or the ruler commits itself or himself to a commutative justice duty under a private transaction. Thus, in case of paying salary to soldiers or recompense to workers for services rendered, the measure of the payment is according to the contractual agreement relating to the value of the service and not to the status of the person. ¹⁶⁷ In this connection, the author mentions the argument that in these cases of commutative justice, a proportional measure is applied that is not different from that used in distributive justice. Moreover, where the distributor gives to one person less than his status requires, the latter has a right under commutative justice for compensation.

As a result—thus the additional argument goes—distributive justice does not seem to constitute a different kind of justice. ¹⁶⁸ The author then defends the distinction against the two mentioned objections. He argues that it is a mere accidental fact that sometimes in a commutative justice situation a proportion similar or identical to that of distributive justice is used. This proportion is not intended *per se*, but only as a means to determine the equality between things. This is not the case where the state distributes common goods; in this case, the whole basis is the proportion between the quality or status of persons and the quantity of the things to be distributed.

In relation to the second objection, the author admits that the violation of the distributive criterion by the distributor may grant the recipient a (strict) commutative justice right for compensation. This is, e.g., the case where under a will a certain amount of wheat is to be distributed to the poor according to their respective need. In the author's view, this is a situation where simultaneously both a commutative and a distributive justice right are violated.

However, the distributive justice is not accidental, but entirely intended *per se.* Moreover, not in every case the violation of distributive justice engenders an obligation of restitution. Thus, where public offices or benefits are to be distributed among the worthy, a sinful neglect of the guiding criterion does not entail a right of restitution. ¹⁶⁹

The author's final conclusion is interesting: The division of justice into the mentioned two members is rather one of analogy than of species. Of principal significance is commutative justice, since it presupposes a strict and absolute right. The right under distributive justice is weaker. Hence, the definition of justice suits best commutative justice. ¹⁷⁰

The Jesuit scholar Tarquinio Galluzzi (1574–1649), in his lengthy commentary on the first five chapters of Aristotle's *Nicomachean Ethics*, expounds

the substantive difference between the two forms of justice.¹⁷¹ He equally observes that commutative justice refers also to the state, when the latter engages into private transactions with citizens.¹⁷²

The author insists upon the formal character of the notion of distributive justice, since the criterion of the oligarchy (wealth)—mentioned by Aristotle—is conceived to be "corrupt and depraved." Moreover, even in the preferred governmental system of aristocracy, the criterion of virtue is not always relevant; thus, the government may decide to distribute common goods to the needy and poor. In this case, should the distributor insist upon the criterion of virtue, he would violate the very rule of distributive justice. 174

Distributive justice may, in principle, relate also to one single person whose merits bestow upon him the privilege to obtain the benefit. Aristotle, when speaking of at least two persons, refers merely to the more usual case. ¹⁷⁵

Tarquinio Galluzzi endorsed Thomas Aquinas's view that retaliation is specific to commutative justice. ¹⁷⁶ He emphasizes that retaliation has no place in the distribution of common goods to the citizens, a distribution that is exclusively based upon their relative merits. ¹⁷⁷ The author then proceeds to analyze closely the notion of retaliation and its relationship to commutative justice. In his view, one has to distinguish between two forms of retaliation: one that is in the Pythagorean sense, the exact and arithmetic measure of the gain or the loss, and the other that constitutes their proportional and geometric measure. In other words, inside commutative justice there are two measures, one arithmetic and one geometric. The geometric, proportional measure is the general rule in involuntary commutations, in crimes and delicts. Exact retaliation is generally excluded. Indeed, the punishment for a

delict is meted out in accordance with the specific circumstances, taking into consideration the status of the victim, the state of mind of the perpetrator, and other aggravating or mitigating circumstances. Moreover, a just retaliation would require the compensation of the victim; but exact retaliation punishing the perpetrator does not compensate the victim's damage.¹⁷⁸

However, even in voluntary transactions, the strict arithmetic proportion does not constitute a just measure of retaliation. Where goods are exchanged, their respective value in money is the result of the people's mutual needs (*indigentia*), which is a matter of geometric proportion. Hence the (arithmetic) price expressed in money is itself primarily based upon a geometric proportion. 179

As a result, only very few voluntary transactions are based upon the idea of strict arithmetic retaliation, such as loans and guaranties, where an identical object or amount of money has to be restituted to the creditor. Even in donations, the recipient may, by his thanking and praising of the donator, enhance the latter's reputation and standing in the eyes of the public. This constitutes compensation according to a geometrical proportion. ¹⁸⁰

In the author's view, Aristotle's critique of the Pythagorean conception is not directed against the very notion of retaliation, but against its identification with strict arithmetic proportion. The general opinion that in voluntary transactions commutative justice is based upon arithmetic proportion has to be understood in the following sense: The parties among themselves refer to the monetary value of the object which is to be exchanged. Here the proportion is arithmetic. But the (pre)established monetary value of the object itself is based upon a geometric proportion, being the result of people's mutual needs. We have already mentioned Galluzzi's defense of Aristotle's critical comment in relation to the Pythagorean doctrine of *antipeponthos*, a defense that is identical to that of Thomas Aquinas. However, in this context it is interesting to note that Tarquinio Galluzzi raises against the very idea of a strict *talio* the following argument: A person, who killed another by imprudence, could not be killed the same way, since any punishment would necessarily be an intentional act. 184

Finally, Galluzzi makes an attempt to explain Aristotle's use of the notion of gain in the context of delictual actions¹⁸⁵: In his view, the gain here is not what the wrongdoer receives in fact from the victim, but it is rather an estimation of his state of mind: Since he intends to cause the damage to the victim, he is deemed to obtain the victim's loss as his profit. In other words, the wrongdoer considers it worthwhile to cause the loss; but, since the victim is not willing to suffer the loss for that price, the former is deemed to gain the actual amount of the victim's loss. ¹⁸⁶

In the author's view, the same is true in case of distributive justice. Where the distributor violates the established criterion for the distribution, by awarding more or less than the merit of the recipient would require, the former is deemed to make a profit. His act is based either on the friendship

for the preferred person, or on the hatred for the one discriminated against; in both cases he is deemed to make a profit by satisfying his volition. ¹⁸⁷

The author is aware that where the wrongdoer, who has to pay compensation for the victim's loss, is in addition to it punished by a judge, it goes beyond the symmetry between gain and loss. The author considers the punishment as a different act of commutative justice implemented by the judge. ¹⁸⁸

The important Austrian Jesuit moral theologian Paul Laymann (1574–1635) dedicated to the Aristotelian distinction a relatively very short chapter. However, in a brief comment, the author introduces what seems to be a new aspect of the traditional distinction. He claims that distributive justice is basically not the same kind (*species*) as commutative justice, but merely of an analogical nature. The fundamental difference is that distributive justice is not specifically oriented toward another person and neither does it constitute a strict debt. ¹⁹⁰

In relation to the category of involuntary transactions, namely those arising from delicts, the author remarks that here the gain does not always correspond to the damage. Nevertheless, the idea of equality can be applied in this case like in voluntary exchanges: The measure of the damage caused is tantamount to the measure of compensation. 191

Finally, the author states that vindictive justice (*iustitia vindicativa*) is very remote from a real kind of justice, since punishment does not compensate for the injury inflicted upon the victim. Following Thomas Aquinas, the author dedicates a special chapter to the issue of restitution. He affirms that restitution is always an act of commutative justice. Hence, where a wrong has not caused any material damage, the satisfaction of the victim is necessarily of a vindictive nature. However, vindictive justice is a matter of the public authority. The exclusive function of restitution, as an act of commutative justice, is to restore the damage caused. In cases of distributive justice, one has to distinguish between two different situations.

First, where the distribution of public goods is mainly in the interest of the state—like the bestowal of public functions or the grant of ecclesiastical benefits—the passing over the worthy does not confer them a strict right for indemnity. Such a right may arise in favor of the state if it suffered damage from the distribution of public goods to the unworthy. The situation is different where the distribution of goods is mainly in the interest of the recipients. This is the case, e.g., where the military commander distributes the spoils of war to the soldiers according to their respective merits or dignity. The violation of the distributive-justice-criterion entitles the individual, affected soldier to restitution from the commander's own property. However, in the author's view, this claim is based—contrary to the opinion of some scholars—not upon distributive justice but upon commutative justice. The restitution or compensation is determined according to an arithmetic and not a geometric equality.¹⁹⁴

The mentioned scholastic idea that the validity of the distinction is not based on the difference in proportion but rather upon the nature of the obligation, has been equally adopted by the Spanish Jesuit moral theologian Ferdinandus de Castro Palao (1581–1633).¹⁹⁵ After describing the arguments

in favor of Buridan's opinion, that denied the correctness of the distinction, the author explains that the decisive criterion is not the arithmetic or geometric proportion, but the nature of the arising obligation. Distributive justice does not give rise to a strict right-duty relationship. It is, therefore a different kind of justice. ¹⁹⁶

Finally, the author discusses the vindictive justice. Here, in his view, one has to distinguish: In relation to the offender who has to suffer the punishment, it is not an act of justice, since he does not demand it and submits to it involuntarily. In relation to the judge, in is an act of commutative justice, since he fulfills a duty toward the state. In relation to the victim, demanding the punishment, the author mentions the view that it does not constitute a complete kind of justice, since the victim does not get by it compensation of his injury. However, the author is of the opinion that punishment remains a proper kind of commutative justice. The punishment, even if it does not repair the physical damage, nevertheless repairs it morally according to the common judicial estimation.¹⁹⁷

The question of vindictive justice is treated quite extensively by the Jesuit scholar of Spanish extraction, Juan de Dicastillo (1584–1653). The author notes that one has to distinguish between three relevant factors: the delinquent to be punished, the community, and the injured victim. In relation to the delinquent, the punishment is not a proper act of justice, but part of potential justice. It constitutes neither commutative nor distributive justice, since both the delinquent and the punisher have no right to the punishment. This is evident in

relation to the offender who does not want the punishment. With respect to the punishing agency, it is not an act of distributive justice, since no common goods are distributed. It is neither a case of commutative justice, as neither the state nor the judge, acting for the latter, have a commutative justice right toward the delinquent obliging him not to sin. The delinquent violates only legal justice (iustitia legalis),199 and that violation does not give rise to a commutativejustice-right in favor of the state.²⁰⁰ The injured victim may have a commutativejustice-right for compensation, but this does not relate to the infliction of the punishment.²⁰¹ However, in relation to the judge acting *ex officio*, punishment constitutes an act of commutative justice: The judge by virtue of an express or implied contract is duty-bound toward the state and the victim to impose the adequate punishment upon the delinquent. The judge, when neglecting his duty to punish offenders, might be liable for the damage caused to the state and the private citizens. 202 Moreover, the act of vindictive justice, insofar it is directed toward the public welfare, makes part of legal justice, as a duty imposed upon the public authorities.²⁰³ Finally, the author insists that—contrary to the view of Cajetanus—vindictive justice does not constitute a different kind of commutative justice. Where there is an act of commutative justice, as explained above, it constitutes a material part of this kind of justice.204

In relation to the distinction between the two kinds of justice, the author—relying on Francisco Suárez—considers their substantial difference to reside in the rigor of the underlying rights: commutative justice concerns a strict right of property, or a right morally equal to property. Distributive justice relates to a less strict right, one based upon the dignity or condition of a person granting him, as a member of the community, a proportional part of the common goods. As a result, only the violation of commutative justice gives rise to a duty of restitution.²⁰⁵

The Spanish Jesuit, Cardinal Juan De Lugo (1583–1660), dealing with the mentioned arguments of Buridanus, claims that the person charged by the state to distribute common goods, violates, by not distributing them according to geometrical proportion, both distributive and corrective justice. He violates distributive justice as against the subjects of the state, since their claim is not based upon a strict right; he violates commutative justice as against the state since he, the distributor, is by contract obliged to distribute the goods correctly. This contractual duty confers upon the state a personal, strict right. The author insists upon the distinction between the nonstrict character of a duty by a superior to distribute common goods proportionally and the strict duty of a subordinate to fulfill his (contractual) obligation to follow the superior's instructions. The state of the strict duty of a subordinate to fulfill his (contractual) obligation to follow the superior's instructions.

In relation to the distribution of burdens among citizens, Cardinal De Lugo comes to an interesting conclusion: it is a combination of distributive and commutative justice. On the one hand, the act of imposing burdens and duties on citizens according to their individual possibilities and the necessities of the state makes part of distributive justice. On the other hand, excessive requirements by the state from the individual violate commutative justice, since it signifies taking away from him without justification what belongs to him under strict right.²⁰⁸

Finally, in the same line of ideas, a punishment that exceeds the measure of the delict violates commutative justice, since it violates the strict right of the defendant to his life and bodily integrity. Moreover, it violates equally punitive justice that requires a punishment according to merit; hence it constitutes a kind of distributive justice.²⁰⁹

The French Cistercian scholar Eustache de Saint Paul (Eustachius a Sancto Paulo) (1573–1640), professor at the Sorbonne in Paris, follows closely the Aristotelian tradition in his relatively short discussion of the notion of

particular justice.²¹⁰ He explains that distributive justice has a double function: The one—*iustitia remunerativa*—distributes honors, public functions and other similar benefits according to dignity and merit; the other—*iustitia punitiva*—inflicts in a similar way punishment upon criminals. Commutative justice comprises voluntary contractual transactions (nominate and innominate ones), as well as involuntary, delictual transactions.

Firmly in the scholastic tradition is equally the ethical treatise of the Italian Jesuit theologian Franciscus Pavonius (1569–1637).²¹¹ Relying exclusively on Aristotle and Aquinas, the author explains that at the basis of arithmetic proportion lies a transaction, voluntary or involuntary. After describing a variety of voluntary contracts, he states that in case of delicts, it is assumed that between the parties a kind of contract has been passed according to which the injurer has to restore the loss and to suffer the punishment. ²¹² The right arising from voluntary contracts is called ius commutativum, that from delicts emendativum. The distinction between commutative and distributive justice is based upon formal and material reasons. Formally, they differ in their notion of equality: arithmetic against geometric proportion. However, they agree in their measurement of equality that is made not according to the nature of things, but according to their need and utility. Contrary to distributive justice, commutative justice does not take into account the dignity of parties, but only the value of things. However, in certain circumstances the value of things is influenced by personal dignity, as in case where the injury caused is increased in view of a person's dignity, thus requiring a greater amount of compensation. Materially, the two forms of justice differ in their function: distribution of common public benefits and charges²¹³ as against exchanges or compensation of private property. Private transactions may be, as mentioned above, voluntary or involuntary.²¹⁴ Finally, vindictive justice is

part of commutative justice, since it corresponds arithmetically to the damage caused. 215

The Irish Franciscan scholar Anthony Hickey (Antonius Hiquaeus) (1586–1641), in his commentary on Duns Scotus, ²¹⁶ discusses at length the Aristotelian distinction. After mentioning the negative opinion of Buridanus, ²¹⁷ he supports the essential distinction between the two forms of justice on the ground that distributive justice—contrary to commutative justice—does not grant a strict right to the beneficiary of the public good. Moreover, distributive justice takes into account not only the personal merits, but also the dignity of the person. As a result, sometimes a debt based on a strict right of commutative justice must yield to a debt founded in dignity. Thus, where a person endowed with dignity, but devoid of resources, cannot pay a debt of commutative justice without losing dignity, he will not be bound to pay the debt. The preservation of his dignity is more important for the state than the satisfaction owed to an individual. ²¹⁸

The author then explains the case of one single benefit or one single candidate as being an accidental occurrence in distributive justice. Generally, it relates to a plurality of persons. But the criterion remains the proportional measure of dignity.²¹⁹

The author then refers to the case of an insolvent debtor facing a plurality of creditors. Here, the solution is a proportional one: first, the earlier debtors are preferred over the later ones in payment; second, the (insufficient) assets of the debtor are distributed among the creditors proportionally according to the measure of the individual debt. The proportional solution in a commutative situation is again accidental. It is not based on the quality of the persons, but on the equality of the object. The preference of prior debtors is

based upon the fact that the delay of payment has caused them greater damage; moreover, they have a prior right in the assets of the debtor. The same is true for the proportional payment of the creditors: the greater the debt, the greater the damage. The proportion maintains, therefore, as far as possible the equality among the creditors.²²⁰

The Franciscan scholar John Ponce (Johannes Poncius) (1603–1672), of Irish origin, dedicated in his philosophical work a rather extensive discussion to the Aristotelian distinction, declaredly in the spirit of Duns Scotus. ²²¹ His first comment refers to the situation where only one benefit is attributed to one person according to the latter's merit. In his view, contrary to De Lugo's analysis, it remains a pure act of distributive justice, even if no attention is paid to other people. In other words, distributive justice does not require a plurality of persons or a plurality of benefits. ²²² Moreover, he explains that distributive justice is still maintained where the (geometric) proportion of the respective merits is observed, even if the sum total of the benefits distributed are less than the merits would (objectively) require. ²²³

The second comment concerns the above-mentioned cases where in a commutative justice situation a proportional-geometric solution is applied; namely, the case of an insolvent debtor vis-à-vis a number of different creditors, and that of different investors in a common enterprise.²²⁴ The author follows the views of Suárez and De Lugo²²⁵—as against those of Vasquez and Turrianus²²⁶—who consider the cases to fall exclusively under corrective justice.

The author equally supports the view that the decisive criterion is the intensity of the legal relationship: commutative justice gives rise to a strict right-duty relationship; as a result, its violation bestows upon the affected party an absolute right to restitution. In the case of distributive justice, the relationship does not give rise to a duty of restitution. ²²⁷ Finally, the author refers to vindictive justice. He follows the view that from the point of view of the judges who, under a contract with the state, are committed to the administration of justice, punishing the offenders is a matter of commutative justice. But, if the punishment is meted out without a special contract, according to a person's discretion, then it falls under distributive justice. ²²⁸

Another attempt to defend on similar lines the opinions of Duns Scotus was undertaken by the Italian Franciscan scholar Bartholomeo Mastri da Meldula (1602–1673).²²⁹ The author first repeats the classical criteria of the Aristotelian distinction between distributive and commutative justice: The former compares objects to persons, giving rise to a geometric proportion; the latter compares objects among themselves, giving rise to an arithmetic proportion.²³⁰ However, according to the author, both categories of justice can be divided into a rewarding one (*praemiativa*) and a punitive one (*punitiva*, *vindicativa*, *retributiva*).²³¹ In other words, rewards and punishments can be measured proportionally, as under distributive justice, or equally like by exchange, as under commutative justice. In this way, the author appears to try to resolve the above-mentioned apparent contradiction in the writings of

Duns Scotus.²³² The major difference between the two forms of justice lies, according to the author, in the intensity of the underlying right: The object of commutative justice is a perfect right, the violation of which obliges to restitution, whereas the violation of a distributive justice right does not ex se oblige to restitution. However, in case of a wrongly executed distribution, a strict right of restitution might be attached to it. Thus, if money is distributed in violation of a predetermined proportional criterion, then the distributor sins against distributive justice, but at the same time also against commutative justice. He will, therefore, be held liable to restitution toward that person who has been injured by him. The same is true when the ruler distributes charges and taxes upon the citizens without distinguishing between rich and poor. He, too, sins not only against distributive justice, but equally against commutative justice, since the poor has a strict right in respect of his property that has been taken away from him. In many other cases, however, where public honors are distributed according to dignity and merits, the ruler or distributor has no duty of restitution toward the person injured.²³³

The author then mentions four difficulties concerning the traditional understanding of the two forms of justice. The first one relates to the denial by Buridanus of the specific nature of the distinction. The author mentions the contrary common view, according to which the distinction is *in specie*: the forms of justice differ in relation to the mode of equality (proportional versus quantitative), and they differ in respect of the duty of restitution.²³⁴ The second difficulty arises from the fact that sometimes in a commutative justice situation a geometric proportion is applied. This happens in case of a plurality of creditors facing an insolvent debtor, as well as in case of an

association dividing profits unequally among the partners. Moreover, as mentioned above, a violation of distributive justice may create, in favor of an individual person, a duty under commutative justice that is of an arithmetic nature. In view of these difficulties concerning the geometric and arithmetic proportions, ²³⁵ the author—after discussing the various opinions—concludes that it is preferable to distinguish between the two forms of justice on the basis of the nature of the right created by them: Commutative justice engenders a perfect right, distributive justice a merely imperfect one. ²³⁶

The third difficulty relates to the question whether commutative justice is composed of one single (formal) kind or of different ones (*species*). The author accepts the view that there are different kinds, in view of the different rights at the basis of commutative justice, giving rise to different kinds of duties.²³⁷ The fourth difficulty concerns the question whether distributive justice requires always a plurality of objects and persons. The author, preferring the opinions of Suárez and Poncius over that of Cardinal De Lugo, namely, that distributive justice can be applied to one single benefit without having regard to a plurality of persons. Yet, the tendency of distributive justice is to allocate a plurality of things to a plurality of persons where that is feasible.²³⁸

The Jesuit scholar Louis de Mairat (Ludovicus Maeratius) of Troyes (1577–1664)²³⁹ makes an extensive attempt to refute the view—which he relates to Suárez²⁴⁰—that based the distinction between the two forms of justice on the existence or absence of a (prior) full property right to a thing, or at least of a full right to its equivalence. In the case of commutative justice, one deals with a preexisting full ownership right to a thing; in the case of

distributive justice, no such right exists in relation to the person entitled to a benefit from public goods according to his dignity. The author declares that he adopts the contrary view of Gabrielis Vasquez, who represents the traditional, more common opinion among the theologians.²⁴¹

The author then proceeds to deal with each of the arguments that denied the relevance of the proportional criterion. In relation to the case where only one benefit is accorded to the most meritorious person, he maintains that this is still based upon a geometric proportion, even if on an imperfect one. On the other hand, it is true that in a situation of commutative justice—such as in the case of a plurality of creditors—the payment may follow a geometric proportion according to the size of the respective debts. However, this specific proportion is accidental to commutative justice, since at the base of it stays a debt of an arithmetic proportion. This original debt is not founded upon any comparison with other rights. Hence, by its nature it is grounded in an arithmetic equality. The same is true where in a distributive justice situation, based upon a geometric proportion, the accidental result may be an arithmetic proportion.

The author then refers to what he considers to be the weightiest objection, namely, the cases where, by acts of commutative justice, a duty of geometric proportion is established.²⁴⁵ Three exemplary cases are discussed: 1) According to a will, one hundred gold coins are to be distributed among ten specific poor people, in proportion to the degree of their respective need. The execution of the will is intended to be a matter of geometric equality. 2) Under a partnership contract, the profits are to be distributed proportionally according to the amount of the partners' respective investments. 3) The case of a debtor who has insufficient funds to pay the full amount of his debts to a plurality of creditors. The payment is made proportionally to the respective amounts given to him by the individual creditors. Here again the geometric

equality is evident. The objection to the criterion of proportionality in relation to the two forms of justice is based upon the premise that the three mentioned acts constitute commutative justice. The author contests this premise, claiming that all three transactions constitute proper distributive justice, since they are directly based upon a geometric proportion. Contrary to the opinion of Molina, not every duty arising out of a contract is necessarily one of commutative justice. Thus, a prince, who obliges himself under a contract that the booty obtained from the enemies be distributed among the soldiers according to a geometric proportion, is bound under distributive justice. Moreover, there is no need that the objects of distribution are goods of the community; it suffices that they are intended to be distributed according to a geometric proportion. In this context, the notion of common goods means that a plurality of people may have a common right to a full or partial possession.²⁴⁶

In the situation of the third mentioned case, where a debtor with insufficient funds has to pay the creditors according to a geometric proportion, a violation by the debtor of the right of an individual creditor constitutes a violation of both commutative and distributive justice. His primary duty to pay the debt is founded in commutative justice; the proportional payment in case of insolvency is based upon distributive justice. Hence—assuming the difference *in specie* of commutative and distributive justice—the nonpayment of a proportional part to an individual creditor sins against both forms of justice. ²⁴⁷ If, on the other hand, the two forms are not essentially different, but constitute one single virtue, then the nonpayment is one single sin committed on the basis of two different precepts. ²⁴⁸

The author then discusses Buridan's opinion, according to which the two forms of justice are *not* different *in specie*.²⁴⁹ Rather surprisingly, Maeratius agrees with Buridan, against the opinions of Aquinas and the majority of

theologians. In the author's view, the virtue that lies at the base of the two forms of justice is identical. They are merely sub-categories of the same virtue. Like in the framework of commutative justice, there are different situations, which do not justify the creation of additional forms of justice, so the differences between commutative and distributive justice fall under the same species of justice. The two forms do not differ, neither in the substance (intensity) of the right, nor in the substance of equality. Thus, both the rights under commutative justice and those under distributive justice constitute specific property (*dominium*) or its equivalence. The difference in the number of persons—commutative justice concerns the property of one person, distributive justice the property of a plurality of persons—this difference is not of essence.²⁵⁰

Equally, the difference between the geometric and arithmetic proportion is not of essence. Thus, the act of giving alms to one single poor according to his need, or to a plurality of poor persons proportionally to their individual need—these acts are based upon one identical virtue: compassion. The same is true for the two forms of justice.²⁵¹ Moreover, the criterion of dignity is not exclusively applied in distributive justice; it is relevant also in cases of compensating an injured person. The latter's dignity may increase the compensation. Hence, it is not different in essence from a case of comparison of dignity in relation to a plurality of persons having a right in the distribution of benefits.²⁵²

Finally, the author agrees with the traditional opinion that punitive justice (*iustitia vindictiva*) does not constitute a different species of justice.²⁵³

The Italian Jesuit scholar Francesco Amico (1578–1651), professor of theology at Naples, Aquila, and Graz, specifically argues that the distinction between the two forms of justice does not reside in the geometric or arithmetic proportions, but rather in the basis of the obligation.²⁵⁴ The reason is that

in a number of commutative transactions a geometric proportion has been laid down. Thus, a person may dispose of a certain sum in favor of the poor according to their respective need. The legator is bound by commutative justice to distribute the money according to a geometric proportion. Similarly, a person may sell certain merchandise that is priced according to the quality in a geometric proportion. ²⁵⁵ Hence, the distinction lies in the intensity of the right: commutative justice is based upon a perfect right in re, distributive justice upon an imperfect right ad rem.²⁵⁶ Vindictive justice exercised by a judge constitutes commutative justice, because the judge is under a contractual duty to administer justice. The judge has no right to exercise mercy, contrary to the prince who may for the public good grant pardon. A judge who deviates from vindictive justice, violates either the right of the victim (by a too lenient punishment) or the right of the offender (by imposing a too heavy punishment). The author admits, that, in principle, a violation of distributive justice by the prince creates a commutative justice right of compensation, not of the individual citizens, but of the community as such. 257

The Benedictine Abbot of Einsiedeln, Augustinus II, Reding von Biberegg (1625–1692),²⁵⁸ equally rejects Buridan's opinion and asserts that the distinction is not accidental but *in specie*. He relies on the different intensity of the rights created by the two forms of justice and the difference in the proportions, the one arithmetic and the other geometric. He refers to the famous argument that in the case of an insolvent debtor toward a plurality of creditors, commutative justice applies a geometric proportion; and in the case of one single benefit to distribute, no geometric proportion is applied.

The author argues that in the first case, the debt was created under commutative justice without comparison between the single creditors. The payment uses geometric proportion by accident and in a secondary way, in order to create equality between unequal creditors. It remains, therefore,

commutative justice.²⁵⁹ Correspondingly, distributive justice relates essentially to a plurality of persons subject to comparison. It bestows the benefit upon the person of greatest merit or dignity. Hence, it applies always a geometric equality.²⁶⁰ In relation to vindictive justice, the author reaffirms the opinion of Thomas Aquinas that it is based on commutative justice. However, he limits it to its exercise by a judge, since then the latter's function makes part of a contractual duty.²⁶¹

A detailed analysis of the distinction between commutative and distributive of justice has been undertaken by the Jesuit scholar Christoph Haunold (1610–1689), professor of theology at the Universities of Freiburg/Breisgau and Ingolstadt. He starts with the general proposition that the two kinds of justice, being based upon an obligation, don't create in the receiving party an obligation to respond with an act of gratitude.²⁶² He then describes four different views on the nature of the distinction between the two kinds of justice: 1) Buridan's opinion that denies its essential character; 2) the very common view that bases it on the difference between an arithmetic and a geometric proportion; 3) the "ingenious" view of Martinus Esparza (1589–1669), according to which there is no difference in the strictness of the rights; distributive justice relates equally to a strict right-duty relationship, the violation of which entitles to restitution. Distributive justice has to be based upon a prior law or contract; otherwise it is a mere act of generosity and munificence. Distributive justice is exclusively concerned with the conferral of public functions which have to be executed for the common good. Hence, the difference between the two kinds of justice relates to the object of the duty: the welfare

of the community versus the interests of private persons.²⁶³ 4) The fourth view considers the distinction to be grounded in the different intensity of the respective duties: The duty under distributive justice, concerned with the distribution of public goods, is not strict and its violation does not create a duty of restitution.

The author adopts that last approach.²⁶⁴ He bases his conclusion on the following arguments: The difference between arithmetic and geometric proportion is not sufficient, since in some situations distributive justice uses an arithmetic proportion and commutative justice a geometric one²⁶⁵; where the members of a community have, under a law or a contract, a strict right *ad rem* to the common goods to be distributed, that distribution is an act of commutative justice²⁶⁶; the right of restitution is always based upon commutative justice²⁶⁷; the distribution of charges and contributions is basically an act of commutative justice with some aspects of distributive justice.²⁶⁸

The German theologian Ewaldus Marchius (active around 1660) states in his summary of the notion of justice that it is commonly divided into legal, commutative, distributive, and punitive justice. ²⁶⁹ Distributive justice relates to meritorious citizens, punitive justice to malicious ones. Judges, who receive salaries from the state, are obliged under commutative justice to punish offenders. Distributive and commutative justice may coexist in one act, according to the existence of a strict duty. ²⁷⁰

The Bavarian Franciscan (Recollector) scholar Patricius Sporer (ca. 1620–1683) analyzes the different aspects of punishment.²⁷¹ From the point of view of the judge, who exercises his official punitive function, it constitutes commutative justice as in relation to the state and the victim; the punishment itself, being meted out in accordance with the measure of the crime, has a likeness to commutative justice; however, when considered proportionally in relation to other offenders, it is similar to distributive justice. But, since punishment is not a distribution of common goods, nor does it compensate the victim, it belongs neither to distributive nor to commutative justice. It constitutes, therefore, an imperfect kind of justice.

The Bayarian Franciscan moral theologian, Anacletus Reiffenstuel (1642-1703), adds an additional subdivision to both of the two categories of justice: a rewarding one (praemiativa) and a punitive (punitiva) one. Thus, under distributive justice, honors and other benefits may be awarded according to the proportion of merits, but also punishments may be meted out varying according to the different societal status of the offender. The same is true under commutative justice; on the one hand, rewards can be distributed equally without taking into account the condition, dignity, or status of the recipient; on the other hand, punishments may be imposed in an equal measure according to the offence, again without taking into account the prior condition of the offender.²⁷² A similar approach was adopted by another seventeenth-century Franciscan scholar, the Silesian Amandus Hermann. This author affirms that both iustitia praemiativa and iustitia vindicativa can be referred to both commutative and to distributive justice. On the one hand, reward is an exchange for work and punishment an exchange for guilt; on the other hand, both forms of justice determine respectively the reward or the punishment according to the proportion of the merit or the demerit.²⁷³

The view that a duty under distributive justice is weaker than one under commutative justice has been challenged by various scholars. Thus, the Discalced Carmelite Gabriele da San Vincenzo (1601–1671), in a treatise published in 1663, criticizes the view of Suárez by arguing that this specific

distinction between the two forms of justice cannot be found in the writings of Aristotle or Thomas Aquinas.²⁷⁴ These forms of justice have different forms of equality, but they are not different in the substance of the right. The rights under both forms of justice have the same force.²⁷⁵ Moreover, the author assumes that even in case of one single office or one single candidate to the benefit, there is still a situation of distributive justice, since potential other candidates remain excluded.²⁷⁶ He disagrees with Molina's view that any obligation arising out of a contract is exclusively one of commutative justice. Gabriele argues that nothing prevents a person to assume an obligation to distribute goods of his property according to a geometrical proportion of distributive justice. In his view, these cases represent a combination of commutative justice and distributive justice: There is a personal obligation to apply distributive justice.²⁷⁷

Petrus Barbay (d. 1664), professor of philosophy in Paris, states in his commentary on the *Nicomachean Ethics*,⁷⁷⁸ that a certain situation may at the same time belong both to distributive and commutative justice. Thus, the obligation of the soldier to serve in the military, and the king's obligation to pay the remuneration, fall under commutative justice; but the measure of the salary, according to the specific kind of military service, makes part of distributive justice. The author distinguishes between three kinds of distributive justice: remunerative, vindictive (or punitive), and civil: the first distributes honors and other public goods according to merit and dignity; the second kind constitutes an equality between punishment and offense; the third kind

distributes public charges, such as taxes and military service, according to the individual's condition.

However, the author denies the presence of proportion in a number of situations. His assumption is that proportion requires at least four elements: two things and two persons. This condition is absent in punishment, since there the equality is merely between crime and punishment; in remunerative (distributive) justice, it lacks where there is only one indivisible benefit for distribution. Moreover, arithmetic proportion can never be present in commutative justice. Thus, in case of different rates of investment by merchants, the distribution of profits occurs in a geometric proportion; the same is true in sales, where the price of any merchandise is calculated according to a basic unit: if one ell is sold for three moneys, then eight ell sell for twenty-four. Finally, where the price is equal to the specific merchandise, then there is again no proportion, since there are no four elements.²⁷⁹

The work of the French Jesuit Jacques Channevelle (1620–1699) on the *Ethics* according to the Aristotelian principles remains in the Thomist scholastic tradition. ²⁸⁰ The safeguard of strict rights is the function of commutative justice, not of distributive justice. Hence, restitution is the exclusive act of commutative justice. ²⁸¹ The author analyzes, on the basis of Aristotle's work, the price of goods and the function of money. In relation to need (*indigentia*) as the measure of a good's value, the author explains that one has to distinguish between the need of the poor and the need of the rich. The former need is based upon necessity, the latter upon luxury. ²⁸²

In relation to the Aristotelian discussion of retaliation (*antipepontos, repassio, ius talionis*), the author distinguishes between "simple" and "analogical" retaliation.²⁸³ The former has place neither in distributive nor in commutative justice. In distributive justice, attention is paid to the respective status of the persons; in commutative justice, the goods exchanged are not identical, and in case of injury, the retribution cannot be of a perfect identical nature. Thus, where an

injury is caused by inadvertence, it is impossible to reciprocate inadvertently, since any vindictive act will be done intentionally.²⁸⁴ On the other hand, analogical, proportional retribution (*talio*) is applicable in both kinds of justice.

The Benedictine scholar Paul Mezger (1637–1702) in his work on the scholastic theology according to Thomas Aquinas follows rather closely the great predecessor.²⁸⁵ Distributive and commutative justice are different in kind according to the traditional distinctions: private transactions versus distribution of public goods; measure of things against condition of persons; arithmetic equality versus geometric proportion; however, by accident the geometric proportion may be absent, such as in case of one single person of merit, or a plurality of equally meritorious persons²⁸⁶; strict right and duty of restitution versus neither of the two.

The Praemonstratensian theologian of Antwerp, Florentius de Cocq (1648–1693), starts his short discussion with quotations from Thomas Aquinas. He emphasizes that commutative justice is often annexed to distributive justice. Thus, the duty of restitution is always based upon commutative justice, since distributive justice, as such, does not grant the recipients a strict right. Distributive justice requires the distribution of common goods according to a geometric proportion. Once the required proportion has been violated, the original intent is no more applicable, since the common goods have already been distributed. The restitution of equality comes now from the private property of the wrongful distributor. The conferral of a public function to an unworthy person obliges the official to compensate the state for the ensuing damage. This obligation is again based upon commutative justice resulting from a contractual duty of the official to prevent damage

from the state.²⁸⁸ Vindictive justice is, according to Aquinas, based upon commutative justice. Punishing delinquents is a contractual duty of the judge, who will be liable for the damage caused by the breach of that duty.

Firmly in the mainstream of the Thomist scholastic tradition is also the Slovenian Jesuit theologian Simon Karchne (1649–1722), chancellor of the University of Graz. He affirms, following Cardinal De Lugo, that the formal object of distributive justice is not a strict right in the public goods, but a lesser right based upon dignity and merit. Hence, any right for restitution is necessarily based upon a violation of a commutative justice right. Thus, the violation of distributive justice by a neglect of observing the respective merits does not imply a duty of restitution. The situation is different where there is a specific contract, promising some members a distribution according to merit; the contract gives rise to strict right under commutative justice. ²⁹⁰

In general, commutative justice applies an arithmetic proportion, but in some situations—such as distribution under a will of money to the poor according to their respective need, or the proportionate payment of creditors in case of insolvency—a geometric proportion is used.²⁹¹ Vindictive justice constitutes a species of justice only in relation to the state and the judge. The latter, by accepting the office, is duty-bound, under an express or implied contract with the state, to punish proportionally the delinquent. As a result, the judge has no right to remit the punishment, since he is bound by law to care for the common good. However, the power of pardon is given to the ruler, because a declaration of judicial clemency is very conducive to the common good.²⁹²

The Italian Jesuit scholar Domenico Viva (1648–1726), in his popular *Cursus Theologicus*, starts with the assumption of four different kinds of justice: commutative, distributive, legal, and vindictive.²⁹³ Among these different kinds, only

commutative justice relates to a strict right; hence, the concept of justice is used with respect to the different kinds in an analogous and not in an identical sense.²⁹⁴ A right of restitution arises only from a violation of commutative justice.

In some situations, the violation of distributive justice implies a contemporaneous violation of a commutative obligation. This is the case where a person is charged by a will to distribute a certain amount of money according to merit. The beneficiaries acquire a strict right to receive their part of money, obliging the failing distributor to restitution. The situation is different in the case of public offices; the worthier don't have a strict right to the office. Hence, the ruler who violates distributive justice is not bound to restitution. The same is true for a person who does not help the very poor, or sells with profit corn or another commodity by help of his monopoly. That person merely sins against charity. Free of responsibility is also the bystander who does not extinguish the fire of a burning house—which he could easily do—as long as he is not a watchman or servant. ²⁹⁵ Vindictive justice is concerned with the welfare of the community and not with private rights of property. ²⁹⁶

The French scholar of theology at the Sorbonne, Honoré Tournély (1658–1729), equally affirms that distributive justice is not a strict form of justice. However, the person who causes injury by the unjust distribution to the community or to individuals is bound to restitution on the basis of commutative justice. Principle in the partly to distributive justice and partly to commutative justice. It pertains to distributive justice, since the offender's suffering in relation to another person is proportional to the injury caused by him. It belongs, according to Aquinas, to commutative justice, since the punishment is equal to the guilt; the latter is greater the more dignified is the injured person. Moreover, the judge is bound by his office to impose the punishment. The violation of the vindictive justice often gives rise to a restitutionary duty on the part of negligent judges, like the duty of a paid gardener who lets the weeds suffocate the good semen.²⁹⁸

The German scholar Augustinus Michel (1661–1751), professor of law and theology, starts also from the premise of four kinds of justice: commutative, distributive, legal, and vindictive. Commutative justice is based upon a strict property right; distributive justice upon a lesser right, namely, that of a person's aptitude. The latter does not give rise—in case of violation—to a right of restitution. The major distinction between distributive and commutative justice resides in the different proportions: arithmetic and geometric. The author then proceeds to respond to five traditional objections raised against that difference.

1) The case of the vacancy of one single public office. The author's answer is that in this situation of distributive justice, since the criterion is the dignity of a person and not the quantity of things, the proportion remains a geometric one even in the absence of other persons. 2) The case of proportional distribution of profits to investors in a commercial society. In this situation of commutative justice, the arithmetic proportion is clearly applied, since the profit is measured according to the quantity invested and not according to the dignity of a person. 3) The case of an insolvent debtor facing a plurality of creditors. Here again the quantity of money paid to the single creditors corresponds to that accepted from them; hence an arithmetic proportion is observed. 301 4) The case of a testator who left some property to the poor, to be distributed according to their quality and need by the executor of the will. Here, one has to distinguish between a twofold obligation imposed upon the executor: one based upon commutative justice, in favor of the whole community of poor, conceived quasi as one person; the other, based upon distributive justice, vis-à-vis the individuals obliging the executor to distribute according to their quality and need. The executor, failing to distribute the property, will be held to restitution under commutative justice; if he deviates

from the criterions of quality and need, he will sin against the virtue of distributive justice by the vice of *acceptio personarum*. 5) The case, mentioned in Justinian's *Digesta*,³⁰² where a husband left a will according to which his property shall be distributed the following way: If his wife gives birth to a son, then the latter will receive 2/3 or 8/12 and his wife 1/3 or 4/12; if she gives birth to a daughter, the daughter will get 1/3 or 4/12 and his wife 2/3 or 8/12. Now, the wife gave birth to twins, a son and a daughter. According to the solution under Roman law, the succession should be distributed in the following way: the son will receive 4/7, the wife 2/7, and the daughter 1/7. Hence, a geometric proportion in a commutative justice situation. The author gives the following explanation: In that case, commutative justice pays *per accidens* attention to the geometric proportion as a means to find out the arithmetic proportion, or rather the intention of the testator.

Finally, the author maintains that between father and son, master and servant, husband and wife, a commutative justice relationship may exist based upon a property right. Thus, the son in relation to *peculium Castrense*, the servant in relation to his bodily integrity, the wife in relation to her dowry, paraphernalia, etc.³⁰³

A similar approach, based upon the scholastic literature, is adopted by the Neapolitan Jesuit scholar Nicola Mazzotta (1669–1737) in his work on moral theology. Among the mentioned four kinds of justice, only commutative justice is based upon a strict right in way that its violation entitles to restitution. The division into the different kinds is, therefore, of an analogical nature. In situations of distributive justice, there may be included a strict right of commutative justice implying a right of restitution. The author then illustrates this phenomenon by a number of concrete cases: Distribution by a military commander of the enemy's booty according to the soldiers' merit; grant of ecclesiastical benefits to the worthiest on the basis of prior competitive exams; distribution of money under a legacy to students according

to a criterion of merit. In all these situations the recipients have a prior strict right—based upon an express or implied agreement—entitling them to restitution in case the distributor violates the criterion of merit. ³⁰⁷ In the absence of a commutative-justice-right, the violation of legal, distributive, or vindictive justice, as such, does not entitle the damaged person to restitution. ³⁰⁸ The imposition of a disproportionate punishment by the judge obliges him to restitution, since it is a violation of a commutative-justice-right of the delinquent (in case of an exaggerated punishment) or that of the state or of the citizens (in case of remission). ³⁰⁹

The Belgian Dominican scholar Charles-René Billuart (1685–1757), in his commentary on Thomas Aquinas's *Summa*, affirms that, in principle, nothing prevents an act belonging at the same time to both forms of justice. He relates to the argument that in the case where common (public) goods are distributed in recompense for public services, as, e.g., to soldiers who fought bravely, this is a matter of both distributive and commutative justice. However, the author opines that the mentioned case is rather one of commutative justice, since it deals with a recompense for services, a recompense that is measured according to the actual service and not according to the status of a person. ³¹¹

In the view of the seventeenth-century French Dominican scholar, Hyacintus Chalvet, meting out punishment, as well as awarding recompense for merits, is the privilege of the prince or of the magistrate; hence, both acts fall under the heading of distributive justice.³¹²

On the other hand, the Italian Dominican Cardinal Vincent-Louis Gotti (1664–1742), basically repeated in his scholastic textbook the Thomist analysis of the subject. In a lengthy discussion of the Aristotelian distinction, he maintained that the right arising out of distributive justice was weaker than that based on commutative justice. In relation to punishment, called by the author *justitia vindicativa*, he declared that, if applied by a judge, it belonged to commutative justice, since the judge is legally bound to administer punitive justice. Moreover, punishment is meted out according to the measure of the offense and aimed also at compensating the victim. The author then adds that the implementation of vindictive justice is imposed not only upon the judge or the prince, but equally upon the offender himself, who by suffering the punishment is rendering the just and the equivalent to the victim, to the state and to the law.

Firmly in the Thomist scholastic tradition stands equally the Bavarian Jesuit scholar Anton Mayr (1673–1749), professor of theology at the Universities of Freiburg and Ingolstadt.³¹⁷ In his view, there exists an important difference between commutative justice and distributive justice. The former is based upon a strict right of property, the latter upon a lesser right, since the recipients don't have, before the actual distribution, a right of disposition over the common good. As a consequence, the violation of the distributive-justice-right—though it can be called an injustice in a broad sense—does not entitle the victim to restitution, except if it constitutes at

the same time a violation of a commutative-justice-right.³¹⁸ The latter right may arise out of an express or implied agreement with the state obliging the distributor to divide common goods according to merit.

Moreover, by the very order to distribute public goods, the community may grant the recipient a certain *ius ad rem* which belongs to commutative justice.³¹⁹ The author refers to the objections against the validity of the distinction between the two forms of justice that is based upon the difference of proportion. He relies upon the traditional responses to the examples of the debtor's insolvency in regard to a plurality of debtors and the distribution of profits according to the measure of a partner's individual investment. The fact that in these cases a geometric proportion is applied is merely accidental, since basically the arithmetic proportion is adequate. Similarly, where the merits are equal, an arithmetic proportion may accidentally be applied in a distributive justice situation. Moreover, commutative justice may accidentally deal with a plurality of persons, as distributive justice may accidentally concern one single person.³²⁰

It is true, that in certain commutative justice situation—like in the case of a horse's theft—simple arithmetic equality is not sufficient, since the owner has a right to the restitution of the specific horse. ³²¹ Vindictive justice belongs to commutative justice in two senses: in respect to the judge who, by a contract with the community, is duty-bound to impose a punishment that is proportional to the delict; in respect to the victim who suffered damage by the delict. The delinquent's duty to suffer the punishment might be viewed as part of legal justice. ³²²

Another theologian, who is following closely in the footsteps of Aquinas, is the Italian Dominican Daniello Concina (1687–1756). Vindictive justice is part of commutative justice: punishment, applied by the judge, is measured according to the violated right of the victim. Commutative justice constitutes a reward or a punishment in respect of the acts of citizens; distributive justice, to the contrary, is a distribution of benefits based upon the personal qualities of citizens. The two forms of justice are of a different kind. A right under commutative justice is a strict right; under distributive justice, a mere imperfect one. However, whenever a strict right arises in a distributive-justice-situation, it is based upon commutative justice. Thus, where a person charged with distributing benefits violates his task, he is subject to a claim in commutative justice. The two forms of justices, though being joined together, are essentially of a different kind.

A similar view is expressed by the Belgian theologian Peter Dens (1690–1775), president of the Seminary of Mechlin.³²⁸ It seems, however, that he considers vindictive justice to be included in both commutative and distributive justice.³²⁹ Following the same line of ideas is the eighteenth-century

German Franciscan theologian Moritz Cuer.³³⁰ He adopts the view that both kinds of justice, commutative and distributive, can be subdivided into a rewarding justice (*praemiativa*) and a punitive one (*punitiva*).³³¹ An interesting comment refers to the compensating function of commutative justice. The author stipulates that in order to be compensable, the injury must be caused "unjustly." An injury is considered unjust only when caused deliberately. Hence, a completely indeliberate injury—apart from a contract—does not entail an obligation of reparation.³³²

The tripartite division of justice is also at the basis of the short discussion by the French Lazarist theologian Pierre Collet (1693–1770).³³³ He illustrates, by a number of examples, situations where the violation of distributive justice is accompanied by a concomitant violation of commutative justice entailing a duty of restitution. In relation to vindictive justice, it seems that the author classifies it under the heading of distributive justice.³³⁴

The Premonstratensian scholar Joseph Prickartz (b. 1696), professor at the University of Cologne, affirms the correctness of the division of justice into three categories: commutative, distributive, and legal.³³⁵ The division is based upon the difference in the respective notions of equality: arithmetic equality between the rights and duties of private or quasi private persons³³⁶; geometric equality between the right of private persons against the community

in relation to common goods to be distributed; equality between the supreme right of the ruler or magistrate—for the preservation of the common welfare—in relation to the property or to the acts of the subjects and the corresponding duties of the latter. The author states that vindictive justice belongs to commutative justice and, therefore, does not constitute a fourth kind of justice.³³⁷

As a matter of fact, many of the modern works on moral theology reflect the scholastic discussions and controversies. The views differ on the nature of distributive justice and on the essence of the distinction between the different kinds of justice. Some authors continue to claim that only commutative justice is a strict and perfect kind of justice and that the distinction between legal, distributive, and commutative justice is not univocal, but merely analogical. On the other hand, some modern authors claim—especially when dealing with the notion of social justice—that rights under distributive justice are no less stringent than those under commutative justice. These authors conceive social justice to constitute part of distributive justice.

No wonder, that also in relation to punishment (*iustitia vindicativa*), the controversy on its classification continues. Many authors, among them more modern ones, tend to classify it under distributive justice, since the infliction of the penalty is proportional to the offence.³⁴¹ On the other hand, some modern Catholic authors of moral theology tend to separate the different aspects of punishment.³⁴²

A final comment: there can be no doubt that the Thomist tradition exercised and continues to exercise a decisive influence upon modern Catholic moral theology. 343

A Special Theological Problem

Divine Justice

INTERESTINGLY, THE SUBSTANCE of and the relationship between distributive and corrective justice was discussed by theologians in relation to Divinity. This discussion constituted the natural continuation of the fundamental general problem concerning the relationship between Divinity and justice. In other words, the general question was whether mankind had a legitimate claim of justice toward Divinity.

Already Aristotle had stated that it would be ludicrous to assume the existence of a divine virtue and practice of justice. However, in Christianity the problem presented itself quite differently, since the Aristotelian conception of divine activity being restricted to mere contemplation contradicted the biblical tradition. The latter assumed Divinity's active intervention in human affairs and personal fates, both in this world and in the world to come. Hence, quite early the fundamental problems of the exercise of divine justice were discussed, such as the general relationship between divine and human justice, and, in particular, the vexing question of the connection between divine justice and divine mercy.

The church fathers tended to elevate the perfect divine justice highly above the human one, the latter inevitably being imperfect.³⁴⁵ The problem of divine

justice, compassion and grace turned into a major subject of theological discussions. Since we are exclusively concerned with the Aristotelian distinction between corrective and distributive justice, we will limit ourselves to one rather typical discussion by one of the founders of scholasticism, Anselmus, Archbishop of Canterbury (1033–1109). In a touching personal address to God he says:

For, though it is hard to understand how your compassion is not inconsistent with your justice; yet we must believe that it does not oppose justice at all. Because it flows from goodness, which is no goodness without justice; nay, that it is in true harmony with justice. For, if you are compassionate only because you are supremely good, and supremely good only because you are supremely just, truly you are compassionate even because you are supremely just. Help me just and compassionate God, whose light I seek; help me to understand what I say. Truly, then, you are compassionate even because you are just. Is, then, your compassion born of your justice? And do you spare the wicked, therefore, out of justice? If this is true, my Lord, if this is true, teach me how it is.³⁴⁷

accept in principle the idea of divine distributive justice.³⁵¹ This was the basic approach of the Franciscan scholars Ricardo de Mediavilla (Richard of Middletown) (1249–1308)³⁵² and Johannes Duns Scotus (ca. 1265–1308).³⁵³

The important French Dominican scholar, Johannes Capreolus (ca. 1380-1444), the "Prince of the Thomists," 354 defends—against the contrary scholastic view-the opinion of Thomas Aquinas that God is not subject to commutative justice.355 The arguments in favor of divine commutative justice are that God's punishment is according to guilt, and His reward according to merit, and that even in cases where distributive justice criteria are applied, there is an element of commutative justice. Moreover, retribution implies commutative justice. Capreolus objects that the essence of commutative justice is the application of an arithmetic proportion, the mean between two amounts. This measure is not applied in relation to divine punishment. The punishment is not measured according to the amount that the sinner took away from God by his guilt. It is not according to a comparison between punishment and guilt, but according to the proportion between two sins and two punishments: who sins more is punished more. This is rather like distributive justice applying a geometric proportion between things and persons. In the same way, rewards for merits are according to a geometric proportion, since the person who has more merits gets a greater reward than the person with fewer merits.³⁵⁶ Moreover, the merits of the just in this world are substantially far from being an equivalent to the divine reward of eternal life.357

In relation to Thomas Aquinas, the Dominican Cardinal Thomas de Vio Cajetanus (1469–1534) raises in his commentaries on Aquinas's *Summa*

*Theologiae*³⁵⁸ the problem of an apparent contradiction between that author's statement in one place that commutative justice does not belong to God,³⁵⁹ and the statement elsewhere that divine punishment is based on commutative justice.³⁶⁰

Cajetanus argues that Aquinas excludes, in relation to God, commutative justice in its strict sense, namely that which relates to transactional equality between the giving and the acceptance. There can be no such equality between Divinity and man, since *a priori* everything belongs to the former. However, in God's acts of distribution there can be an element of commutative justice, as in punishing offenders according to their crime, or in rewarding the meritorious according to their merits. Hence, there is no contradiction in Aquinas's two statements. It appears that Cajetanus considers divine punishment to be an act of distributive justice with a mode of commutative justice mixed into it.³⁶¹

But, again, the attribution of distributive justice to Divinity depends ultimately on the existence of a duty. Thus, it has been argued by the French Dominican theologian Durandus of Saint-Pourçain (ca. 1275–1334) that since in relation to distributive justice the duty to apply it arises out of commutative

justice, one cannot properly speak in relation to Divinity of distributive iustice.³⁶²

Thus, the Spanish Dominican scholar Francisco de Vitoria (ca. 1483–1546) observes that it is particularly doubtful whether God, when rewarding the good and punishing the evil, exercises distributive or commutative justice. ³⁶³ Indeed, God rewards beyond merit and punishes below the due. He mentions the opinion of Thomas Aquinas that commutative justice does not belong to God. De Vitoria argues that God does not have any duties toward men. But one can say that God owes the duty to Himself to reward the good, and therefore He, so to speak, exercises justice. But in God there is rather distributive justice than commutative justice, since He concedes us much more than we merit, and punishes less than our sins demand. It is not commutative justice based on equality, but distributive justice, since there is more of grace than of merit. ³⁶⁴

Following closely in the steps of Thomas Aquinas is equally the Spanish Dominican scholar Domingo Báñez (1528–1604), professor of theology at Salamanca. Accordingly, in relation to God there is no commutative justice, but only distributive justice. Since God remains the absolute master of all, He can do no wrong even if He would annihilate everything. 365

A different approach was adopted by the Jesuit scholar Gregorius de Valentia (1550–1603). In his view, there are two dimensions to the awarding of eternal life to the just: one of distributive justice and one of commutative justice. The measuring of the award according to the merits of the just applies

the proportional criterion characteristic of distributive justice. On the other hand, the award of eternal life is based upon a promise of God, and therefore—given the preconditions of the promise—it is His duty to confer it, and the right of the just to obtain it. This is an application of commutative justice. The author deals with the argument that the reward of eternal life exceeds the objective value of the good deeds' merits and is therefore an act of grace. His response is that God's promise includes this excess of reward and therefore it becomes binding upon Him and constitutes thus an integral part of commutative justice. He supports his conclusion by means of an example: Assuming that a prince determines by law the price of a good higher than its actual value, this price will avail in the transaction between the citizens.

In the view of the Jesuit Cardinal Robertus Bellarminus (1542–1621), Divinity exercises—when granting eternal life to the just in recompense of their good deeds—both distributive and commutative justice. But there is a difference: The substance of God's judgment is distributive justice; the form of it commutative justice. The substance is distributive justice because the recompense is strictly according to merit; God does not unjustly prefer any person. On the other hand, the form of the judgment is commutative justice because God not only grants recompense proportionally to the measure of the individual merit (which constitutes distributive justice), but there is a strict equality between the measure of the merit and that of the recompense (which constitutes commutative justice).

The author claims that even in the framework of distributive justice, there must be a promise of God. Generally, distributive justice does not require a promise. But this is true only where common goods are distributed. In case of private property, there is a need of a promise or contract. Since God distributes not common goods, but what belongs to Him, the recompense is based upon a promise.³⁶⁷

The contemporary Jesuit scholar Francisco Suárez (1548–1617) dedicated a special work to the question of divine justice on the background of

the Aristotelian distinction.³⁶⁸ He starts mentioning the dominant view that excludes in relation to God the strict notion of justice;³⁶⁹ thus, all theologians deny especially the applicability of commutative justice to Divinity.³⁷⁰

In relation to distributive justice, Suárez mentions the view that this form of justice, too, is inapplicable to God, since He rewards the just for their own, specific merits, and not in a proportional way by comparison to the merits of others.³⁷¹ The same argument is voiced in relation to punishment, which again resembles more commutative justice.³⁷² Suárez contests the validity of these arguments. The Holy Scriptures have more weight than the reasons of human philosophy. God's justice, unlike human justice, is comprehensively perfect; it is higher and more eminent.³⁷³ When God grants goods to creatures, the universal and superior ownership of them remains nevertheless with Him; the situation resembles, by way of example, the particular ownership of citizens to property, a right that may coexist with the superior, sublime ownership retained by the state.³⁷⁴

The author claims—against other scholars—that divine justice constitutes a specific and proper attribute of Divinity, distinct from the attributes of fidelity, charity, and compassion.³⁷⁵

The author then proceeds to elaborate upon the particular features of distributive and commutative justice, rejecting from the start Buridan's opinion that denied the distinction between them in specie. 376 The definition of commutative justice is, as mentioned above, the following: The constant and perpetual will to give everybody his own full right, i.e., what is his specific property or what morally is its equivalent.³⁷⁷ The traditional opinion, that denies the reality of commutative justice in respect of God, relies on the specific human relationship with all its imperfections. Between human beings, commutative justice arises from transactions, voluntary and involuntary. But, formally, it is enough for the existence of commutative justice that the criterion of equivalence between things is applied, without having regard to the material circumstances that gave rise to the duty. Moreover, there is no need that the transactions took place between human beings: They can be made also between angels. Thus Lucifer and Michael can be held to duties under commutative justice. True, human beings cannot cause injuries to angels, but conversely the angels are capable of damaging the former. They can, therefore, be held to abstain from it under strict commutative justice. 378 Concerning human beings, they can—contrary to the opinion of scholars do wrong (injuria) to Divinity under commutative justice. Even if the wrong cannot injure Divinity or the proper use of things, it nevertheless can detract from external benefits that relate to honor, glory, or esteem.³⁷⁹ The person who injured God in this way is duty-bound not only to give Him satisfaction, but equally to repair the damage; this is the sign of commutative justice.³⁸⁰

Correspondingly, where a person promises something to God by means of a vow, it creates a strict, commutative-justice-obligation. There is no need that the promise confers a real benefit upon God: it is enough that it relates to His service and honor.³⁸¹

Basically, commutative justice does not require an equivalence of a mutual giving and accepting. Thus, a promise of giving a gift confers eventually a full commutative justice right upon the promisee, without the latter being bound to reciprocate. 382

However, in relation to the reward of the just, God is exercising commutative justice based upon the equivalence of mutual giving and taking (*secundum aequalitatem dati & accepti*): The just person offers merit and receives reward, offers penitence and receives pardon. There is no need that what the human being gives God is something that is of any utility to God; it is enough that it is given in His glory and according to His will.³⁸³

But in order for God to have a duty under commutative justice, there must precede an explicit promise or agreement by Him. Without such promise or agreement, no duty in justice can arise.³⁸⁴

In respect of distributive justice, God exercises it in relation to the reward of the just. The fact that the reward is measured according to the individual merit, and that its resource with Divinity is unlimited—this fact does not detract from the reward being measured comparatively according to a geometric proportion.³⁸⁵

It appears, therefore, that Divinity, in rewarding the just, applies at the same time both commutative and distributive justice. The author then attempts to explain the background and possibility of that situation: The reward of the just belongs to commutative justice, to the extent that he confers, with the grace of God, something worthy of reward, based upon an agreement or contract. However, God as a debtor cannot be subject to a strict duty like human beings,

since a human being's right is subject to a higher right or to the highest property right that God has in every creature and in every right of creatures. As a result, God cannot be coerced from the outside to implement that right; He will be inclined to do it only out of His intrinsic rectitude. Since the right of the just lacks the rigor of a strict right, it falls under distributive justice. The conclusion is that this justice of God belongs, formally and eminently, to both commutative and distributive justice. The author ends his analysis by affirming that the duty of God under distributive justice has equally to be based upon an explicit promise or agreement. The subject to a higher right or to the highest property right or to the hight property

The author then dedicates a special section to the issue of Divinity's vindictive (punitive) justice. 388 He repeats his view that punishing a delinquent person by human justice is an act of commutative justice, not intrinsically from the viewpoint of the defendant, but because of the official duty of the judge toward the state to exercise his judicial function. 389 His conclusion in relation to Divinity is that punishing the sinners does not involve any kind of commutative justice. One cannot say that the sinner has a right to the punishment; it is rather to be subjected to another's right of punishing. Since God is the supreme master over the person, He may punish him at His will. If God does not punish beyond the measure, it is not the result of commutative justice, but of His benignity, compassion, and love toward His creature. God is equally the supreme governor and, therefore, not obliged to punish under a notion of (external) commutative justice, especially so, because of His being also the supreme master of all. Finally, there is no binding promise of rendering evil for evil. Hence, no kind of commutative justice is involved in this divine vindication. 390

The author then refers to the opinion of a number of scholars—among them: Capreolus, Cajetanus, and Richardus—that divine punishment is a matter of distributive justice. Suárez rejects this opinion on the mentioned ground that the delinquent has no right to the punishment, since its omission constitutes only an injury to the state. Hence, the punitive action as such does

not belong to distributive justice. God is not subject to a proper duty of justice, except if it is founded upon a promise or agreement. However, divine punishment is not based upon a promise, but rather upon a menace.³⁹¹

Suárez concludes that divine punishment is based upon a special notion of divine justice, called by him "providential justice" (*justitia providentialis*).³⁹² This kind of justice corresponds to the Aristotelian "legal" or "universal" justice that is relevant in human affairs. This divine justice does not exclude the application of arithmetic and geometric proportions in meting out punishment or in rewarding the just. However, the form of distributive justice (geometric proportion in comparison to other persons) is more common in rewarding the just, than in punishing the sinners, where the ordinary form is that of commutative justice (arithmetic proportion between punishment and sin).³⁹³ Yet, in determining the measure of punishment, a comparison between guilts is appropriate.³⁹⁴

The Dutch-born Jesuit theologian Martin Van der Beek (1563–1624), professor of divinity in Mainz and confessor of Emperor Ferdinand II in Vienna, mentions briefly, in relation to the divine reward of eternal life, the contrasting opinions of Durandus (commutative justice), De Soto (distributive justice), and Cajetan (a combination of both kinds of justice). The author tends to accept the latter view. God not only grants each person as much reward as he merits—which is a form of commutative justice—but the person with greater merit receives a greater reward, which is a form of distributive justice. However, it is not a case of rigorous commutative justice, since the merit of the just is based upon grace and a free divine promise. Moreover, according to the common opinion of scholastics, God remunerates the merits of the just beyond worthiness (*supra condignum*). The Italian Jesuit theologian Francesco Pavone (1569–1637) deals in his treatise on ethics briefly with the problem of divine justice. ³⁹⁷ He affirms that in Divinity there is legal, distributive, and commutative justice. God distributes gifts to the creatures according to their dignity and merits applying a geometric proportion. Commutative justice is exercised on the basis of a contract that God sometimes enters into with His creatures promising rewards for actions. Divine commutative justice is equally applied in relation to punishments for misdeeds. ³⁹⁸

The Flemish Jesuit and exegete, Cornelis Cornelissen van den Steen (1567-1637), professor of Holy Scripture at Louvain and later in Rome, deals with the problem of divine justice in his famous Commentary on the Epistles of St. Paul.³⁹⁹ His starting point is that according to the Scriptures, there is in God vindictive, distributive, and commutative justice. God punishes the damned and the sinners; He distributes glory to the blessed and rewards a recompense for the good deeds. However, there exists no formal, perfect, and absolute duty in God, neither of vindictive nor of distributive justice, and even much less of commutative justice. These kinds of strict duties can exist only between equal human beings. God is the absolute owner of everything and cannot bind Himself by a strict duty of justice. God's duty is based upon His truth and faithfulness. But the duty is nevertheless a kind of commutative justice, like the duty between father and son, where the father promised a recompense for good actions. God promised reward not for free, but in exchange of good deeds and merits, and therefore it is a debt of justice. The duty in justice does not detract from God's supreme dominion, since He could always rescind His promise without doing wrong. But being faithful and steady in His promises, He will keep, because of His infinite benignity,

this obligation and debt of justice out of His free will. Between us and God is a kind of agreement creating a kind of a commutative-justice-obligation that is less strict than that existing between men. 400

The French scholar François Du Bois (1581–1648) equally argues that nothing prevents it to consider God as being bound by justice to reward the just with eternal life for their good deeds. 401 Moreover, the author claims that God may be subject to commutative justice as a result of a promise made by Him, though the basic relationship between Him and His creatures differs from that prevailing between men. Men are mutually independent and can act as exclusive owners of property. In contrast, men are dependent upon Divinity who is the real owner of all property. Hence, commutative justice in human transactions has some specific characteristics that are absent in relation to divine rewards. But the latter can nevertheless be conceived as falling under the real notion of commutative justice. 402

The Irish Jesuit scholar Peter Wadding (1581–1644) also arrived at an identical conclusion, claiming that it results from the Scriptures and from the definitions of the Council of Trent (1545–1563). He argues that upon those, who deny the application of commutative justice in relation to Divinity, lays the burden of proof of demonstrating that the relevant texts of the Scripture have to be given a different sense. In his view, they failed in this task.

A similar view was adopted by the Spanish Jesuit scholar Pedro Hurtado de Mendoza (1578–1651), professor of theology and philosophy at Valladolid and Salamanca.⁴⁰⁴ In addition to the traditional argument that Divinity can create, by an explicit promise of His, a right-duty relationship falling under

commutative justice, ⁴⁰⁵ the author claims that there are other possible divine acts that belong to this category. Thus, let us take as an example Anton being a debtor of Peter for a certain sum of money. Now assume that God, out of His free will, gives Peter this amount of money for Anton's sake. God did not owe this payment to Peter, hence there was no debt of His. Nevertheless, in the author's view, the payment of the debt was an act of commutative justice, since it freed Anton from his debt that he owed to Peter. ⁴⁰⁶

The Italian Jesuit scholar Francesco Amico (1578–1651), in a lengthy discussion of the various contrasting scholastic views, arrives at a negative conclusion: Between man and Divinity there can be no perfect, formal justice relationship. 407 The reasons for the absence of commutative justice are that between man and God there is no perfect legal independence (*alteritas iurium*) nor equality, no perfect duty of God toward man to fulfill an obligation (*perfectum debitum retribuendi ex parte debitoris*), and no perfect right of man to demand that fulfillment (*perfectum ius exigendi ex parte creditoris*). 408 Since man is the creation of God, everything belongs to Him, and hence even by agreement no perfect legal right (of remuneration) can be created. 409 The author equally denies the existence

of formal distributive justice in Divinity. He rejects the view of Suárez, according to which God exercises simultaneously formal commutative and distributive justice. Francesco Amico objects that it is impossible to assume simultaneously a perfect, commutative justice obligation and an imperfect distributive one. One excludes the other. Concerning the view of Thomas Aquinas, who admits that God exercises distributive justice, the author suggests that Aquinas did not consider the distributive obligation, but rather the geometric proportion that underlies the recompense of merits.

The French Jesuit scholar Louis de Mairat of Troyes discusses, too, at a considerable length the problem of divine justice. He denies the possibility of a strict right relationship between God and the human beings. He relies on the traditional grounds of Divinity's absolute ownership over human beings and, as a result, the absence of a perfect "otherness" between God and His creatures. In his view, even an explicit promise of God does not create a strict duty of His, since He remains the absolute owner of everything. For the same reason, commutative justice has no place between God and human beings, since God remains the absolute owner of everything, even after any transaction. Moreover, God cannot be awarded a benefit, nor can He suffer damage. Hence, the basic elements of commutative justice are lacking. The author equally denies the existence of strict distributive justice between God and human beings.

The contrary conclusion is suggested by the Jesuit scholar of Spanish extraction, Juan de Dicastillo (1584–1653). He explicitly follows the view of Suárez that subjects God to commutative justice on the basis of a promise of His. He accepts in this respect the arguments of Suárez and uses them against those scholastics who deny the existence of commutative justice in relation to Divinity. Thus, commutative justice does not require an exact equivalence between the benefits exchanged. Moreover, the fact that God is the absolute owner of all things does not detract from the possibility of a legal relationship with human beings. In relation to distributive justice, the author equally tends to recognize it in relation to Divinity on the basis of a promise or agreement.

The contemporary Irish Franciscan scholar Anthony Hickey (Antonius Hiquaeus) (1586–1641), in his commentary on Duns Scotus, ⁴²⁰ follows in a lengthy discussion Thomas Aquinas's above-mentioned view that commutative justice cannot be, simply speaking, in Divinity. The complete lack of equality between man and God prevents the existence of a strict duty. The situation remains the same even in case of an explicit promise. Since all and everything belongs to God, nothing can be given to Him, and no duty can arise of His giving something back in exchange. Hence the right arising out of God's promise is merely based on His benevolence, faithfulness, and truthfulness; it cannot be in the nature of a strict right. Moreover, man as a creature of God lacks independence, "otherness" (*alteritas*), and is, therefore, incapable of acquiring property from Him. Similarly, a father or master, in order to validly transfer ownership in property to a son or to a slave, the latter must have the

capacity of acquiring rights on their own. This capacity can be obtained by manumissio in case of a slave, or by emancipatio in case of a son. Thus, e.g., a Franciscan monk cannot acquire property on his own as long as his legal incapacity is valid. 423 In relation to Divinity, the capacity remains excluded. 424

The author then deals with the problem of justification—the relationship between righteous deeds and eternal life—on the background of the doctrinal statements of the Council of Trent (1545–1563). They affirm, in the author's opinion, the absence of a strict right toward God, as well as the absence of equality. Eternal life is a gift by God based upon His mercy and Christ's merits. It is not based upon a strict right of the just. Thus, e.g., if a person makes a promise to give a great amount of gold to another person, as a favor without any cause, it may happen that this promise is conditioned upon a service; nevertheless, no strict duty emerges for the promising person, since the promise remains based solely upon his generosity. The added condition does not detract from the gift's nature. Hence, the merit of the just, which is a gift of God, cannot give rise to a right under commutative justice. As a result, in no way can God be held to be a debtor under strict law, nor can a creature acquire such a right. However, since the reward is according to the merit, there is—as Duns Scotus affirms—substantially a commutative justice proportion without constituting a strict right.

The author then rejects the idea of viewing the relationship between God's right to property and that of men like the relationship between the state's *dominium universale* and private property. God's property rights in relation to His creatures are absolute, unlimited, invariable, and inalienable.⁴²⁹ The author criticizes the contrary view of Suárez—who imputes commutative justice—as being unconvincing and not sufficiently consistent with religious faith.⁴³⁰

The author then proceeds to discuss distributive justice. According to Duns Scotus, God applies distributive justice in its full sense. According to the author, Duns Scotus limits the divine application of distributive justice—contrary to Richardus, Cajetanus, and Soto Code Code (divine) government or natural providence, but not to retribution for deeds. The author goes on to say that one has to pay attention that distributive justice in relation to God is not to be understood in its strict sense implying a strict duty. It signifies merely the application of a proportion in the government of nature which does not give rise to a moral or legal duty.

A thorough and rather fierce defence of the opinions of Duns Scotus was undertaken by the Italian Franciscan scholar Bartolomeo Mastri da Meldula (1602–1673).⁴³⁴ The author, who is well versed in the whole scholastic literature, painstakingly analyzes the different opinions on the question whether the just are rewarded by Divinity on the basis of justice. He mentions three different

opinions, among them two extreme ones; one that completely denies the possible existence of commutative justice in relation to God. Accordingly, the basis of the reward of the just lies exclusively in the divine virtues of gratitude or fidelity⁴³⁵; the other extreme opinion assumes the application of a proper and veritable commutative justice by God.⁴³⁶ The third opinion—a medium one—assumes that in relationship between God and His creatures justice can intervene; however, not in the general, simple sense of justice (*simpliciter*), but in certain respects only of the notion (*secundum quid*).⁴³⁷

The author supports this third opinion which, in his view, is held by Duns Scotus and his followers. It means that the reward of the just by Divinity is not merely an act out of fidelity or gratitude, but equally one out of justice. On the other hand, God is not subject to a rigorous and strict duty of commutative justice, but merely to one *secundum quid*, like the imperfect justice relationship that exists between father and son, master and servant. However, whereas the father can create a strict justice relationship with his emancipated son, and the master with his freed servant, no such possibility exists between Divinity and human creatures: God's rights of paternity and dominion are inalienable. The author—after a lengthy and detailed refutation of all the arguments voiced in favor of a strict commutative justice relationship between God and human beings the proceeds to analyze the existence of a distributive justice relationship.

of Duns Scotus, according to which, distributive justice is exercised by God in the proper and full sense of the notion. 442 When rewarding the just, the proportion to other persons' merits is also taken into account. 443

In a later part of his work, the author deals at length—again in the characteristic detailed scholastic way—with the juridical nature of atonement of sins. 444 He discusses the following questions: By sinning are we committing an injustice toward God? Are we held by justice to atone for our sins? Is the atonement by the sacrifice of Christ an act of justice? The author adopts basically a positive answer to all these questions in the spirit of Duns Scotus, but in relation to God and Christ the notion of justice is again used by him in a less rigorous way, namely *secundum quid*. 445 The author notes that in this context of atonement of sins, the appropriate notion is not commutative justice, but rather *iustitia remissiva & condonativa*. 446

The German Benedictine scholar Paul Mezger (1637–1702), in his work on the scholastic theology according to Thomas Aquinas, follows also in relation to this topic rather closely the great predecessor. However, he denies the very possibility of formal distributive and commutative justice between man and Divinity because of the total absence of any equality of status. Hence, there can be no formal justice relationship between man and Divinity, and that in either direction. God's justice is of an eminent, perfect substance (*justitia eminentialis*). A similar conclusion reaches the Belgian theologian scholar Laurent Neesen (1612–1679): Divinity is not subject to a strict commutative justice, neither to a distributive one. There can be no strict duty of God toward human beings.

The same conclusion is adopted by the French scholar of theology at the Sorbonne, Honoré Tournély (1658–1729).⁴⁵¹ In relation to commutative justice, he relies on Vasquez and Aquinas. The reference in the Scriptures to God's justice has to be taken metaphorically, since in its strict sense it contradicts His nature.⁴⁵² God's ownership in the property of human beings is much more extensive than that of the prince's in that of his subjects. For the same reason, there is strictly speaking no distributive justice in relation to God; nor is He bound to exercise vindictive justice. Aquinas's contrary statement has to be understood as relating to justice in the large sense, namely of applying a geometric proportion.⁴⁵³ On the other hand, on the part of a human being, there can be a strict duty in relation to Divinity.⁴⁵⁴

A contrary approach was taken by the Spanish Jesuit Juan de Ulloa (1639–1723). In a lengthy and rather sinuous discussion, the author attempts to establish his thesis that God can oblige Himself to a strict, commutative justice duty. The example used by the author is the divine promise to grant glory to the just. He undertakes a considerable intellectual effort to overcome the objections based upon God's omnipotence and absolute dominion over human beings and their property. A major part of the discussion is dedicated to the problem of God's lack of power to deny the promised glory to the just. The author tries to defend his thesis on the basis of medieval, scholastic

distinctions developed by logicians and used in connection with the vexing problem of divine foresight, predestination, and free will.⁴⁵⁶

The topic of the relationship between Divinity and the forms of justice remained a central issue in Christian theology producing an extensive literature.⁴⁵⁷ It served equally as a permanent topic in academic

disputations.⁴⁵⁸ But in post-scholastic times, the problem lost much of its intensity.⁴⁵⁹

Nevertheless, some mention should be made of the use by some theologians of the Aristotelian distinction in relation to the heated and prolonged controversy between Catholics and Protestants on the nature of justification, a controversy that arose in the wake of the Reformation. Hous, the Polish Cardinal Stanislaus Hosius (1504–1579), a papal legate at the Council of Trent, relies upon the distinction between commutative and distributive justice in order to explain the award to the just of eternal life's glory. Since there can be no quantitative (arithmetic) equality between the earthly merits of the just and the heavenly reward, it must be a matter of proportional (geometric) equality, i.e., the application of distributive justice. The author explains the topic by means of an example: The semen of a tree, though being quantitatively much smaller than the tree itself, nevertheless contains all the latter's qualities. Likewise, the act of the just, though quantitatively far from being equal to the glory, nevertheless contains in its qualities, by the grace of the Holy Spirit, the eternal life. Holy Spirit, the eternal life.

However, notwithstanding the objections to some fundamental tenets of Catholicism, some Reformed scholars continued to rely on scholastic literature. Thus, the English theologian Thomas Jackson (1579–1640), chaplain and president of Corpus Christi College in Oxford, do bserves in relation to the covenant between God and Abraham:

The word *Covenant* in our English, is sometimes equivalent to what the Latines call *pactum*, or *conventum*, to wit, any contract or bargain, wherein there is, *quid pro quo*, somewhat given, and somewhat taken. And in this sense every Covenant or bargain is an act of commutative justice, wherein there is, *ratio dati & accepti*, a mutual bond between parties contracting upon some valuable considerations. this rank there cannot be properly said or imagined betwixt God and mere man as *Abraham* was; for who can give any thing to God, which was not his own before, by a more sovereign right and more peculiar title than it is, or can be his that would take upon him to make God his Debtor by deed of gift. And for this reason the acutest Schoolmen resolve us, that commutative justice cannot be *formally* in God. But when we read that Justice is one of God's Essential Attributes, or when we say that God is truly and *formally* Just; this must be meant of distributive Justice, the ballance of whose scales are *poena* and *praemium*, matter of punishment, and matter of reward.⁴⁶³

In relation to the question of *antipeponthos*, Jackson has an interesting and quite original solution; he says:

Aristotle did rightly deny Retaliation, or Counterpassion to be άντοδικαίον, exact justice, and yet it may be, Pythagoras his thoughts did soar much higher than his, when he pitched upon the affirmative. In ordinary offences committed by unequal or extraordinary persons, Pythagoras his tenent, is not universally true. As if a great Person should beat his far Inferior, without just cause, it stands neither with the Law of God, or Rule of Equity, to beat him in the same fashion, or according to the same measure again. But when Kings and Monarchs do extraordinary wrongs unto their Subjects, or practice Prodigious Cruelties upon their Inferiors, they usually suffer the like harms or plagues themselves.⁴⁶⁴

The author then goes on to illustrate lengthily, by means of very detailed biblical and historical examples, the divine retaliatory punishments that befell upon great princes. Some are inflicted according to the geometrical proportion of distributive justice, others according to the arithmetic one of commutative justice.⁴⁶⁵

Jackson's treatise provoked a sharp polemic attack by William Twisse (1578–1646), theologian and rector of Newbury. He Twisse, adhering to a supralapsarian Calvinism, blamed Jackson of Arminanism and even Pelagianism. He Being well versed in scholastic literature, Twisse made only a short comment in relation to our topic, He Since his main interest lay in the more profound theological problems of divine attributes, such as predestination and election.

A more detailed discussion of the various forms of justice in relation to Divinity, one finds in the work of the German-Dutch theologian Conrad Vorstius (1569–1622), who extensively relies on biblical sources. 469 The author starts with a notion of judiciary justice which can be divided into cognitive and retributive justice. 470 The latter itself is divided into *iustitia remunerativa* and *iustitia vindicativa*. 471 In relation to the Aristotelian distinction, the author basically assumes that both forms of justice, in their strict sense, cannot be applied to Divinity.

They can be applied only "analogically." However, especially inapplicable to Divinity is the concept of commutative justice, since there can be no equality of exchange. In lengthy notes to his basic theses, the author severely criticizes the "Papists" for interpreting biblical texts literally, instead of reading them metaphorically. 473

A short reference to the scholastic approach relating to divine justice, one finds also in the work of the great Scottish Presbyterian theologian, Rev. Samuel Rutherford (ca. 1600–1661), professor of divinity at the University of St. Andrews.⁴⁷⁴ He affirms that there is no equality between the promise of divine reward and human works. Hence, there is no place of commutative justice between God and human beings:

The virtue of justice stands in the equality of that which is given and received. Now there is a two-fold equality, one *rei ad rem* between thing and thing, an Arithmetic justice, so many ounces of natural actings, and the same number of ounces of grace and glory: This commutative justice is not in God, as the soundest and learned'st School-men teach. There is another justice of proportion *duarum rerum ad duas alias res*, of two things proportionally answering to two things, distributive justice is this, and it keeps a Geometrical proportion.⁴⁷⁵

The promise of grace is a free promise:

If a promise as a promise should make an equality between one thing and another, and so lay a band of strict commutative justice upon God, then should every promise do the like, *quod convenit* καθ' αὐτό *convenit*

κατά παντός, but that cannot be said: For then if God should promise glory of ten thousand millions of degrees above the glory that Angels and men now enjoy, for speaking one good word, that should be a free promise, but that promise should not make an equality between so huge and rich a reward of glory, and so hungry and poor a work as the speaking of a good word, so as God should fail in Justice, if he should deny a reward so great, for so small a work: For the denying thereof should be against the veracity and faithfulness of God, if he should not fulfill his promise, but he should not fail against strict Justice either in not rewarding the work with a condigne reward, or not in giving to the man that spake the good word his own. For there is no just equality between work and wage here. 476

However, the situation is different in relation to the intertrinitarian covenant, i.e., between God and Christ. The deliverance from satisfactory punishment is due to human beings under a commutative-justice-duty of God toward Christ.⁴⁷⁷

The idea that God cannot be subject to commutative justice was equally adopted in a short statement by the important German Lutheran theologian Johann Gerhard (1582–1637).⁴⁷⁸ It was similarly affirmed by many other Protestant theologians, among them: Abraham van der Heyden (1597–1678), professor of theology in Leiden⁴⁷⁹; the English Puritan theologian Richard Baxter (1615–1691)⁴⁸⁰; the Orthodox Lutheran philosopher and theologian,

Johannes Andreas Quenstedt (1617–1688), professor in Wittenberg⁴⁸¹; the Dutch Calvinist theologian, Andreas Essenius (1618–1677)⁴⁸²; and the Dutch neo-Calvinist scholar and professor in Gronigen, Johannes Braun (1628–1708).⁴⁸³ The same view was voiced by the Reverend Stephen Lobb (d. 1699), who denied the existence of commutative justice even in the relationship between God and Jesus Christ; the latter's merit is only according to the rule of distributive justice.⁴⁸⁴ Moreover, the notion that according to the rule

voluntarily doth oblige himself to us, it is *impossible* that God should be *our Debtor*, and consequently that upon terms of *commutative justice* we should *Merit* anything of God. For what can we render to him but his *Own*? And how should he (properly and antecedently) be indebted to for his *Own*"? Baxter, who was involved in many theological controversies, encountered legal troubles and spent some time in prison for his views until his release by the Declaration of Indulgence in 1687.

of commutative justice man may merit of God is in the author's view absurd, since man cannot give God anything which is of a value proportional to eternal life, to infinite excellence. The author then adds in this connection:

However, notwithstanding the ridiculousness, as well as falseness, of the notion, there are many among the Papists (if we may believe Arriaga) who assert it. It is true, Vasquez explodes it, with an essay to evince that the Papists generally reject it; but Arriaga, a later Jesuit, freely rebukes Vasquez, affirming that commutative righteousness is in God, and may be found to be between God and man, and that this is generally received in the church of Rome. "For," says he, "this is the opinion of Suarez, Valentia, Granadus (who introduces Medina and Alvarez, to agree with him in this point), Hurtado de Mendoza, Ragusa, Tannerus, and Albertinus, and Molina also; who, though he expresses himself with caution in one place, yet elsewhere doth freely enough own it. Besides, Capreolus and the Thomists generally," says Arriaga, "do agree with him in this"; and that therefore Vasquez is greatly to be blamed for affirming that so many were of the contrary opinion; whereas this about merit quoad iustitiam commutativa, ["as to commutative justice"] has many more authorities than Vasquez could produce for his sense of it. In fine, Arriaga corrects Vasquez' mistake, in saying that Hosius and Scotus were against commutative righteousness, and then proceeds to an attempt of demonstrating the truth of this doctrine.

By this it is apparent that, if we may believe Arriaga, the Papists generally assert merit according to commutative justice; in which sense it is mostly oppugned by the Protestant writers, as a ridiculous doctrine: the which, from what has been already suggested, has been manifested. But seeing this doctrine contradicts our reason, our endeavours

must not be how to improve it; we must immediately reject it as false and unreasonable. 485

This evident disrespect for the scholastic literature is not an isolated incidence. A further good example of this tendency—that appears to be growing in the wake of the reformation—constitute the writings of the English Puritan minister John Owen (1616–1683), Dean of the Christ Church College in Oxford. In his *Dissertation on Divine Justice*, ⁴⁸⁶ he undertakes the task to refute the extreme thesis, adopted by the "Socinian heresy," of the purely voluntary character of divine punishment. Referring to some of the scholastic discussions on the notion of justice, he refers to the authors (such as Duns Scotus, Durandus, Paludamus, Cajetanus, Gabriel, Pesantius, and Suárez) as "hair splitters," "triflers," and "bunglers." Owen then adds:

They resemble those advocates in Terence, whose opinion, after Demipho, embarrassed by the cheats of Phormio the sycophant, had asked, he exclaims, "Well done gentlemen; I am now in a greater uncertainty than before!" so intricate were their answers, and resembling the practices of the Andabatae. 488

Suárez's view on the merits of Roman Catholics with God, Owen calls a "rotten fiction." He then suggests dismissing "these bunglers (who know not the righteousness of God)" from his dissertation, in order to attend to "the more sure words of prophecy."⁴⁸⁹

Jewish Commentators

IT IS A MOST NOTEWORTHY FACT that in the whole classical Jewish (rabbinic) literature one does not find an attempt of defining the notion of justice, neither that of law. Generally, it appears that the rabbis were considerably more interested in concrete solutions than in abstract legal concepts. 490 Moreover, the Jewish scholars first learned the ideas contained in Aristotle's *Ethics* through the intermediary of the Arab philosophers, probably only in the twelfth century. 491

However, even after Aristotle's *Nicomachean Ethics* became known to Jewish scholars, there was—in great contrast to the Christian scholastics—no interest in Aristotle's specific analysis of the notion of justice. The interests lay elsewhere. Very few Jewish scholars mentioned at all the Aristotelian distinction; an analysis of Aristotle's distinctions relating to the forms justice was undertaken by even fewer ones, namely by those three to four scholars who composed an original commentary on Aristotle's *Ethics*. Nevertheless, there is considerable interest in these rare attempts of analyzing the Aristotelian distinction on the background of the Jewish legal tradition.

An early Hebrew source dealing with Aristotle's *Ethics* was the translation of Averroes' *Middle Commentary on the Ethics* made from the Arabic by Samuel ben Judah of Marseilles in 1321/22.⁴⁹² It seems, however, that this translation had relatively little impact on Jewish philosophy.⁴⁹³ A first (direct) Hebrew translation of Aristotle's *Nicomachean Ethics* was made from Robertus Grosseteste's Latin version by R. Meir (Harofe) Alguadez of Castile in 1405.⁴⁹⁴

As a matter of fact, Aristotle's *Ethics* became quite popular among Jewish scholars in Spain, especially among those who were committed to philosophy. ⁴⁹⁵ Moreover, one can discern the influence of scholasticism, and more

specifically that of a number of leading Christian theologians, such as Thomas Aquinas.⁴⁹⁶

A first commentary on the *Ethics* was written by Josef Ibn Shem Tov in Spain (1400–1460) in 1455, using the Hebrew translation of R. Meir (Harofe) Alguadez.497 In relation to the Fifth Book, the author follows basically the analysis of Aristotle, but refers in many places to Jewish Talmudical sources that correspond, in his opinion, to Aristotle's views and can serve as their illustration. He explains at length the difference between the geometric proportion in the framework of distributive justice and the arithmetic proportion in commutative justice. He states that in the former one looks at the persons, in the latter at the acts. In relation to the known problem of *contra*passum, namely, the above-mentioned apparent internal contradiction in Aristotle's approach, the author adopts a solution similar to that of the scholastics: hitting a prince means an increase in the actual damage. 498 It causes shame to the prince and to the entire people. He mentions that, in relation to retribution, the Jewish sages had laid down the corresponding principle: "Everything is in accordance with the person causing the indignity and the insulted party."499 The author then critically mentions the commentary of Ibn Rushd, according to which in Aristotle's view a prince who hits an ordinary

person should be punished more severely than the contrary situation where an ordinary person hits a prince. 500

In the author's view, even if there is some truth in the idea that a person's higher standing may increase the severity of his delict, this cannot be Aristotle's opinion in relation to retribution. He suggests the possibility that Ibn Rushd used a garbled text of Aristotle, since in the present correct version, the contrary solution is mentioned. The criterion under commutative justice is not the quality of the person as such, but the quantity of the actual damage. ⁵⁰¹

Rabbi Yizhaq Arama (1420–1494), a Spanish Talmudist and philosopher, is another most influential Jewish scholar who was familiar with Aristotle's *Ethics* and with the commentary of Josef Ibn Shem Tov. ⁵⁰² In his major work, *Aqedat Yizhaq* (עקידת יצחק), Arama refers to the known problem of Aristotle's comments on retribution (*contrapassum*). ⁵⁰³ After stating the apparent contradiction between the elements of commutative justice, which disregard the status of the litigants, and the later comments of Aristotle on retribution, the author states:

Indeed, commutative justice does not consider the value of the other people, but it retaliates according to the actual deed of a person, and if he caused a damage of ten dinars, it will command that he will be damaged for ten dinars; and if a person suffers damage for ten dinars, it is appropriate that he will gain in return ten dinars. Commutative justice requires to evaluate the quality and the quantity of damage. In the manner that law considers the difference in the quantity of damage, it should consider its quality, since quality is connected to quantity. As a result, the hitting of an ordinary person by a Prince is not of equal shame and injury as the hitting of the Prince by an ordinary person. And if the Prince, who hit an ordinary person, is punished by being hit himself, the shame and injury caused to him is of a much greater measure than that caused by him, thus constituting an eminent injustice. Equally, when an ordinary person, who had hit the Prince, is merely hit

in return, that person has not suffered a punishment that is equal to what he did. Indeed, everything should be according to the position of the insulter and that of the person insulted. Thus, the law judges both on an equal basis, since, when it is lenient in this way towards the Prince, it does not remit, because of his princehood, anything of his appropriate punishment; it does so because the Prince did not cause the ordinary person a greater injury that the punishment meted out to him. Equally, when the ordinary person is punished with more than a blow, this is not because of his inferior status, but because the injury suffered by the Prince through him is greater than a mere blow in retaliation. As a result, all persons are equal under this justice, the insignificant as the mighty, the just as the wicked; as they did, so shall be done to them, equal to equal. ⁵⁰⁴

In 1480 Baruch Ibn Yaish composed another Hebrew commentary on the *Nicomachean Ethics*. He based his commentary on two new fifteenth-century Latin translations.⁵⁰⁵ This Hebrew commentary, too, remained in manuscript form.⁵⁰⁶ The commentary on the Fifth Book of the *Ethics* is rather succinct, and it lacks originality.⁵⁰⁷ Moreover, no Jewish sources are mentioned in the commentary.

The next comprehensive commentary on the *Nicomachean Ethics*, entitled *Penei Mosheh*, was written by Moses Almosnino (ca. 1518–1581) of Salonika.⁵⁰⁸ The author used the mentioned Hebrew translation of Meir

(Harofe) Alguadez. Unfortunately, this commentary, too, remained unpublished and has been preserved in an apparently only partial manuscript.⁵⁰⁹

However, Moses Almosnino published a book on Jewish ethics,⁵¹⁰ where he dedicates three chapters to the virtue of justice.⁵¹¹ He expounds in a rather summary way the Aristotelian distinction between distributive and commutative justice.⁵¹² The author basically follows Aristotle; he links the substance of justice to the rules of Jewish law.⁵¹³ He notes that in relation to Divinity, distribution of benefits is not a form of justice, but an act of pure mercy and compassion since God has no obligations.⁵¹⁴ The author mentions the fact that in the framework of commutative justice, one has to disregard the litigants' respective virtues; however, he refers this rule to the biblical commandment of the judges' duty to a strict impartiality.⁵¹⁵ He mentions the Talmudical saying that every judge who judges a true judgment according to the truth becomes a partner to the Holy One, blessed be He.⁵¹⁶ It is not enough

to adjudicate according to truth, if it is done out of fear or out of other external reasons; justice must be done exclusively for the sake of truth.

The author then refers to the rejected view of the Pythagoreans. He explains that, in accordance with the rabbinical sources, the difference in retribution between persons of different social status is not based upon any inherent quality of these persons, but upon the difference of the injury.⁵¹⁷

The philosophical approach among Jewish scholars, that was rather widespread in Spain (until the expulsion of the Jews in 1492), in Provence and equally in Italy, lost much ground in the sixteenth century until its near disappearance in rabbinical circles. A major reason for that change was most probably the rapid and vast spread of Jewish mysticism, the Kabbala, throughout the whole Jewish world. This movement became intrinsically hostile to the rationalistic Greek philosophy as well as to the scholastic project of its adaptation to religion. A relevant example of the shift from rationalism to mysticism presents Yohanan Alemanno (1433–1503), who in his *Song of Salomon's Virtues* deals specifically with the virtue of justice. However, the author—very remote from the formal distinctions of Aristotle—includes in the notion of justice a "right will," harmony between faculties of the soul, and, principally, the mystical ascent toward God in the framework of Kabbalistic symbolism. ⁵²¹

No wonder, that for the next Jewish scholar to publish a commentary on the *Nicomachean Ethics*, one had to wait until the eighteenth century for the Jewish enlightenment movement (*Haskala*). It was the Jewish scholar and philosopher, Isaac Satanow (1732–1804), who published an extensive commentary in Hebrew together with the mentioned medieval Hebrew translation of Meir (Harofe) Alguadez of Castile of 1405.⁵²² The author, who was a complex and controversial personality,⁵²³ was familiar with the commentary of Josef Ibn Shem Tov,⁵²⁴ to which he referred, in a number of instances, in a critical way.⁵²⁵

In relation to commutative justice, the author explains the difficult Aristotelian notion of equalizing gain and loss in delictual situations:

The judge will try to assess in order to equalize the pleasure of the injurer with the pain of the injured. And this he will achieve by causing pain to the injurer according to the measure of the pleasure the latter had when

injuring his neighbor out of malice and wickedness and by causing pleasure to the injured from the assets of the injurer or by causing the injurer pain as revenge according to the measure of the injured's pain.⁵²⁶

The author then states that, since individuals differ in their affection when submitted to bodily assaults, a judge inflicting exactly measure for measure would do wrong justice. He continues:

Hence the right justice is when the judge assesses and fills the pain with the pleasure of money, as the sages said "eye for eye means money for the eye" and they said "one assesses the corporal punishment." When compensating injuries that differ among persons, the judge will equalize the pain with the pleasure according to each individual's value: the great and important person will be given more, the lesser will get less. And in this sense, it was said [by Aristotle] "taking away the gain," 527 meaning that he eliminates the pain of the injured person by means of the money of the injurer, that the latter gained, and not that it will be paid from the latter's body which is like a kind of capital that will not be called "gain." This seems to me to be the right interpretation of Aristotle's words. But, Rabbi Josef Ibn Shem Tov interpreted it differently, namely that the judge will try to equalize it by equalizing the pain with the pleasure according to the actual injury. He explained "gain" as referring to the pleasure, and "loss" to the pain. And I wrote what seemed to be right according to my humble opinion.

The author then deals with the Aristotelian text concerning retribution (*contrapassum*) and the criticized view of the Pythagoreans. The author first explains the difference in respect of the measure of punishment between the case of an ordinary person hitting a prince or governor, and the case of the latter hitting an ordinary person. He then illustrates this principle by means of Jewish sources. The first case corresponds to the biblical story of Shimei the son of Gera, who was eventually put to death because he had cursed and insulted King David. 528 The second case is illustrated by the Talmudic principle

that if a sage committed an offence that is punishable by excommunication, he will get a lighter punishment of shame and disgrace. 529

The author then continues:

Do not think that when Aristotle says that the punishment is according to the honor, he contradicts what he said in the preceding chapter, namely that commutative justice, of which he spoke, is not applied according to the honor of persons, but according to the measure of the injury: With the measure that a person measures, so it is measured out to him,⁵³⁰ the honorable person like the ignoble one, as he [Aristotle] wrote: "For it makes no difference whether a good man has defrauded a bad man or a bad one a good one." Because there he spoke of pecuniary laws and of matters that do not relate to the body, [hence, of a matter] that is equal and equalizes the great and the small, because it is not concerned with honor or with shame. But here justice concerns duties of the body that have an influence upon honor. Hence, the punishment considers the value of each person's honor. Such was the question and such was the answer given by Rabbi Josef Ibn Shem Tov, and I had my say in the preceding chapter that the condition of Aristotle's view was that the judge should try to assess in what places the punishment should be ransomed by money and capital, taken away from the profit of the person, namely from his property. There is a great difference between voluntary and involuntary, since sales and other transactions are executed with the consent of the owners. whereas injuries and their compensation are made without the consent of the owners, both fall under commutative and corrective justice, as explained in the fourth chapter. In any event, their legal regime is not identical, since in case of voluntary transactions no attention is paid to the persons, but to the exchanged objects in order to be mutually equal. The owners, i.e., the buyer and the vendor, may be one a master and the other a slave, or both slaves, or both masters; however the nature of the sale remains identical in both cases, since everything follows the value of the exchanged things, not that of the owners; It is



different in cases of involuntary [transactions], namely damaging acts, such as bodily injuries. Justice in relation to them is according to the value of the owners, as explained by [Aristotle] by the example of the Prince's blow. So the Sages said: "Everything is in accordance with the person causing the indignity and the insulted party." If it would be otherwise, you would render impossible human life, since "the youth will be insolent to the elder and the base to the honorable," and they would pay him for his shame a fixed sum of money as if he were one of the ignobles. This seems to me to be the meaning of Aristotle's sayings. 533

Post-Scholastic Writers

THE TRANSITION FROM SCHOLASTICISM TO POST-SCHOLASTICISM was evidently a gradual matter. It signifies on the one hand, a critical approach toward medieval scholastic thought by a direct return to the classical thinkers of the antiquity. It is the period of the so-called Renaissance characterized by the activity of the humanists. ⁵³⁴ But, on the other hand, it could also mean a critical approach to Aristotle himself. ⁵³⁵ The critique of Aristotle was considerably enhanced during the succeeding era of the Enlightenment. ⁵³⁶ In the limited framework of our study, we will concentrate on the Aristotleian distinction of justice. ⁵³⁷ Naturally, not all humanist scholars added original

ideas to the classical distinction; many limited themselves to a rather succinct description of Aristotle's writings. This is especially true for the literary genre of compendiums for students of Aristotle's *Ethics*, works that concentrated on the original text. Besides the reliance on Greek and Roman sources, one finds in the post-reformation theological-moral literature an enhanced reference to biblical quotations in support of the Aristotelian notions of justice. 40

The Flemish Judocus Clichtoveus (1472–1543), a Catholic humanist, theologian, and influential teacher at the University of Paris, analyzes in his commentary on Aristotle's *Nicomachean Ethics*, the notion of justice on the background of the classical writings of the antiquity.⁵⁴¹ He affirms that in the framework of distributive justice, the distribution of benefits is better and more dignified than the distribution of evils and punishments. Distribution of benefits assimilates man to the intelligible and celestial world.⁵⁴²

Moreover, it is more enjoyable for the just man, since distribution of evils causes sadness and compassion. ⁵⁴³ Commutative justice in commerce exists only where there is human need (*indigentia*). It alleviates or removes that need. In heavens, since there is no need, there can be no commutative justice. Hence, there the more dignified distributive justice is practiced. In the world of darkness, where need is at its utmost, commutative justice is not conspicuous. Commutative justice of commerce is practiced in this world of senses, where there is partially sufficiency and partially need. ⁵⁴⁴

The author affirms that distributive justice is of a geometric proportion: benefits according to merits (two different merits, two different benefits); punishment according to the measure of guilt (two different delicts, two different punishments). ⁵⁴⁵ Commutative justice observes an arithmetic proportion. The measure of commutative justice is determined by human need (demand); the greater the demand the greater the price. A thing is not valued according to its natural dignity, but according to the human need. If something is not needed, there is no exchange. ⁵⁴⁶

The Aristotelian distinction was equally analyzed by the great humanist jurist and theologian of the Reformation, Philipp Melanchton (1497–1560). He insists, on the basis of Aristotle's work, that there are only two forms of particular justice, commutative and distributive. Tommutative justice is based on an arithmetic proportion and includes punishment that distributive justice applies a geometric proportion in bestowing upon persons private and public functions and offices. The author then illustrates that division of justice by a series of examples. Thus, he recounts Aesop's fable on the animals which, after hunting together, divide the quarry (three oxen) under the lion's governance: The luckless jackass and horse apply, respectively, commutative and distributive justice the clever fox safeguards the

"lion's share." ⁵⁵² In the author's view, the story demonstrates a tyrant's confounding of the two forms of justice. ⁵⁵³

Another typical humanist work is the commentary on Aristotle's *Nicomachean Ethics* by the eminent Florentine philologist Pietro Vettori (1499–1585).⁵⁵⁴ His commentary follows the Greek origin and its Latin translation. Totally unconcerned with the scholastic discussions, he concentrates more on the philological aspects and tends to rely on classical sources for the illustration of some ideas.

An additional trend in post-scholastic literature is the emphasis on Roman law. Thus, the French humanist jurist François Connan (1508–1551), after stating the Aristotelian distinction between the two forms of justice, adduces a number of examples from Roman succession law in order to illustrate the difference between arithmetic and geometric proportions.⁵⁵⁵

A typical humanist approach one finds in the oration on justice of the German scholar Nicolaus Agricola (b. 1520), that he delivered as rector in Regensburg in 1555. The classic sources are his starting point for sayings and examples on the notion of justice as well as for the Aristotelian distinction. The orator describes the political importance of distributive justice that, based on a geometric proportion, attributes offices, benefits, and punishments. He emphasizes the fact that the arithmetic proportion of commutative justice is equally applicable to involuntary contracts. Thus, Orestes who killed his mother was convicted under Greek law to the capital punishment.

However, the laws for punishing delicts differ in the various states. They are just if they conform to God's will and to human reason. The laws are enacted out of distributive justice considerations, taking into account the circumstances of the persons, the places, and the times. Once these laws have been so established, they are rightly considered to be orders of commutative justice that are applied by the judge in order to achieve equality between the delict and the injury.⁵⁵⁹ In the whole nature a measure of equality between agent and patient is necessary, otherwise things perish. A lack of equality is like a too strong medicine that causes the destruction of the body, or a too strong light that blinds the eyes. Finally, need (*indigentia*) lies at the basis of the measure of equality in relation to commodities and services.⁵⁶⁰

Another important post-scholastic jurist is the Flemish Matthias Wesenbeck (1531-1586), who, after joining Protestantism, became Dean of the Law Faculty in Jena and later rector of the University of Wittenberg. He is one of the founders of the early usus modernus pandectarum. In his influential commentary on the Pandects, he discusses the Aristotelian notions of justice. 561 He identifies the virtue of particular justice with the famous Roman definition of Ulpianus: *Constans e perpetua voluntas ius suum cuique tribuens*. ⁵⁶² The author then illustrates the geometric proportion applied in the distribution of public functions and rewards by means of a variety of positive Roman legal rules. He then states that nowhere is the application of a geometric proportion more conspicuous than in the distribution of punishments. Though the law in general and in the abstract establishes for punishment an arithmetic proportion—by measuring it according to the delict according to the *lex talionis*—it nevertheless adapts it in the concrete case to the person of the offender and to that of the victim according to a geometric proportion.⁵⁶³ On the other hand, in transactions no attention is paid to the difference in the status of the contracting parties. The author refers the primary reasons (causa efficiens) of the two forms of justice to divine design and relates their functions (finis & effectus) to the service of Divinity and the welfare of society. 564

In a book published in 1572,⁵⁶⁵ the author Detlev Langenbeck describes the geometric proportion by the example of the human stomach that distributes the food to the various parts of the body according to their nature and dignity: the heart, the eyes, and the brain receive the best one, the hands and feet according to their quality. True, all are human beings, but there are differences in their quality and circumstances. Likewise, the earth gives each plant food according to its nature.⁵⁶⁶ The arithmetic proportion is applied in

contracts, acts, obligations, and offenses. Here, the great and powerful is bound to keep his contract and punishable for offenses like the low one. ⁵⁶⁷ Since there is a great difference between these proportions, the prudent man must know, especially if he sits in government, which one to apply. The author then mentions the story of the young King Cyrus of Persia as recounted by Xenophon ⁵⁶⁸:

The young King Cyrus committed a grave mistake in relation to these proportions and as a result was severely punished by his teacher of justice. A big boy with a little tunic, finding a little boy with a big tunic on, took it from him by force, giving him his little tunic. The case came before the young King who decided that the little boy should keep the little tunic, the other boy the big one. However, it would have been

much more equitable and just that each should have got back the ownership of his own tunic, without paying attention to any difference between the persons or to their standing. For in this case not the geometric proportion, but the arithmetic one should take place.⁵⁶⁹

The French jurist and political philosopher, Jean Bodin (1529-1596), also starts from the Aristotelian distinction between corrective and distributive justice, but he criticizes the assumption of their dichotomous, mutually exclusive character.⁵⁷⁰ In his view, the two forms of justice have to be combined in a harmonious way. Thus, he claims that Aristotle was wrong in assuming that punishment, in distinction to rewards, should be imposed according to an equal, arithmetic justice. He states that, as a matter of fact, aristocratic people always received a milder punishment. Had Aristotle been a judge, or at least read and understood the laws of his country, he would never have written that punishment should be meted out according to arithmetic justice. The right measure is a combination of geometric and arithmetic, i.e., harmonic justice. Moreover, Aristotle errs when postulating that in sanctioning offences one had to ignore the good or evil character of the offender. On the contrary, that should be the foremost factor in the eyes of the judge. Equally, in relation to corrective justice, it is not enough that a thief always restores the mere loss of the victim.

In some ancient laws, he was obliged to pay the double, the triple or more of the stolen object's value. Even in cases of mere civil liability for damages, the concrete situation of the litigants was decisive for the existence of liability and the measure of interest. All this is the result of the application of harmonic justice, the combination of distributive and corrective justice.⁵⁷¹

A typical representative of the humanist approach is the German Professor of Ethics at the University of Jena, Wolfgang Heider (1558–1626). He refers directly to Aristotle's text and to the classical literature, disregarding the

scholastic endeavors.⁵⁷² His concrete examples, relating to the two kinds of justice, are taken from classic authors: Homer, *Iliad*,⁵⁷³ Plutarch, *Apophthegmata Regum*,⁵⁷⁴ Laertius, *Lives of Eminent Philosophers*,⁵⁷⁵ Xenophon, *Cyropaedia*,⁵⁷⁶ and Gellius, *Noctae Atticae*.⁵⁷⁷

The author notes that distributive and commutative justice differ in their action (division and exchange), in their object (things to be distributed and contracts), and in their proportion (geometric and arithmetic). In relation to punishment, the author suggests that it falls under both forms of justice. It conforms to corrective justice, since loss and profit are removed and brought to an equality that resembles an arithmetic proportion. Moreover, the punishment has to correspond exactly to the offense, as done in retaliation. However, it can also be classified under distributive justice, because it takes into account a person's merits.⁵⁷⁸ In this context, the author defends the Pythagorean notion of *antipeponthos* against Aristotle's critique. In his view, the Pythagoreans did not conceive retaliation as a simple equal act, but rather something proportional, taking into account the specific merits of the case. Thus, if somebody imprudently causes death, reciprocity certainly does not mean to kill the offender, but to punish or exile him.⁵⁷⁹

The Oxford philosopher and physician John Case (ca. 1540–1599), characterized by Charles Schmitt as an "eclectic Aristotelian," ⁵⁸⁰ actually closely followed in his work on ethics Aristotele's analysis of the two forms of justice. ⁵⁸¹ The author, using in his work a Socratic method of oppositions and responses, ⁵⁸² fully defends the Aristotelian approach. In relation to the example of the commoner who, after being hit by the ruler has no right to hit back, the author gives the classic explanation that retaliation is excluded not because of dignity, but in view of the greater damage caused to the community. ⁵⁸³ The author's original addition relates to the position of kings and rulers. They have to be honored even if they lack virtue. Kings are subject to nobody except to Divinity and nature. Hence, there is no right to rebel against rulers. ⁵⁸⁴ The author mentions in this context the biblical story of David restraining himself twice from killing King Saul, and his putting to death the young informant who (falsely) vaunted himself to have killed Saul. ⁵⁸⁵

The German philosopher and Protestant theologian Bartholomäus Keckermann (ca. 1571–1608), follows basically the Aristotelian analysis.⁵⁸⁶ Distributive justice is based upon a geometric proportion, taking into account the higher persons' status and dignity or their merits. He insists that punishment makes part of distributive justice.⁵⁸⁷ The same is true for retribution (*ius talionis*).⁵⁸⁸ According to Aristotle's criticism of the Pythagoreans'

notion of *antipeponthos*, it does not signify simple, identical reciprocity but an analogical, proportional one. Thus, if a person injures, by means of words or acts, a public orator while standing on the rostrum, he must be punished more severely, not only because of the person's circumstances, but also in view of the location. The concept of judicial justice (*iustitia iudiciaria*), that prohibits to take into account personal qualities which are not relevant to the issue in litigation, makes also part of distributive justice. Moreover, distributive justice includes equally defensive and preventive justice (*iustitia defensiva*, *iustitia propulsatrix*) that protect innocent, vulnerable persons from being injured. Figure 2.

On the other hand, commutative justice applies an arithmetic proportion and does not pay attention to the personal qualities of the contracting parties, but only to the things exchanged. However, the required equality between the things exchanged does not mean the exclusion of any profitmaking in the commercial transaction. 593

The German Calvinist scholar, Abraham Scultetus (1566–1625), preacher and iconoclast,⁵⁹⁴ considered the notions of distributive and commutative justice to be too restricted.⁵⁹⁵ In his view, they do not include the virtues of

veracity, gratitude, and *innocentia*⁵⁹⁶ that are subjects of justice. On the other hand, he considers the essence of all justice to be the function of distribution, since between *suum cuique tribuere* and *suum cuique distribuere*, there seems to be no difference. Moreover, the arithmetic proportion is applicable not only in relation to contracts, but equally to delicts and punishment. Hence, some call punitive justice commutative justice, others distributive justice. As a result, he suggests that the whole Aristotelian distinction is unsatisfactory.⁵⁹⁷

These objections did not remain unanswered. Valentin Wudrian, the respondent in an academic disputation, argued that Scultetus himself confounded between immediate and mediate distinctions. ⁵⁹⁸ Thus, e.g., the virtue of gratitude will fall—if referred to particular justice—under distributive justice. Likewise, veracity does not in itself constitute a kind of particular justice, but relates to the matter of agreements. The same is true for honesty and abstention from wrongdoing (*innocentia*) that belong to commutative justice. Since these virtues constitute an indirect, mediate part of particular justice, they, by no means, exclude the immediate kinds of justice. ⁵⁹⁹

The idea that all forms of justice are based upon the virtue of "giving everybody his due" ("suum cuique tribuens") is not to the point, since not all cases fall under distributive justice. Distributive justice is the standard for the distribution of things, commutative justice, on the contrary, for the exchange of things. ⁶⁰⁰

In relation to punishment, the author notes that the majority of scholars consider it to be part of distributive justice. However, he objects to that view for four reasons: 1) Punishment is not an object of distribution: It is not property of the state that can be distributed among the citizens. 2) Objects that are distributed on the basis of distributive justice are given according to the individual's position in the state, qua citizen and member of the community. Punishment is meted out not in the offender's capacity as a citizen, but because the delict he committed deserves punishment. 3) Objects that are distributed on the basis of distributive justice are to be distributed among all citizens. Punishments, to the contrary, are imposed solely upon criminals. 4) Aristotle agrees to that conclusion, since he refers the compensation of involuntary contracts—which are nothing else than the punishment of delicts—to contractual justice and not to distributive justice. 601

In addition, the author states that he does not join the view of most scholars, according to which punishment is based upon a geometric proportion. In his opinion, punishment is a matter of commutative justice for a number of reasons: It involves equality between the delict and the penalty; and insofar the condition of a person is taken into account, it is merely in order to assess the quantity of a thing and not the form of the equality. The law prescribes the measure of punishment according to an arithmetic proportion and requires to impose it without paying attention to the person's status. Moreover, if the geometric proportion would be appropriate in imposing punishment, then, for an identical offense, the more dignified person should be punished more severely than the less worthy one. This, however, is absurd. Finally, the author declares that commutative justice lies in the equality of exchange and not in its inherent physical quality or

natural essence. Its measure is determined by its need and utility in the human life. 605

Identical conclusions on similar grounds we find in another, later dissertation on commutative justice published in Leipzig in 1670.⁶⁰⁶ The author insists—again against the opinion of a majority of scholars—that punishment for delicts constitutes commutative justice based upon an arithmetic proportion.⁶⁰⁷ True, different persons may be punished differently for the same offence. Thus, e.g., a simple theft may be committed by a person in a public office or by an ordinary person. The punishment will be different: For the official it is enough to be removed from office, but the ordinary person may be punished by lashes. Still, it constitutes commutative justice on the basis of arithmetic equality, since the persons are not considered *per se*, as it is done in distributive justice.

Here, the position of the delinquent person is taken into account *per accidens*, in order to equalize the punishment. If both would get the same punishment, the more honorable person would suffer pain and in addition to it lose his dignity, whereas the private person would merely suffer pain. In order to achieve equality, the punishment is not based upon a simple comparison of the public and private person, but attention is foremost paid to the delict and the punishment. ⁶⁰⁸

Distributive justice is different: It divides common things to the members of the community; benefits are distributed according to the citizens' position and dignity in the state. Punishments are meted out to persons not qua citizens, but qua delinquents.⁶⁰⁹ The author, after discussing the measure of

equality in transactions and the function of money,⁶¹⁰ comments on Aristotle's critique of the Pythagorean notion of *antipeponthos*.⁶¹¹ In his view, there is an affinity between the *jus talionis* and the notion of justice, even if not a full identity. Retaliation should be understood not as a simple equality, but as implying a proportion between delict and punishment.⁶¹²

A different approach toward the distinction was voiced in an earlier dissertation, presented at the University of Wittenberg under the direction of the Lutheran theologian Nicolaus Hunnius (1585–1643) by the respondent G.-F. Rosa. ⁶¹³ In relation to both commutative and distributive justice, the author starts with rejecting the view of the Anabaptists according to which the very exercise of these forms of justice runs counter the Christian faith. ⁶¹⁴ In commutative justice, both the arithmetic and geometric proportions are applied. ⁶¹⁵ The former applies in relation to persons: the differences in their respective merits have to be disregarded. Geometric proportion is used when comparing different things or comparing things to services. In these cases, equality is not measured according to quantity but according to value. Thus, in case of a sale of wood, the quantity of gold for its payment is not equal to that of the wood, but equality is measured according to their respective value. ⁶¹⁶ The value of an object includes also labors or other services that

have been performed in its connection. However, only those expenses are taken into account that were necessary for the thing to be sold.⁶¹⁷

After a rather lengthy discussion about the legitimacy of taking interest (*usura*),⁶¹⁸ the author then classifies punishment as falling under the heading of distributive justice.⁶¹⁹ The punishment has to be measured according to the gravity of the criminal act, by taking into account the surrounding circumstances. Thus, taking away a penny from a poor man might be more serious than taking away a pound from a rich man.⁶²⁰ Similarly, an offence committed by a public officer is graver than that of a private person. Moreover, the frequency of a crime requires harsher punishments, such as the death penalty for theft.⁶²¹

The problem of classifying punishment occupied also the Dutch Calvinist scholar and theologian Antoine de Waele (1573–1639), professor of divinity at Leiden. In his summary of the Aristotelian ethics, ⁶²² he suggests, in order to reconcile the different sayings of Aristotle, to distinguish between public and private delicts. The retribution of the former falls entirely under distributive justice. The author illustrates the application of distributive justice to a public offence by means of the reaction of King David to the shame caused to his envoys by the Ammonites: not an equal act of retaliation but public war. ⁶²³ However, in case of a private delict, both forms of justice may be applied. As far as the delict causes damage to the public, distributive justice and a geometric proportion are required; as far as the damage concerns private citizens, commutative justice and an arithmetic proportion have to be applied. In this way, both the state and the private person get simultaneously satisfaction.

Another Dutch scholar, Franco Burgersdijck (1590–1635), professor of logics and ethics at Leiden, gave an identical answer to that problem. ⁶²⁴ He assumes that punishment, as such, falls under distributive justice, but the satisfaction of delicts may involve both forms of justice, one (distributive) in relation to the damage caused to the state, the other (commutative) to that caused to the private citizen. ⁶²⁵ The *jus talionis* (*antipeponthos*), in its strict sense, does not conform to either of the two forms of justice. ⁶²⁶ It does not take into consideration the difference in status nor the specific circumstances of a delict, such as the mental state of the perpetrator. Moreover, in certain crimes, such as adultery, exact retaliation is impermissible. Even in voluntary contracts it is inapplicable, since the differences in regions and desires prevent that identical things are exchanged. ⁶²⁷ However, when the idea of equality is applied not in the strict sense of identity, but by way of analogy, then retribution (*jus talionis*) constitutes an integral part of commutative justice that is applicable to all transactions, voluntary and involuntary. ⁶²⁸ It signifies adequate compensation.

An interesting classification of the various terms relating to justice is suggested by the influential English Protestant (Puritan) scholar, William Ames (1576–1633), professor of theology at the Dutch University of Francker in Friesland. The basic distinction is between distributive and emendative justice. 629 He states:

Emendative justice is either Commutative, or Corrective. Commutative Justice, presupposeth some Injustice, and is either civill or criminall.

Civill doth chiefly correct the injustice of the cause. Criminall doth chiefly correct the injustice of the person. To corrective Justice pertaineth revenge, and restitution. Revenge is an act of corrective Justice, whereby punishment is inflicted on him, who hath violated Justice . . . Restitution is an act of corrective Justice, whereby another is set againe into the possession of that thing of his own whereof he was unjustly deprived.

These distinctions were basically adopted later in the work of the German-Dutch, Reformed philosopher and theologian Peter van Mastricht (1630–1706), professor at the University of Utrecht. 630

A typical humanist approach to the problem of justice, one finds in the work of the famous, controversial French Protestant theologian Moïse Amyraut (Moses Amyraldus) (1596–1664), professor at the University of Saumur. Following rather closely the analysis of Aristotle, the author relies on illustrations from the Bible and classical literature; in relation to the latter, he uses especially examples taken from Cicero's *De officiis*. Punishment makes part of distributive justice applying a geometric proportion by taking into account the disparity of persons. The author, however, states that not everybody agrees here with Aristotle: Some ancient and modern scholars prefer the practice of Rhadamantes, applying the rule of *lex talionis* (*antipeponthos*). The author believes that this problem belongs rather to the political legislator than to moral philosopher. It is important to abide by the law. But basically he believes that Aristotle is right in assuming that the gravity of a delict depends on the victim's disparity of dignity. In a lengthy chapter on

commutative justice, the author deals with the problems of just price, fraud, natural law, and usury. 634

The Dutch scholar Adrianus Heereboord (1614-1661), professor of philosophy at the University of Leiden, equally follows in the steps of Aristotle. 635 Distributive justice relates to public benefits and charges applying a geometric proportion⁶³⁶; commutative justice is concerned with private transactions subject to an arithmetic proportion. In relation to the latter, the author distinguishes between voluntary and involuntary transactions: in the former, the compensation refers only to the object matter of the transaction; in the latter to both the damage and the offense. 637 Contrary to distributive justice, commutative justice does not take into account a person's status or merits. Thus, a prince and a plebeian will pay the same amount for a pair of shoes. Similarly, a colonel and a simple soldier will pay the promised rent for their home.⁶³⁸ A public official has to pay for his private deals from his own money. In case of involuntary transactions, at least one party does not agree to the act, such as in case of theft, adultery, and poisoning. The author then refers to the question what are the gains and losses in these cases. His answer is that the gain of the person who kills another consists in the satisfaction of his vengeance or hatred.639

In relation to punishment, the author insists that, since its measure is according to the gravity of the offense, it applies an arithmetic proportion. In this respect it partakes of commutative justice. This, however, does not mean that for an equal delict all offenders must be punished by an identical penalty. Thus, the removal of a public officer from his office might constitute a heavier punishment than the whipping of a plebeian. On the other hand,

the fact that punishment is imposed by a public officer constitutes an aspect of distributive justice. As a result, punishment belongs partially to the two kinds of justice. 640

The English Puritan theologian Richard Baxter (1615–1691), distinguishes in relation to punishment between the commutative justice aspect of compensating the victim and the distributive justice aspect of satisfying the public interest; in his words:

But here you must distinguish betwixt *satisfaction* in Commutative Justice, for a Debt, or *injury*, and *satisfaction* in *distributive Governing* Justice, for a *fault* or *crime*. The measure of the former satisfaction, is so much as may compensate the owners loss; not only so much as the thing was worth to another, but what it was worth to him: But the measure of the *later* satisfaction is, so much as the *ends of Government* instead of actual obedience; or so much as will suffice as to the *Ends of Government*, to repair the hurts which crime hath done, or avoid what it would do.

And here you may see the answer to that question: Why a Thief was commanded to restore fourfold by the Law of Moses? For in that restitution there was a conjunction of both sorts of satisfaction, both in point of Commutative and Distributive Justice: So much as repaired the owners loss was satisfaction to the owner for the injury. The rest was all satisfaction to God and the Common-wealth for the public injury that came by the crime or violation of the Law. Other answers were given by some, but this is the plain and certain truth.⁶⁴¹

A major and most influential figure of the enlightenment was Hugo Grotius (1583–1645). He accepted basically the Aristotelian dichotomy of distributive and corrective justice, translating them, as mentioned, with the

Latin terms of *iustitia attributrix* and *iustitia expletrix*.⁶⁴² He introduced into the distinction two new terms: *aptitudo* and *facultas*. The latter term designates a legal right in the strict sense, like: personal freedom, paternal authority, ownership, and obligation. The former concept, aptitude, constitutes the potential of obtaining a right; in the framework of distributive justice it is the Aristotelian *axia*, the merit (called in Latin *dignitas*) serving as criterion for the proportional distribution. The *facultas* is the object of the corrective justice, since the latter is aimed at restoring rights to their owners. Distributive justice, by considering the *aptitudo* of a person, is the companion of those virtues that benefit the other members of society, such as generosity, compassion, and guiding care.⁶⁴³

However, Grotius is critical of Aristotle's mathematical analogies. He claims that, contrary to Aristotle's assumption, corrective justice is not always a two-term arithmetic proportion, and distributive justice is not exclusively a four-term geometric proportion. Thus, the social contract is implemented by a geometric proportion; on the other hand, where only one person is found to be apt for a public office, the distribution will be based merely on an arithmetic proportion. Hence, the difference between the two forms of justice is not to be found in the use of different kinds of proportions but in the nature of the objects to which they respectively relate.

Grotius then proceeds to refute the opinion of those who claim that distributive justice concerns the common goods of society and corrective justice those of the private individuals. Grotius argues that granting a legacy out of private property constitutes a matter of distributive justice. On the other hand, when a state restitutes to citizens, out of the common property, the expenses made by them in the public service, then it fulfills merely a duty of corrective justice. ⁶⁴⁶

Grotius dedicates a special section to the classificatory problem of punishment.⁶⁴⁷ Here are his comments:

(1) But opinions differ as to whether punishment falls within the sphere of attributive or of expletive justice. For, on the ground that he who has committed the greater sin is punished more heavily, and he who has committed the lesser is punished more lightly and that the penalty is given as it were by the whole to the part, punishments are assigned by some to the sphere of attributive justice.

However, this first principle which they lay down, that attributive justice comes into play whenever an equality is established between more than two terms, we have shown to be untrue at the beginning of this work; then, as regards the fact that those who have done greater injury are punished more severely, and those who have done less injury are punished more lightly, that happens only as a consequence, not because it is aimed at first and for its own sake. For first and its own sake a balance is aimed at between the guilt and the penalty...

(2) Neither is the second principle which they lay down more true, that all punishments come from the whole to the part; this will appear from what we have to say. We have, in fact, shown above that the true nature of attributive justice properly consists neither in such balance nor in the transference from the whole to a part, but in taking account of the aptitude, which does not contain in itself right strictly so called, but furnishes an opportunity for it. Although, to be sure, he who is punished ought to be fit or worthy to be punished, this does not mean that something should befall him which attributive justice demands.

Nor yet do those give a better explanation who claim that expletive justice, which they commonly call commutative, is exercised in punishments. For in so doing they consider this a business transaction, as if something were paid to the wrongdoer, in accordance with the usage of contracts. They are deceived by current speech, whereby we say that punishment is due to him who sins. This is plainly "misleading." For he to whom something is properly owed has a right against another. But when we say that punishment is due to some person we mean nothing more than that is proper for him to be punished.

- (3) Nevertheless, it is true that expletive justice is exercised in penalties primarily and for its own sake, because he who punishes, that he may punish rightly, must have the right to punish; and this right arises from the crime of the guilty. In this matter, therefore, there is something that approaches the nature of contracts. For just as he who sells, even if he says nothing specifically, is considered to have obligated himself to all the things which are naturally involved in a sale, so he who does wrong seems by his own will to have obligated himself to a penalty, because a serious crime cannot be unpunishable; hence whoever directly wills to sin, by consequence has willed to deserve a punishment. In this sense the Emperors say to a person, "You yourself have subjected yourself to this punishment," and those who take evil counsel are already punished at that time, that is they are said of their own will to have contracted for the recompense of punishment. In Tacitus a woman who had married a slave is said to have agreed to subject herself to slavery, because that penalty had been ordained for such persons.

Grotius's comments on Aristotle provoked a considerable controversy by later authors. But before examining the scholarly reactions to Grotius's approach to the Aristotelian distinction, a look at Thomas Hobbes's (1588–1679)

treatment of it is appropriate. Dealing with the secondary laws of nature, Hobbes first distinguishes between "justice of manners" (which is conceived by him as the expression of a man's general character: justice as virtue) and "justice of actions" which denominates men guiltless or guilty in relation to a concrete act.⁶⁴⁹ Hobbes then goes on to say:

Justice of actions is by writers divided into commutative and distribu*tive*; and the former they say consisteth in proportion arithmetical, the latter in proportion geometrical. Commutative, therefore, they place in the equality of value of the things contracted for, and distributive in the distribution of equal benefit, to men of equal merit. As if it were injustice to sell dearer than we buy, or to give more to a man than he merits. The value of all things contracted for is measured by the appetite of the contractors, and therefore the just value is that which they be contented to give. And merit (besides that which is by covenant, where the performance on one part meriteth the performance of the other part, and falls under justice commutative, not distributive) is not due by justice, but is rewarded of grace only. And therefore this distinction, in the sense wherein it useth to be expounded, is not right. To speak properly, commutative justice is the justice of a contractor; that is, a performance of covenant in buying and selling; hiring and letting to hire; lending and borrowing; exchanging, bartering, and other acts of contract.

And distributive justice, the justice of an arbitrator—that is to say, the act of defining what is just. Wherein, being trusted by them that make him arbitrator, if he perform his trust, he is said to distribute to every man his own; and this is indeed just distribution, and may be called, though improperly, distributive justice; but more properly equity; which is also a law of nature, as shall be shown in due place.⁶⁵⁰

Hobbes then explains that latter comment under the heading of the eleventh law of nature:

Also if a man be trusted to judge between man and man, it is a precept of the law of nature, that he deal equally between them. For without

that, the controversies of men cannot be determined but by war. He therefore that is partial in judgment doth what in him lies, do deter men from the use of judges, and arbitrators; and consequently, against the fundamental law of nature, is the cause of war. The observance of this law, from the equal distribution to each man, of that which in reason belongeth to him, is called EQUITY, and, as I have said before, distributive justice: the violation, acception of persons, $\pi \rho \sigma \sigma \sigma \lambda \eta \psi (\alpha.651)$

The impression one gets from Hobbes's opposition to the Aristotelian distinction is that he is wary of giving substance to the notion of distributive justice on the basis of supposedly natural rights that would contradict his own assumptions on the nature of these rights. ⁶⁵² In relation to commutative justice, Hobbes denies the existence of an *a priori* binding principle of just exchange: the only requirement of justice is the performance by the parties of their agreed undertakings. ⁶⁵³

As mentioned, some scholars were rather critical of Grotius's approach to the Aristotelian distinction. Thus, the German philosopher and jurist, Johannis a Felden (d. 1668), criticized Grotius for insisting on the dichotomy of two forms of justice (attributive and expletive justice), whereas Aristotle recognized in that author's opinion a third form, namely that of retributive justice (*antipeponthos*). In relation to punishment, the author blames Grotius for confusing two different meanings and functions of *poena*: deterrence and retribution 654

One of the more renowned critics of Grotius is Samuel Pufendorf (1632–1694), who in his work on the Natural Law and Law of Nations examines the Aristotelian notions of justice in the light of the conceptions of Hobbes and Grotius. 655

Pufendorf equally uses the distinction of Grotius between perfect and imperfect rights, but in a completely different way. As mentioned above, according to Grotius the "attributive" (distributive) justice is concerned with imperfect rights, the "expletive" (corrective) justice enforces perfect rights. In Pufendorf's view, imperfect rights are the object of what Aristotle called "universal justice," conceived by the latter as the exercise of complete virtue in relation to others; on the other hand, perfect rights are the object of particular justice. As a result, Pufendorf observes in relation to Grotius's view:

[H]is expletive justice does by no means exactly agree with commutative, nor his attributive with distributive; and that his division is not on the same basis as ours. For our division is taken primarily from the matter which is due, and from the origin of the obligation, but his from the manner and the degree to which something is owed. And so it is clear why the distribution of the profits in the contract of a society belongs, in his opinion, to expletive justice, in mine to distributive . . . As for the example of Grotius: "If only one person can be found who is fitted for a public position, the award will be made to him on the basis

of a simple proportion only," we must inquire further, whether he has a perfect or imperfect right to that position. If it is the latter, the case will be one for universal justice, if the former, we agree what he says about proportion, that usually, but not always, a geometrical proportion is employed in distributive justice. But we have not taken our distinction between the two kinds of justice from the use of a different proportion. And so also the assigning of legacies belongs not to distributive but to universal justice; and when a state pays from its treasury the amount that some citizens have expended for a public undertaking, this is an exercise of commutative and not distributive justice, because the reason for the obligation does not come from an agreement by which the state received the citizen into its fold, but from a special and very different contract.⁶⁵⁶

Discussing Aristotle's forms of particular justice, Pufendorf states that there are three different kinds: distributive (διανεμητική), corrective (διορθωτική), and retaliation (τὸ ἀντιπεπονθός). Concerning the involuntary transactions, "they are seen in crimes, where what is properly an involuntary transaction takes place, because, for example, in a case of robbery my property has passed to a thief against my will, and so an inequality has arisen, in that he has more than he should, and I have less. This is corrected by taking from him what he has in excess of his due, and giving it to me." In relation to the third kind of justice, retaliation, Pufendorf explains that it regulates the manner in which men exchange things among themselves, "whereby things which are different and unequal are compared and finally made equal, on laws of a geometrical proportion. For instance, when a horse and a pair of shoes are to be exchanged, it must first be decided how many pairs of shoes the horse is worth, and, if it is set at twelve, the "retaliation," τὸ ἀντιπεπονθός, would be observed if one took twelve pairs of shoes for one horse.

In Pufendorf's view, retaliation is different from punishment, since it is exclusively concerned with restitution. Indeed, Pufendorf considers punishment, vindictive justice, as a different form of particular justice. ⁶⁶⁰

Referring to Grotius's above-mentioned analysis of punishment, Pufendorf in a lengthy paragraph rejects the notion that punishment makes part of corrective justice. ⁶⁶¹

Rejecting also the idea that punishment makes part of distributive justice, he observes:

Distributive justice takes place whenever an equality is established between more than two terms, that is, so often as something must be

divided proportionally between more than one. For in the contract of a partnership the dividends are divided *pro rata* when there is more than one stockholder, and yet in this contract the dividends are owed in a very different way from that in the rewards or penalties are owed. For it is surely obvious that penalties are not owed because of a pact, nor does any man in subjecting himself to a state agree that punishment shall be laid upon him for crimes And so the imposition of penalties in no way squares with distributive justice as we described it above. In the next place, the fact that the more guilty are punished more severely, and the less guilty less severely, comes about only by consequence and by accident, not because that was intended primarily and for its own sake.⁶⁶²

In relation to corrective justice he remarks:

Grotius, Bk. II, ch. XX, § 2, writes that expletive justice, primarily and for its own sake, is observed in the infliction of punishments, and this for the reason, that, "in order for him who punishes to punish lawfully, he should have a right to punish, which right arises from another's crime." Yet here the ambiguity of the term "right" has led him astray, for to have a right to do something, and to have a right to receive something from another are two very different things. The former means that the power belongs to me to perform some act, in the exercise of which no one should hinder me; the latter means that I have such a right to have something from another that he is also under an obligation to give it to me. And yet when we speak of expletive justice, the word right is taken not in the former but in the latter sense, and this right lies in him who receives a thing, not in him who gives it.⁶⁶³

In relation to Grotius's assumption that the criminal, when committing a crime by his own will, has obligated himself to a penalty, the author comments:

Yet it is not proper to say on this account that any man has directly or immediately given his consent to his own punishment, or, better, has by his own agreement obligated himself to undergo that punishment.

For no man ever commits a crime without having the hope that by concealment or in some other way he will avoid the penalty.⁶⁶⁴

Pufendorf then goes on to explain that the obligation arising from a crime is that of repairing the damage, not to bear a penalty. He states:

And this obligation is properly based not on the fact that a man has agreed to a penalty, but because natural law, after the introduction of dominium in things, produced the necessity of making that restitution ... But the reason why the obligation to repair a damage is classed by [Aristotle] under an involuntary contract, is because, for example, in the case of a loan it rests upon the will of the creditor as to whether the debtor shall receive the money, while, for example, the fact that a thief is obligated to restore to me either the article which he took from me or its value, is due to the deed having been done without my consent, and his having laid upon himself that obligation without my consent... Therefore, upon the commission of a crime there lies in the injured person a right to demand reparation for the loss, and upon the injurer an obligation to repair it, and this is the concern of expletive justice. But in so far as a crime is a deviation from the law, there resides in the governors of states a power to require a fitting penalty, but no obligation in the offender to pay the penalty of his own accord; and on this score the exaction of penalties does not agree with expletive justice. 665

Pufendorf therefore concludes that punishments belong to neither species of justice, but fall under a branch peculiar to itself.⁶⁶⁶ He adds that although one might prefer to say that the imposition of penalties as well as the distribution of rewards, on which there has been no agreement in advance by a special pact, are parts of the prudence which is connected with the duty of ruling others, and so it is referred to universal justice.

A somewhat more positive echo to the distinction suggested by Grotius between attributive and expletive justice, one finds in the work of the Dutch

Remonstrant (Arminian) theologian Philippus van Limborch (1633–1712).⁶⁶⁷ The author concentrates on the notion of commutative justice and his analysis is of considerable interest. He observes that the exchange in a commercial transaction has not always to be of an identical nature. Thus, a doctor who cures a mortally sick person will not receive an identical performance. In many cases the exchange of identical goods is even economically useless. The idea of reciprocity is realized by means of determining the price of the exchanged good and by its payment in terms of money.⁶⁶⁸ In case of violation of contractual duty or the performance of delict, a quasi third kind of justice emerges, commonly called corrective justice. It concerns the restitution of the thing detracted from another person. However, sometimes attention is nevertheless paid to the status of a person, since that may influence the extent of the injury.

Thus, God recognized in His law that offences committed against parents, officials, widows, and orphans are more serious than against others. In these cases, the taking into account of a person's status is legitimate, since it is connected to the issue. ⁶⁶⁹ Retribution (*talio*) too does not always require a rigidly identical act. Sometimes exact reciprocity would induce an inequality to the highest degree. Thus, e.g., where a one-eyed person blinds the eye of another person, the reciprocal blinding of his eye would deprive him of his sight and so cause him a much heavier damage. ⁶⁷⁰ Moreover, persons differ in their health, as well as in relation to the economic utility of their respective limbs. Finally, an adulterer with another's wife cannot be punished by suffering an equal act to his own wife. The author then affirms that the *lex talionis* established in the Bible does not mean always a literal, rigorous reciprocity, but the injury's evaluation in money or an equivalent corporal punishment. This is, he remarks, also the view of the Jewish sages. ⁶⁷¹

At this point, the author refers to the alternative distinction between attributive and expletive justice, without, however, mentioning the name of

Grotius. In the author's view, this distinction coincides with the traditional Aristotelian notions.⁶⁷² The author then deals—relying on biblical sources—with the conditions for the legitimacy of prices and profits and with the problem of usury.⁶⁷³

A completely different critical voice one hears from a theologian and preacher, John Hartcliffe (1651–1712), Fellow of King's College at Cambridge, Canon of Windsor.⁶⁷⁴ Evidently, not a friend of legal scholarship, he blames Grotius (without naming him) and others for inventing new terms:

Now Justice taken in this Sense is twofold, either commutative or distributive or as some learned Men affect to call it, *Justitia expletrix* or assignatrix; here by the way, we may take notice of a vanity in many great Scholars, of innovating the ordinary and known names, under which things have passed; thus Mr. *Hobbes* hath been thought as the prodigy of the age, as very a *deviser*, as if he had found out Gunpowder, or Printing, only for dressing *common acknowledged things* in *new Phrases*, and then *trimming* them up for new *Discoveries*; so *Ramus* is notoriously Guilty of this fault . . . for as my Lord *Bacon* wisely observes, nothing hath more hindred the Growth of learning, than Peoples studying of *new Words*, and spending their time in *Chaptring, Modelling*, and *Marshalling of Sciences*. The learned Author of this new language of *Expletrix* and *Assignatrix*, instead of the old Dialect of *Commutative* and *Distributive* Justice, may take his share patiently in this reproof.⁶⁷⁵

The author after praising the wisdom of Justinian, who prohibited scholarly legal expositions—as distinguished from short summaries (*paratitla*)—deplored the "torrent of writers" in legal science:

It is not much more, than 400 years, since *Irnerius* and *Accursius* began to write; but there followed upon them such a Rabble of Scribblers, that our whole Libraries have been too little to hold them; so fertile

have their wits been, either by opening the paths of *Justice*, or in contriving *by ways* to *injustice*: if therefore you would hear more concerning *Justice*, I must recommend you to *Aristotle*, or to the Interpreters of the *Law*, if at least their multitude do not confound you.⁶⁷⁶

Among the critics of Grotius, one finds also the outstanding and influential Italian philosopher, historian and jurist, Giambattista Vico (1668–1744).⁶⁷⁷ The latter suggests another Latin translation of Aristotle's two forms of justice: *iustitia rectrix* for distributive justice and *iustitia equatrix* for commutative (corrective) justice.⁶⁷⁸ Vico defends the Aristotelian distinction between the geometric and arithmetic "measures" against Grotius's criticism.⁶⁷⁹ The commutative justice considers exclusively the inequality of things and not the inequality of persons, who are viewed to be equal. It concerns therefore the transactions. Distributive justice concerns the community of unequal persons and takes into account the merit, the dignity of the individual for distribution. Commutative justice is at the basis of restitution and prevails in every community of equals.⁶⁸⁰ Hence, two partners who invested different sums of money into the enterprise receive an arithmetic measure of the profit, and not, as Grotius thought,⁶⁸¹ a geometric measure, since the latter considers the

dignity of a person and not the money. Indeed, each partner takes an equal part of the profit according to simple arithmetic measure. The money is at the basis of the equality and not the personal dignity; each takes that measure of the profit that he would have received if he had been the only investor.⁶⁸²

On the other hand, contrary to Grotius's view, the father who, by dint of his prerogative, makes a legacy in his will by considering the merit (dignity) of a person makes use of distributive justice. 683 The family is like a little state, and the state like a big family. 684 Corrective justice is at the basis of all restitutionary claims; in these cases, we ask from the defendant nothing more than to restore the possession of our property. 685

Vico pays special attention to the problem of categorizing punishment. He says:

One should not think that considerations about punishments pertain to aequatorial [corrective] justice just because Aristotle in his Ethics, elegantly says punishment is justified by an "involuntary contract." The term is improper because it implies that some things deserve, require, or are owed punishment, as if on the one hand, where the punishment is not meted out, someone will be owed something else, or on the other hand, if someone does suffer punishment, the offended party somehow recovers something of which they have been deprived by the crime. But when we say something "deserves punishment" it is not simply on behalf of the injured party it is deserved, but more generally it is deserved for the sake of civil society. For civil power is able to impose such punishments justly, as the laws require, because the defendant had consented to the laws on which the civil society is founded and against which the supposed crime has been committed. Rectorial [distributive] justice obtains in public affairs; aequatorial [corrective] justice in private affairs. 686

In a final paragraph,⁶⁸⁷ Vico notes that the distinction between distributive and corrective justice is valid in theory, but in the practice of life they are not separated. Thus, if the citizens deal among themselves on the basis of equal rights, this is so because the government obliges them to do it; and if the civil authority governs its subjects, this is so because the latter have consented to that power by a common promise. "Finally, all people are obligated by the principle of equity [aequum bonum] because reason dictates its truth [verum], and reason dictates it because a certain sociability and equality has been established. Humans cannot grasp this equality any other way. Other than by recognizing that they are created by God according to the one principle of nature." 688

Vico then states that in distributive justice one finds corrective justice and vice versa. Where distributive justice reigns, there is frequently equality between the subjects; and where equality is lacking, distributive justice is equally wanting. Thus, where there are many equals, they regularly follow distributive justice, and where there are many superiors, they regularly apply corrective justice among themselves. For that reason the persons who were above the law understood that between all of them a certain affinity had been established; hence, a law of nature governed them according to equity; and, therefore, the monarchs, when waging war on one another, recognized each other as *hostes* (enemies), that means as *equals*.⁶⁸⁹

It seems, however, that those scholars, whose main interest lay in Roman law, were not overly concerned with the Aristotelian distinction. They presumed that Aristotele's notion of justice does not contradict the traditional Roman definition by Ulpian: *Justitia est constans ac perpetua voluntas jus suum cuique tribuendi.* ⁶⁹⁰ A good example is the commentary on the Pandects

by the jurist Johann Brunnemann (1608–1672), professor at the University of Frankfort on the Oder. ⁶⁹¹ The author merely repeats the traditional criteria of the distinction, observing that distributive justice relates not only to rewards but also to punishment; then he adds that, nevertheless, sometimes the arithmetic proportion is applied in punishment—like in case of homicide—and sometimes the geometric proportion obtains in contracts, such as in case of corporation. ⁶⁹² Similarly, the Dutch jurist Paulus Voet (1619–1667), after shortly mentioning the basic traditional criteria of the Aristotelian distinction, observes that under their own (Roman) law, even in some commutative justice situations, the condition, quality and dignity of persons are taken into account. ⁶⁹³ Thus, in specific cases, the opinion of the most dignified creditors is accepted by the Praetor. ⁶⁹⁴

Johannes Voet (1647–1713), the son of the former, adds in his commentary on the Pandects⁶⁹⁵ a number of additional cases where, under Roman law, the dignity or quality of persons, are taken into account in commutative justice

situations.⁶⁹⁶ In relation to distributive justice—which has to do with rewards and penalties—the author notes that often, though not always, respect is paid to persons and that thus the geometrical proportion is preserved.

However, "penalties and rewards which looked at in themselves are unequal, will yet, because they are applied to persons differing in age, origin, dignity, sex, be equal, in so far as a penalty lighter in itself weighs no less heavily on a man of more honourable degree than one which, though appearing heavier when looked at in itself, weighs on a man of more humble degree." The author then adds that it is generally known that fines of definite amount are fixed generally by law for all persons of whatever sex, dignity, or position. This was common with the Romans and is also not foreign to the usage of the present day. In a separate section, 698 the author refers to the mentioned Grotian distinction between expletive and attributive justice, noting that there is no great difference between that distinction and the Aristotelian one. In his view, Grotius's division is aimed at distinguishing between legally sanctioned rights and duties, and merely moral ones that are based on equity and natural reason.

The contemporary Dutch jurist, Gerard Noodt (1647–1725), after shortly describing the Aristotelian distinction, equally remarks that, under their law, the criteria of the distinction do not always prevail. ⁶⁹⁹ Thus, in commutative justice situation, the (Roman) law may grant privileges to orphans, minors, women, and soldiers, privileges that are denied from other people. Likewise, the action in fraud is not given to children or servants against their parents or masters. ⁷⁰⁰ Moreover, there are examples where under distributive justice an arithmetic proportion is observed and, conversely, a geometric proportion under commutative justice. Thus, in relation to delicts, that according to Aristotle are subject, like contracts, to an arithmetic proportion, the Roman jurists measure the punishment according to a geometric proportion: the more distinguished persons get a lighter punishment, the less worthy a heavier one. Finally, the delicts are measured according to the person of the

wrongdoer and that of the victim. Sometimes, the more distinguished persons are punished more than the others, as in the case of an embezzlement committed by an official during his public office. He is punishable by death; others will get a lighter punishment.⁷⁰¹

Finally, the German jurist, Johann Gottlieb Heineccius (1681–1741), who taught also in Holland, adopted fully the ideas of Grotius: The rights and duties under *iustitia expletrix* are fully binding and can be enforced; those under *iustitia attributrix* are rather based upon good will and, therefore, do not admit coercion. The Aristotelian distinction between commutative and distributive justice is in most cases based upon the arithmetic and geometric proportion, but not always.⁷⁰²

As a matter of fact, the topic of justice was treated during the sixteenth, seventeenth, and eighteenth centuries in numerous academic dissertations, often in a very cursory form, and generally the reference to Aristotle's distinction was rather succinct, lacking original ideas. It usually came after Ulpian's famous definition as mentioned in Justinan's *Digesta*. 703 Nevertheless,

Moreover, they represent the rather high standard of discussion prevailing at a number of academic institutions in that post-scholastic, humanistic period.

A good example constitutes the academic disputation on the subject of distributive justice held at the University of Wittenberg in 1653.⁷⁰⁴ After relying on the analysis of Melanchton in relation to the Aristotelian distinction, the author rejects Buridan's view⁷⁰⁵ by affirming that the distinction

designates a real difference in kind. They differ in their form of proportion (arithmetic, geometric), in their object (private property, public honors), in relation to the persons (private, public). The author then refers to the etymology of the word "distribuere" connecting it to "tribus" (tribe), "tributum," "tribunus," and "tributio." The just distribution has to take into account the dignity of the individual. This is vital for the preservation of the state. To 8

There are a number of conditions for the proper application of the geometric proportion. First, the person administering it must be of reasonable age, of a public status and endowed with moral and intellectual virtue. Experience shows that those who lack virtue, hate virtuous persons out of jealousy, or malice, or any other reason. Second, the persons who are to benefit from the distribution have to be distinguished according to their merits. If all are treated alike, a great confusion will be created in the human life. Two examples from classical literature illustrate that point: first, Achilles' refusal to engage—in favor of the Greeks under Agamemnon's rule—into the dangers of war and battle, since with Agamemmnon the bravest and the most cowardly receive equal honor 709; second, the complaint of the Theban Philosopher Crates about the disregard of the respective dignity and merit in the distribution of rewards and salaries to professionals (cook, physician, flatterer, philosopher).⁷¹⁰ Finally, the object of distribution influences the criterion of distribution. Thus, when public money is distributed, the poor should receive more. In case of honors and dignities, the erudites and virtuous should be preferred; in case of charges and contributions, the wealthy should bear more than the poor, since they have more property.711

Another typical example costitutes a dissertation of 1670 at the same University and on the same topic of distributive justice. After analyzing the notion and application of distributive justice, the author deals at length with the classification of punishment. After presenting the arguments for the various contrasting views, he enters into a detailed defense of the opinion that considers punishment to be part of commutative justice. The fact that a variety of positive laws take into account the status of offender and victim does not detract from the basic classification. One has to distinguish between the assessment of the offense's gravity and the very infliction of the punishment: in relation to the former a geometric proportion may be admitted, but in the latter a purely arithmetic proportion must be applied. In his arguments, the author relies on scholastic and post-scholastic sources.

Another interesting example of an academic dissertation is the one publicly defended in 1667 at the Catholic University of Salzburg for the obtention of a degree in theology. The author, after dealing at considerable length with the notion of "legal justice," enumerates five differences between distributive and commutative justice. In distributive justice, the community, or its representative, deals with a private person; in commutative justice, private persons, or those who conduct themselves like private persons, deal with another private person. The former orders distributions, the latter transactions. Contrary to distributive justice, the basis of commutative justice is a property right or a quasi property right. Commutative justice, as such, regards an arithmetic proportion, which constitutes an exact equality between exchanged things; distributive justice considers a geometric proportion that constitutes a proportional equality between things to be distributed and the condition of the recipient persons. Addity of restitution

arises from the violation of commutative justice, but not from the violation of distributive justice as such. However, in some situations the distributive justice includes commutative justice; as a result, in case of an unjust distribution, a duty of restitution arises. This is the case where the distributor of public benefits is bound by a contract to act in accordance with a geometric proportion. He will be liable to pay compensation for the damage caused to the community by the bestowal of benefits or offices to the unworthy. The same is true where a person is charged to distribute money according to some proportional criteria.

A violation of the criteria constitutes a violation of both distributive and commutative justice. The recipients have acquired a strict right to the benefit and the distributor is, in addition, under a commutative-justice duty toward the donator. But, in some distributive-justice situations, there is no commutative-justice-right involved. This is the case where a public office has to be granted to the most worthy person. Here, distributive justice does not include commutative justice. Thus, the election to the office of a less worthy person does not give the worthier one a right of restitution. Yet Vindictive justice constitutes in respect of the judge's position and function an act of commutative justice. He is charged by contract to care for the common good, as well as to protect the citizens from crimes. A neglect of his task will oblige him to pay compensation for the damage. However, the very task of imposing punishment in proportion of the delict may be considered as an act of distributive justice, since it is executed in the name of the community.

Finally, it has to be admitted that the motive of imposing punishment in order to safeguard the common good according to the law makes part of legal justice (*justitia legalis*), but its actual execution belongs to distributive justice.⁷¹⁸

An additional example of a high-standard academic dissertation is the one publicly defended in 1672 at the Catholic University of Ingolstadt.⁷¹⁹ Referring to a great number of scholastic sources, the author concludes that distributive justice is not based upon a strict right. He shows that in cases where a strict right is recognized, it is grounded upon a specific contractual commutative-justice-right.⁷²⁰ He distinguishes between the distribution of common goods that is primarily in the interest of the recipients, and the conferral of public functions, that lies in the interest of the state. In the former case, the recipients have a right of restitution against the wrongful administrator; in the latter case, the right of compensation is primarily given to the state, except if the candidates have acquired a strict right under a contract.721 In relation to vindictive justice, the author admits that the judge by ordering, according to his public duty and function, the punishment for the delict or its compensation, executes an act of commutative justice. However, vindictive justice, seen as such, does not belong to any kind of real justice, since it is not concerned with rendering somebody his right.722

A thesis, submitted to the Catholic University of Innsbruck in 1705, starts with the assumption of four different kinds of justice: distributive, legal, commutative, and vindictive justice. 723 Among these, commutative justice is the strictest and most properly called justice. The author identifies commutative justice with the classical definition of Ulpian 724 and maintains its specific

nature in relation to the other kinds of justice and virtues. He defends that thesis—in a typical scholastic way—against a long series of objections.⁷²⁵

Firmly in the Thomist tradition is an additional noteworthy dissertation of 1715 submitted in Augsburg. The author concludes—on the basis of the traditional arguments—that the difference in the proportion is an insufficient criterion for the distinction between commutative and distributive justice. There is a difference in the underlying legal duty: distributive justice is based not upon a strict right of property—like commutative justice—but upon a legal right grounded in the adequacy of merit (condignitas). The duty of restitution derives from a contractual commutative justice obligation. Vindictive justice is not a different kind of justice. If exercised by a judge for the common good, it makes part of commutative justice, that on its part has been ordered by the higher legal justice. If vindictive justice's purpose is merely the good of the individual, then it is solely based upon a contractual commutative justice.

In connection with the reliance on the Roman law tradition, mention must be made of Gottfried Wilhelm Leibniz (1646–1716), the great jurist, philosopher, mathematician, scientist, and diplomat. His general definition of justice is "caritas sapientis," the "charity of the wise man." Nevertheless, he uses in his writings Aristotle's division between universal and particular justice. The resulting three notions of justice—namely, universal, distributive, and commutative justice—he identifies with the general precepts of the

Roman legal tradition⁷³¹: *honeste vivere, suum cuique tribuere* and *neminem laedere*. In Leibniz's words:

And while justice is only a particular virtue, when one leaves out of consideration God or a government which imitates that of God; and while this limited virtue comprises only what are called commutative and distributive justice; one can also say that as soon as it is founded on God or on the imitation of God, it becomes universal justice, and contains all the virtues... And universal justice is stamped with the supreme precept *honeste* (*hoc est probe, pie*) *vivere*, just as *suum cuique tribuere* was in conformity to particular justice, whether in general or (taking it more narrowly) as distributive justice (which distinguishes men); and as *neminem laedere* stood for commutative justice, or for the *ius strictum* as opposed to equity, according as one takes the terms [in different ways].⁷³²

It is likely that Leibniz's notion of strict right as commutative justice has been influenced by the scholastic literature.⁷³³ In an earlier work, Leibniz referred—when dealing with the Aristotelian forms of justice—to the abovementioned specific terminology of Hugo Grotius⁷³⁴:

The precept of bare Right or Right *in the narrow sense* [jus strictum] is that *no one is to be injured*, lest if it be within the state, the person should have ground for an action in law, or if it be without the state, he should have the right to make war. From this there comes the justice which the philosophers call *commutative* and the right which Grotius calls *right proper* [facultas]. The higher degree I shall call

equity, or if you prefer it charity (that is, in the narrower sense), which I extend beyond the rigour of bare Right to those obligations also on account of which those to whom we are obliged have no ground to compel us to perform them, such as gratitude, pity, and the things which are said by Grotius to have *imperfect right* [or *fitness, aptitude*] not right proper [facultas]. And as to the precept of the lowest degree was to do injury to no one, so that of the middle degree is to do good to everybody; but that so far as befits each person or so far as each deserves, since we cannot be riend all men. Therefore to this place belong *distributive* justice and that precept of Right [jus] which bids us give to each his own. And to this political laws in the state are related, laws which have to do with the happiness of subjects and which usually bring it about that those who had only moral claim [aptitudo] acquire a jural claim [facultas], that is to say, that they are enabled to demand what is fair that others should give. But while in the lowest degree of Right no regard was paid to the differences among men (except to those which arise from the particular matter in hand), and all men were regarded as equal, now in his higher degree merits are weighed, and hence privileges, rewards, and punishment appear. 735

It has been noted by a number of scholars that Leibniz's identification of commutative justice with the legal precept of *neminem laedere* deviates from

Aristotle's original conception of the forms of justice. As one scholar puts it: "Leibniz's theory of justice, then is a complex amalgam of Christian charity, a metaphysic of Platonic perfection, Roman law, and transmogrified Aristotelian terminology; its relation to his pure philosophy is, to say the least, problematical, but taken in itself it has integrity and force." 737

Among the legal scholars of the seventeenth and eighteenth centuries, we find a strong tendency to criticize Aristotle's distinctions, sometimes with ironical undertones directed against those jurists who spent time and intellectual efforts to elaborate these distinctions. An influential voice is Christian Thomasius (1655–1728), professor of law at the University of Halle. He argues in relation to Ulpian's definition of justice that the attempt to explain it on the basis of Aristotle's writings is even more awry than the attempt to explain the books of Protestant theologians on the basis of the writings of the Popes. 738

The weekly dissertations held in the summer of 1750 at the University of Göttingen under the direction of Johannes Andreas Hannesen (d. 1751),⁷³⁹ are another good example of this kind of criticism. The authors note that at a time when the Roman law penetrated Germany, the jurists' mind were

occupied with the philosophical question of justice under the influence of Aristotle: "Nobody would commit the fragile boat into the very vast sea of jurisprudence without Aristotle sitting as steersman at the rudder." All, teachers and disciples, were infected by this philosophical disease. The distinction between universal and particular justice is inadequate. After shortly describing the traditional criteria of the distinction between commutative and distributive justice, the authors state that these distinctions are useless and contribute little to clarity. The proposition that in distributive justice a geometric proportion is observed reveals itself, by a close inspection, to be completely false. Thus, where a war leader promises a certain reward to the soldier who will first climb up a valley or wall, no attention will, indeed, be paid to the status of the soldier; putting first his foot upon the bulwark, he may be a common soldier, a corporal, an ensign or a captain.

The proposition that in commutative justice situations there is always an application of an arithmetic proportion is, in the authors' view, equally false. One example of the falsity constitutes the plurality of unsecured creditors who often are, in case of insolvency, paid according to a geometric proportion. The appears that in the authors' view, any further analysis of the distinction is a waste of time and of intellectual energy.

On the other hand, the authors agree with Grotius's distinction between *iustitia expletrix* and *iustitia attributrix*, as an expression of the difference between a perfect legal right and an imperfect one.⁷⁴⁵ The former creates a legally enforceable obligation, the latter a merely moral duty.⁷⁴⁶

Finally, the authors refer to the problem of classifying punishment. Again, their discussion has a clear ironical dimension. After mentioning the differences

of opinion between scholars—one part defining it as distributive justice,⁷⁴⁷ another as commutative justice⁷⁴⁸—they claim that neither of the two forms is appropriate. Commutative justice is inapplicable, since in a series of legal provisions in Roman law, the social status of the offender is taken into account.⁷⁴⁹ Moreover, one can ask what is exchanged in meting out punishment. "Perhaps, you would say, the wicked life before the deeds, the mutilation of limbs, the bad reputation, the diminished property is exchanged against the punishment; but, in the same line, I would affirm that when a good life before the acts, a undiminished property, a good reputation and the limbs' integrity are exchanged against rewards and honors, then they pertain to distributive justice."⁷⁵⁰

Distributive justice is inadequate for punishment, since it presupposes a community. However, punishments are not held in common: the criminal alone is fully liable. Some are of the opinion that punishment constitutes a third kind of justice, *iustitia vindicativa* or *vindicatrix*. There is no need for that additional distinction; it suffices that punishments should conform to the delicts and be established for the welfare of the state. Since the awkward Aristotelian distinctions are of no use, the controversies among the scholars relating to the classification of punishment are idle.⁷⁵¹

The German Pandectists of the nineteenth century, too, were not specifically interested in the scholastic discussions of the Aristotelian notions of justice. Thus, e.g., Anton Friedrich Justus Thibaut (1772–1840), in his famous *System des Pandekten-Rechts*—after mentioning Grotius's distinction between *iustitia attributrix* and *iustitia expletrix*⁷⁵²—simply adds that, for the history of science, the scholastic division between commutative and distributive is noteworthy.⁷⁵³ Some Pandectist scholars used even a most disparaging language

in relation to these classical notions of justice, claiming that their analysis was a waste of time, misleading, and a contraband of prohibited goods.⁷⁵⁴

In relation to punishment, the question remains what was Aristotle's exact understanding of its function, and why has he not more exhaustively expounded its nature in relation to the forms of justice. An interesting suggestion has been made by the nineteenth-century German scholar Karl Hildenbrand. According to his opinion, Aristotle views punishment basically as a means of education. When stating that virtue has to do with pleasure and pain, Aristotle adds:

This is further indicated by the fact that that punishment is inflicted by means of pain. For punishment is a kind of medical treatment to take effect through the introduction of the opposite of the disease.⁷⁵⁶

Aristotle returns to the idea of punishment as an educational means to achieve and maintain virtue at the end of the *Ethics*:

But it is perhaps not enough that they receive the right upbringing and attention only in their youth. Since they must carry on these pursuits and cultivate them by habit when they have grown up, we probably need laws for this, too, and for the whole of life in general. For most people are swayed rather by compulsion than argument, and by

punishment rather by (a sense of) what is noble. This is why some believe that lawgivers ought to exhort and try to influence people toward (a life of) virtue because of its inherent nobility, in the hope that those who have made good progress through their habits will listen to them. Chastisements and penalties, they think, should be imposed upon those who do not obey and are of inferior nature, while the incorrigible ought to be banished abroad.⁷⁵⁷

It follows that Aristotle conceives punishment, apparently in the wake of Plato, as a means to education, having thus rather the utilitarian function of deterrence and rehabilitation (healing).⁷⁵⁸ This rationale seems to distance punishment from the idea of justice as interpersonal equality.⁷⁵⁹

The idea of geometric proportion has been criticized by modern authors on the ground that even if in the abstract it sounds good, in practice it is in many cases impossible to quantify by numbers the difference of persons' merits. Thus, even if one knows that one person is more virtuous than another, how can this difference be expressed in exact numbers?⁷⁶⁰

A general observation on the development of the distinction between distributive and corrective justice: Aristotle's emphasis was on the virtue of justice, which means the doing of justice. Hence, his major interest concentrated on the nature of the just act and correspondingly that of the unjust one. He found it in the notions of equivalence and proportion in their arithmetic and geometric sense. Aristotle was not concerned with the legal dimension of justice, namely, justice as an institution conferring legal rights and imposing correlative legal duties. It is true that he mentions the judicial function of restoring the equivalence in relation to the arithmetic proportion. But he did

it in order to illustrate the functioning of corrective justice in restoring the arithmetic equivalence.

However, in the scholastic literature, the issue of the nature of the legal right under the different forms of justice became predominant. The traditional approach tended to define distributive justice—the function of which was to distribute goods belonging to the collectivity—as a nonperfect right of the recipient and a nonperfect duty of the distributor. Distribution of common goods was conceived to be the privilege of the prince, the ruler, who was not subject to any legal enforcement. This approach was criticized by some authors as going beyond the Aristotelian distinction. Later it was argued that the traditional approach was based upon the idea of sovereign immunity, an idea that was no more valid.

The Modern Use of Aristotle's Forms of Justice

THE TRANSITION TO MODERNITY is again evidently a very gradual process that cannot be reduced to a specific moment in history. Being aware of its inevitable arbitrary character, we assume that for our specific purposes, the modern trends start with the eighteenth century. However, the criterion for modernity is not to been seen exclusively in the specific period of time, but rather in the change of certain ideas. Thus we can still see, in this assumedly modern period, (late) scholastic works—especially by Catholic authors—that do not substantially differ from those of their predecessors in earlier times.^{762a}

Generally, the modern tendency appears to distance itself from the notion of justice as a moral virtue in the Aristotelian sense; it inclines to relate justice to law as a public institution.

Another phenomenon that can be conceived as a sign of modernity is the linkage of the Aristotelian forms of justice to the distinction between public and private law. The idea itself that commutative justice relates to private acts, distributive justice to public ones, was already explicitly expressed by Aristotle. It was later applied in practice by scholastic authors, who used the Aristotelian distinction as a means for the basic classification of legal fields that ran somewhat parallel to that of public and private law. Thus, e.g., the Jesuit Thomas Sanchez of Cordoba (1550–1610), in his book on Justice and Law, groups under commutative justice the matters of property rights, damage and injuries, promises and gifts, sales and leases, games and bets; under distributive justice: acception of persons, 763

bestowal of benefices (*de beneficiis*), simonia, taxes, and fees (*de tributis et vectigalibus*).⁷⁶⁴

However, a close analysis of the exact relationship between the two sets of concepts was apparently made first by Donatus Hoffman (1703–1783), rector at Kempten, professor of philosophy and theology. He states that distributive and commutative justice can be relevant in both public and private law. Thus, the state may engage into buying and selling like private persons; correspondingly, the head of a family may distribute among its members rewards and charges. Hence, it is appropriate to distinguish between *public* distributive and commutative justice. He can decreeing war or peace by treaties, enacting laws, assessing prices of things, requiring taxes, establishing punishments for crimes, etc.—exercises *public commutative* justice; he exercises *private commutative* justice in contracts made for the sake of his own benefit. *Public distributive* justice relates to the institution of officials, the establishment of their prerogatives functions and charges, etc.; *private distributive* justice consists in the distribution of honors and duties to the servants of his court.

Conversely, any private citizen exercises *public commutative* justice when abiding by the just laws, by the treaties of commerce, of war and of peace,

and when paying the taxes, etc. He exercises *private commutative* justice when contracting freely with citizens or equitably with the very community itself. He exercises *public distributive* justice when showing more reverence, compliance, and obedience to higher officials than to lower ones; *private distributive* justice is exercised when caring more for the spouse than for the children, more for the children than for the servants, and so forth.

In view of his new classification, the author denies the necessity of the separate category of "legal" or "general" justice. Moreover, the *iustitia vindicativa* can be classified partly as public commutative justice and partly as public distributive justice.

The author then states that in many cases it may happen, especially in the public context, that both commutative and distributive justice are violated. Whereas the violation of distributive justice may not require the reparation of the injury—because the violation did not affect a vested right (*ius quaesitum*), but merely one to be acquired (*ius querendum*)—reparation may nevertheless be required, because the same act may have violated commutative justice, by affecting adversely the vested right of another person. Thus, e.g., the prince, while distributing honors, prefers unworthy persons over worthy ones. He sins against distributive justice by violating the nonvested rights of the worthy persons, but he, nevertheless, is not held to repair the inflicted injury. However, the unworthy administrators may cause various damages to the state that has a vested right to its integrity. Hence, *public commutative justice* has been violated, and the prince is, without doubt, liable to repair the damages.

The same is true when the prince, without any reason, grants remission to one among a plurality of death convicts. He sins against distributive justice in relation to those who do not get pardon, but toward them he cannot be obliged to anything. However, with respect to the state, whose interest it is that offences should be punished, he doubtlessly sinned against *public commutative justice*, and he will be held to repair the damages caused by that pardon.⁷⁶⁷

In more recent times, some authors simply identify commutative justice with private law, distributive justice with public law.⁷⁶⁸

A completely different meaning and use of Aristotle's notions of justice is suggested by Immanuel Kant (1724–1804) in his Rechtslehre. 769 His starting point is a sharp distinction between moral duties (officia virtutis s. ethica) and legal duties (officia iuris).770 Justice is, therefore, not a personal virtue but a public institution. Kant's analysis of the forms of justice is very complex, since he connects them to his general philosophical premises relating to cognition.⁷⁷¹ Besides the concepts of commutative and distributive justice, he introduces a third form: the protective justice (*iustitia tutatrix*).⁷⁷² These three forms correspond to the three Kantian categories of modality: possibility (Möglichkeit), reality (Wirklichkeit), and necessity (Notwendigkeit). 773 Whereas the notion of commutative justice is still, to some extent, based upon the Aristotelian meaning of transactional justice between private persons, Kant's notion of distributive justice is very remote, if not completely divorced, from the original meaning of distributing public honors and benefits. In Kant's understanding, distributive justice is the decision handed down by a state court in the private law conflict. Kant affirms that what might a priori appear to be right under private law (commutative justice), could be viewed differently

under distributive justice, as applied by the court, since the latter has to take into account the idea of public law.⁷⁷⁴

Kant illustrates this contrast between commutative and distributive justice by means of four examples: the binding force of a contract of donation; the allocation of risk in a contract of bailment (*commodatum*); the principle of market overt; the application of a decisive oath in judicial litigation.⁷⁷⁵ It is remarkable that in Kant's view, considerations of public law, such as the efficiency of the administration of justice, may change the substance of private law.⁷⁷⁶

An echo of the old scholastic discussion about divine justice, we find in Kant's Concluding Remark to his *Metaphysics of Morals*: Divinity has no duties, but only rights toward human creatures; correspondingly the latter have only duties and no rights toward God. Kant's conclusion is that ethics is limited to the moral relations between human beings. The idea that under divine justice human beings have a right to reward or to remuneration is a contradiction; they can only be based upon love and charity (*benignitas*). The idea of a divine punitive justice is equally problematic, since it must be based upon the unconceivable concept of an injury (*Läsion*) to Divinity. Moreover, divine punitive justice runs counter the intended end of the Creator in creating the human race, namely the happiness of mankind.

Kant's moral and legal philosophy exercised an enormous influence upon modern thinkers—including his specific notions of justice—creating a vast literature. An analysis in depth of the Kantian notions exceeds by far the limits of this study, as well as the capacities of the present author. 778

Aristotle's ethical works remained an object of great scholarly interest in the nineteenth and twentieth centuries. But in the spirit of the time, great intellectual efforts were invested into the philological, textual, and editorial problems of these philosophical writings according to the so-called methods of "higher" and "lower" criticism. A major objective was the correct understanding of Aristotle's original intentions. A good example of this tendency one finds in a dissertation on Aristotle's notion of justice published in Paris in 1902, rather surprisingly in Latin. The author, adhering strictly to the Greek text, critically analyses the various contemporary scholarly views. Thus, he sharply criticizes the widespread view classifying punishment under corrective justice. In the author's opinion, a correct analysis of the Aristotelian texts implies that punishment makes part of distributive justice. It explicitly takes into account the mental state of the perpetrator and thus the latter's ethical dignity.

In relation to Aristotle's discussion of *antipeponthos*, the author rejects the view of some scholars who consider it to be a third kind of justice. In his view, Aristotle opines that the *lex talionis*, in order to be just, has to be a combination of corrective and distributive justice. That is the way one has to understand also Aristotle's example of the transactional exchange, between an architect and a shoemaker, of a house and shoes. As a matter of fact, both forms of justice may be combined. The author then emphasizes the formal nature of these notions of justice.

However, another most remarkable phenomenon of contemporary legal scholarship, especially in tort law, is the renewed interest in the ancient

distinction between distributive and corrective justice. One pronounced tendency is to found tort liability on the premises of corrective justice. As it has been noted by one scholar:

There is no indication that an organized body of tort law existed in ancient Athens. Nevertheless, Aristotle's notion of corrective justice appears well suited to the law of torts, and many modern legal scholars, with scant knowledge of Aristotle, have casually borrowed the term and used it to talk about corrective justice of tort law. In fact, corrective justice has become a cottage industry for tort law theorists.⁷⁸⁵

It seems that the first important (modern) scholar to relate the substantive rules of delictual liability to the classical Aristotelian distinction between distributive and commutative justice has been the German Josef Esser. The latter published in 1941 a seminal and most influential work on strict liability (Gefährdungshaftung).786 The author deplores the exclusive application of the traditional fault principle in relation to the liability for damages. In his view, it was a mistake of the liberal ideology to base liability exclusively upon the (Kantian) ideas of freedom of will and equality. Since many damages were caused by nonfaulty activities, i.e., as a result of causes that could not be viewed as an abuse of freedom, the problem became one of allocation of accidental losses between innocent parties. The traditional fault approach could not offer a satisfactory solution to this problem. The idea that the victim had to bear himself all accidental losses, did not constitute a reasonable legal ordering, but was merely a manifestation of the impotency to chose between two "equally innocent people" according to justice. 787 Here, the author states:

Out of this apparently insoluble situation conducts us the recognition that the distribution of accidental losses, as well as that of goods, is *not* the task of "*commutative*," i.e., of retributive or reciprocal justice, but that of "*distributive*," i.e., of apportioning and allocating *justice*.

We are following here the fundamental insight of *Aristotle* into the existence of two independent functions (and criteria) of justice, of which the first is directed at the ordering of legal relations (of both the voluntary as well as the involuntary, delictual ones); the second being directed at the ordering of the allocation of goods (*Nicomachean Ethics*, Book 5, Chapter 5)⁷⁸⁸

It is noteworthy that Esser, in justifying the imposition of strict liability, relied on Otto Gierke's idea of the social function of private law. However, the latter considered the imposition of strict liability, on the basis of causation, to be a postulate of *corrective justice*: "Corrective justice requires, as far as expediency and equity allow, a shifting of the damaging consequences." Moreover, Gierke viewed the allocation of loss on the basis of causation to be founded—like fault—on a "moral principle," namely: that where a special risk for others was created through something which brought a special advantage to somebody, the latter should equally support the loss. We find here the first signs of the widespread and heated modern controversy about the correct understanding of the Aristotelian distinction in relation to the substantive rules of liability.

Esser himself emphasizes correctly the "empty" idea of distributive justice, because of its merely formal character. In its framework, all possible substantive solutions are conceivable, as far as they are conform to the historical social situation. The substantive solutions may lie between the poles of a collective assumption of damages and the individual bearing of success and misfortune. He considers the finding of the just solution to constitute a historical task. It may depend on society's measure of organization and the connected mental attitude toward the contrasting notions of "fate" and "rational planning."

It has been widely recognized that in view of the formal and, therefore, "empty" character of the Aristotelian notions of justice, the latter cannot yield by themselves substantively "just" solutions. Fin order to reach these solutions, one has to refer to independent moral values that are capable to supplement the formal notions of "merit" and "equality." In the words of the German scholar Helmut Coing, who undertook one of the many enterprises to elaborate these additional moral values: "The value 'justice' is in itself not completely unequivocal; it requires supplementation by means of other moral values that will grant the criterion of the just allocation. It points from itself to other criteria."

The Aristotelian distinction between the two forms of justice lay dormant for many decades in the legal discourse. This does not mean that jurists were not aware of the difference in their respective aims. Distributive considerations played an important role in the analysis of legal liability, as well as in other fields, but very rarely reference was made to the conceptual framework of the classical distinction.

An important exception in the U.S. legal literature constitutes the most famous article, published in 1936, of L.L. Fuller and W.R. Perdue, Jr. on the "Reliance Interest in Contract Damages." The authors make the following remark: "In passing from compensation for change of position to compensation for loss of expectancy we pass, to use Aristotle's terms again,

from the realm of corrective justice to that of distributive justice. The law no longer seeks merely to to heal a disturbed status quo, but to bring into being a new situation. It ceases to act defensively or restoratively, and assumes a more active role."⁷⁹⁸ However, this particular reference to the Aristotelian distinction seems to have escaped scholarly interest for a very long period of time.⁷⁹⁹ In U.S. case law, one finds one lonely reference to that passage.⁸⁰⁰

The whole situation changed dramatically in the early eighties of last century: A growing flow of scholarly papers started to appear U.S. law reviews—especially, but not exclusively, 801 in relation to tort law—all referring to the

Aristotelian distinction of corrective and distributive justice. Ro2 At the origin of this still continuing controversy are the papers of two scholars dealing with tort liability: George Fletcher and Richard Epstein. Ro4 Both used the notion of corrective justice in order to act counter the instrumentalist, economic approach that had won important scholarly support in the recent preceding years.

The start was made by Fletcher, who first observed that the journals cultivated the idiom of cost-spreading, risk-distribution, and cost-avoidance; hence, "discussed less and less are precisely those questions that make tort law a unique repository of intuitions of corrective justice," such as the rationale

for an individual's "right" to recover for his losses.⁸⁰⁶ And more explicitly, Fletcher remarked in relation to the economic argument of shifting losses to the individual who was in better position to distribute losses:

This is an argument of distributive rather than corrective justice, for it turns on the defendant's wealth and status, rather than his conduct. Using the tort system to redistribute negative wealth (accident losses) violates the premise of corrective justice, namely that liability should turn on what the defendant has done, rather than who he is. See the *Nicomachean Ethics of Aristotle*, Book V, ch. 4, etc. What is at stake is keeping the institution of taxation distinct from the institution of tort litigation."⁸⁰⁷

This specific use of the Aristotelian distinction marks an important and decisive change seen from a historical point of view. Contrary to the medieval and late scholastic endeavors, aimed at the correct understanding of the Aristotelian notions of justice and of their application in practice, we encounter here their employment for a critical analysis of substantive solutions. The argument voiced here is that the distributive aims of tort liability are inherently inconsistent with corrective justice and therefore illegitimate in relation to the parties involved. The truth is that objections against the economic-utilitarian approach in tort law—based upon the Aristotelian distinction—had been raised already in the late nineteenth century in

continental Europe. 808 However, these were less founded on arguments of an impermissible violation of the structural-conceptual coherence, than on the more functional reason that the two kind of justices could not be integrated (theoretically or practically) in one uniform principle of liability. In this context, it is noteworthy that Josef Esser did not see any inherent inconsistency in introducing distributive considerations into the domain of delictual liability. 809

Be that as it may, the substantive argument, based on the notion of corrective justice, which was raised against the instrumental-economic approach in tort law, gained prominence and provoked a protracted scholarly controversy. The result was a direct return to Aristotle's original text and its renewed analysis on the background of the actual debate. Apart from very few limited exceptions, ⁸¹⁰ the millennial treatment of the Aristotelian distinction was completely disregarded.

The intellectual effort was directed to different aspects of the two forms of justice, depending upon the respective scholar's basic conception concerning tort liability's foundation. 811

Those scholars who opposed the instrumental approach, being oriented toward economic efficiency, emphasized the postulate of corrective justice that required an exclusive concentration upon the concrete litigants on a basis of strict equality. This necessarily implied the disregard of the prior status of the parties, as well as of all possible objectives going beyond their personal interests. Seen from the perspective of the Aristotelian distinction, the critique assumed the dichotomous, i.e., the mutually exclusive, character of the two forms of justice. It meant that the very introduction of distributive considerations into the notion of liability constituted a violation of corrective justice and was, therefore, illegitimate.

Viewed from a historical perspective, the use of the distinction as a normative tool for examining the legitimacy of substantive solutions seems to be quite a novelty. As we have seen, the high scholastics, the late scholastics and the post-scholastics, all used the positive law as a criterion for the correctness of the distinction and not the other way around. It is interesting to note, that the challenge of tort liability's conformity to corrective justice was taken most seriously by many U.S. tort scholars. Hence, the great intellectual effort applied by many scholars to reconcile their suggested substantive solutions with the assumed requirements of corrective justice. Other scholars used the Aristotelian notions of justice in order to criticize legislative schemes of compensation. Finally, some scholars—relying on the formal character of the distinction—used it in an expository way, aimed at explaining in a coherent way the normative structure of a legal regime in a certain field. A precondition to this discourse was naturally the right understanding of the very notion of corrective justice and its relationship to the substance of law. Since we are not directly concerned here with the substantive legal solutions in tort (or in other fields of law), we will limit our discussion, as far as possible, to the specific use of the Aristotelian distinction. This is by no means an easy task in view of the fact that our conclusion about the formal character of the distinction has been contested by a number of modern scholars. The latter assume that the very notion of corrective justice implies substantive principles that determine the legal solution of the question of liability. This approach is in our view erroneous.

Corrective justice is formally concerned with restoring the antecedent equality between specific parties. But in order to establish the relevant notion of equality and the relevant initial position of the parties, extrinsic values will have to be invoked. More specifically, in tort cases, corrective justice relates to an involuntary transaction. The functional notion of corrective justice—undoing, by means of an award of damages, the wrong suffered by the plaintiff at the hands of the defendant—does not yield the criterion for the notion of wrong. 814 As it has rightly been stated, the notion of wrong embodying the principle of justice, as distinguished from the form of justice, has to be derived from a specific moral philosophy. 815

A significant, influential, profound, and comprehensive analysis of the Aristotelian forms of justice in the modern context has been made by

Ernest J. Weinrib. 816 This scholar's starting point remains the formal character of the Aristotelian notions of justice. However, the author affirms that despite its abstraction from particular prescriptions Aristotle's formalism is by no means empty: "Aristotle's attention to structure enables to appreciate both the internal coherence of the private law relationship and the categorical difference between private law and other legal orderings." The author adds: "Despite his achievement, however, Aristotle's exposition, like all pioneer efforts, is seriously incomplete. Aristotle presents corrective justice as a transactional equality, but he does not tell us what the equality is an equality of." 818

Weinrib's declared enterprise is to fill in this lacuna in Aristotle's account by connecting corrective justice to Kant's legal philosophy. As a result, the equality of corrective justice is the abstract equality of free purposive beings under the Kantian concept of right. The connection between corrective justice and Kantian right implies a number of important substantive consequences, such as the exclusion of strict liability based on risk or causation without fault. Weinrib's legal formalism, its concern with intelligibility of juridical relationships and with coherence, as well as his approach to tort liability and Kantianism, have provoked a considerable number of critical studies. However, we limit ourselves to his specific understanding of the Aristotelian forms of justice.

A major critique of the formalist conception of corrective justice has been undertaken by Richard W. Wright. 822 The author attempts to derive substantive conclusions directly from the two forms of justice, in order to rescue the Aristotelian concepts of justice from their "formalistic evisceration." 823

The author is well aware of the fact that the notion of distributive justice requires a determination of the relevant criterion of "merit," and, correspondingly, corrective justice a determination of the "unjust" loss or gain. However, in his view it is possible to derive substantive conclusions from Aristotle's general discussion of the relationship between justice and the good. As a result, "the Aristotelian concepts of corrective justice and distributive justice are not empty formalist shells. They have a powerful nonaggregative and egalitarian substantive ethical content."⁸²⁴

In our view, the author's reasoning is not convincing. No doubt Aristotle himself had very defined and clear notions about the contents of vice and virtue, of justice and injustice, of right and wrong. However, these (personal) ethical judgments have to be sharply distinguished from his conceptual insight into the structure of justice. Thus, when discussing distributive justice, Aristotle mentions the contrasting possibilities of defining the content of "merit," such as wealth in the political system of an oligarchy. Now, it is well known that in Aristotle's view, wealth was not a component of the "good," and oligarchy certainly not the ideal political system. One is, of course, free to accept Aristotle's ethical notions, but this can in no way detract from the purely formal character of the distinction between corrective and distributive justice.

Let us continue with one of the great protagonists of the economic approach to tort law, Richard Posner. The latter seems to agree that the Aristotelian distinction is of a purely formal character.⁸²⁸ His major argument

is that the Aristotelian concept of corrective justice is compatible with, and indeed required by, the economic theory of tort and, incidentally, contract and criminal law.⁸²⁹ He states:

To be sure, the Aristotelian judge is not to look "beyond the case at hand," but only in the sense that he is not to consider whether the defendant is a better man than the plaintiff, evaluated apart from the character of the injury; it does not follow that the social utility of the defendant's conduct is irrelevant to whether the injury was wrongful.⁸³⁰

Posner's conclusion is that corrective justice is an instrument for maximizing wealth, and that the concept of corrective justice in the *Nicomachean Ethics* is, and must be, a component of the economic theory of law. 831

A final comment: No doubt, the formalist approach clashes with a substantive understanding of both distributive and corrective justice. However, it has to be remembered that even from a strictly formalist conception, the difference in the formal structures implies some important consequences for the substance. Form and substance become linked through the idea of coherence.⁸³²

In view of the widespread controversy and fundamental dissent among contemporary scholars about the nature of the two notions of justice, it is by no means easy to sum up the modern use of the Aristotelian distinction. The rather surprising fact is that the notion of corrective justice has exercised upon scholars, especially in tort law, ⁸³³ a most suggestive power. As a result, a huge intellectual effort has been applied by a great number of scholars to reconcile their substantive views on tort liability with the notion of

corrective justice. 834 One could ask: What is fundamentally wrong with a liability based upon distributive considerations? Why the attempt to squeeze all suggested concrete solutions into the notion of corrective justice? In this context, Richard Posner somewhat caustically observed: "No doubt they like the favorable connotations of the term 'corrective justice'—why else use it?" 835

The consequence of these efforts was a great diversity in the understanding of the notions of distributive and corrective justice. In view of the extremely vast literature on the topic in relation to tort law, as well as in relation to other fields, a detailed analysis of all the different views would become cumbersome and not very productive. ⁸³⁶ We will, therefore, limit ourselves to the more fundamental aspects of the discussion.

A special and quite vexing problem of Aristotle's analysis of corrective justice was raised by the relation between gain and loss. Aristotle himself noted that these terms are not always appropriate:

For the term "gain" is used in a general way to apply to such cases, even though it is not strictly appropriate to some of them, for example to a person who strikes another, nor is "loss" appropriate to the victim in this case; but at all events the results are called "loss" and "gain" respectively when the amount of the damage sustained comes to be estimated.⁸³⁷

It follows that Aristotle was of the opinion that the terms of loss $(\zeta \eta \mu i\alpha)$ and gain $(\kappa \epsilon \rho \delta o \zeta)$ are not quite appropriate in delictual situations. But he still considered the result of the injurious act as a form of gain and loss. However, from an economic, material point of view, it often happens that the

loss caused to the victim is disproportionate to the gain of the actor, even if the notion of gain is conceived in its broadest sense. Aristotle did not explain how the principle of arithmetic proportion (in the sense of symmetry) of corrective justice can be maintained in the case where the injured person's loss exceeds the wrongdoer's gain. 838

The difficulty did not escape the pre-modern scholars, and, as we have seen, some of the post-scholastic commentators on Aristotle have applied great intellectual efforts in order to give sense to the notions of equalizing loss and gain in delictual situations, or, in Aristotle's term, in involuntary transactions. The problem received a renewed actuality in the writings of the modern tort scholars dealing with the foundations of corrective justice. Some authors, being critical of Aristotle's comprehensive conception of the necessary correlation between gains and losses in corrective justice situations, suggest to abandon this notion in delictual, 839 as well as in restitutionary contexts. 840

Here again, Ernest Weinrib suggests to reinterpret Aristotle's original notions in the Kantian spirit.⁸⁴¹ In his view, the correlativity of gain and loss in

corrective justice has to be understood normatively rather than materially. At the heart of corrective justice, linking the two parties lies the correlativity of the normative categories of right and duty, as established in the Kantian legal theory. Another author suggests reinterpreting the notions of loss and gain in a material way: The wrongful gain lies in the tortfeasor's acquisition and exertion of utter dominance over certain portions of the material world, namely, over the body or property of the victim. This gain corresponds to the loss of control by the victim. The amount of damage to the victim indicates the degree of the involuntary transfer of control between the parties. At the degree of the involuntary transfer of control between the parties.

Another issue that got prominence in the modern discourse concerns the exact relationship between corrective justice and distributive justice. ⁸⁴⁴ Thus, it has been suggested that, since the function of corrective justice is merely to restore the original position of the parties, this form of justice is secondary in importance to distributive justice that determines the original position. ⁸⁴⁵

This specific topic received renewed interest in more recent times. According to what appears to be the dominant view among contemporary scholars, corrective justice presupposes the existence of entitlements which, presumably, are the creation not of corrective justice itself but of distributive justice. Hence, the function of corrective justice is to preserve a given distribution of wealth. In this sense James Gordley declares that "according to Aristotle, distributive justice secures a fair share of resources for each citizen. Commutative or corrective justice preserves that share."

The autonomous character of corrective justice in the tort context has been denied by Joseph M. Steiner, on the basis of an additional, related argument, namely, that the definition of "improper" conduct is necessarily in distributive terms: what do I have a right to do; what do I have a right to be free of ⁸⁴⁸ The author affirms:

The right to act in certain ways and the right to be saved harmless from the consequences of certain conduct are as much forms of wealth as a piece of land or a sum of money. Thus the notions of corrective and distributive justice merge. The object of this branch of the law is to define that what is the victim's and to restore it to him if it has been taken away without his consent.⁸⁴⁹

This basic view has been forcefully contested by Peter Benson, who claims that corrective justice must consist in a specific mode of correcting violations of entitlements that is wholly rooted in a distinctive yet self-sufficient nondistributive justificatory structure. Distributive justice could also be said to postulate a mode of correction of its own: persons should receive what is their due according to the distributive criterion. "Correction takes its 'corrective' or 'distributive' character from the specific nature of the notions of entitlement and equality." The author then proceeds to develop a "reasonably systematic justification of the nondistributive conception of entitlement." That is consistent with the Aristotelian notion of corrective justice. Assuming that neither Aristotle nor Aquinas have addressed this problem, the author uses philosophical premises of Kant, Hegel, and Rawls ("abstract right," "personality," "constructivism"), in order to establish the moral justification of the nondistributive entitlement that is at the basis of corrective justice equality. The author then deals, in relation to first principles of justice for transactions, with bodily

integrity, first and derivative acquisitions.⁸⁵³ In the final part of his essay, the author suggests that his constructivist theory of corrective justice does not rule out Rawls's substantively egalitarian conception of distributive justice.⁸⁵⁴

The idea of the autonomous character of corrective justice has been maintained by additional contemporary scholars—such as Ernest Weinrib, Stephen Perry, and Martin Stone—though with partly different argumentations. Thus, Weinrib claims that even if holdings were intelligible solely as distributive justice, the dependence of corrective justice on a previous distribution does not diminish the autonomy of the two forms of justice. The fact that corrective justice must accept the distribution as given does not mean that the justification of the distribution is an aspect of justification in corrective justice. What matters for corrective justice is that the distribution exists, not that the distribution is justified. Corrective justice's mode of justification can operate against the background of a distribution without incorporating into its justificatory structure the justification of the distribution. S55 Otherwise, corrective justice becomes a species of distributive justice, which runs counter the Aristotle's postulate of their being two separate forms of justice.

Stephen Perry, dealing with corrective justice in relation to tort law, equally maintains its autonomous character by relying on the notion of harm. ⁸⁵⁷ In Martin Stone's view, the equality of corrective justice in the tort context signifies "to treat

the parties as equals by according equal status to their interests in acting (which includes their interest in being free from injurious interferences)."858

One author adopts a completely different approach: He claims that in view of the protective function of tort law achieved by means of establishing primary (tort) duties, the corrective justice interpretation of tort law—at least in the common law context—has to be completely rejected. The author does not refer directly to the Aristotelian distinction, and, as a matter of fact, his conception of corrective justice, based exclusively upon the views of some modern tort theorists, is rather remote from the traditional understanding.

Since we do not intend to take position in this protracted controversy, we will limit ourselves to a general remark in relation to the view that commutative justice is secondary in importance vis-à-vis distributive justice. In our opinion, there are two relevant considerations in respect to that issue. First, why should an original distribution of goods be more important in terms of justice than the restoration of deprived goods? From a general, political point of view, it may be different, but justice is in my eyes much more important in its remedial function than in its distributive one. Second, the distinction between the two functions is from a positive-normative view far from being clear-cut. Seen from a purely formal point of view, legal norms are defined by their sanction. As a result, the original distribution of entitlements can only be determined by the remedial potential of the legal system. In other words, legal rights are co-extensive to their remedy: Ubi remedium ibi ius. This is most obvious in those cases where the object of the right is from the beginning in a person's possession, such as the body itself. The right to bodily integrity may be conceived as being part of an original division, but its actual extent is generally determined by corrective justice. 860

This brings us to an issue that is related to the foregoing one: the classification of restitutionary duties in relation to the two forms of justice. As we have seen, in Aquinas's view, restitution is necessarily always an act of commutative justice. Ref Many scholastic theologians have defended this conclusion of Aquinas. More recently, it has been argued that the identification of every restitutionary duty with commutative justice is a misfortune of history. In truth, so the argument goes, where a person received more than his due according to the criterion of distributive justice, his duty of restitution is still substantially founded in distributive justice. It is merely the exterior, formal process that corresponds to corrective justice; the moral dimension, the "soul" of the ought remains to be distributive justice.

A number of modern authors go much beyond this argument: they maintain that restitutionary claims, even if based on corrective justice, cannot be isolated from distributive considerations. According to their more comprehensive theory, corrective justice, as such, is subject to social policies. ⁸⁶⁵ This approach raises the fundamental question of the relationship between the two forms of justice, being mutually exclusive or complementary. To this problem we will now proceed.

The actual question is whether two forms of justice can be applied simultaneously in a given situation. As we have seen in the scholastic literature, many authors have assumed the possibility of their active coexistence in a number of specific circumstances. In this sense, John Finnis affirms that "the distinction between distributive and commutative justice is no more than an analytical convenience, an aid to orderly consideration of

problems. 866 Many actions are both distributively and commutatively just (or unjust). Speaking of the act of the judge in giving a judgment, the author states:

The biased or careless judge violates distributive justice by using an irrelevant criterion (or by inappropriately using a relevant criterion) in apportioning the merits and awarding judgment and/or costs. But, finally, we can also consider the judge's duty to apply the relevant legal rules; in this respect his duty is one of commutative justice: faithful application of the law is simply what is fitting and required of him in his official dealings with others.⁸⁶⁸

This approach clearly resounds the voices of those scholastics who have defined the function of officials as based on a commutative duty toward the state.⁸⁶⁹

However, the possibility of combining in one substantive legal solution the two forms of justice has been strongly denied by some modern authors, principally amongst them Ernest Weinrib:

Because corrective and distributive justice are categorically different and mutually irreducible patterns of justificatory coherence, it follows that a single external relationship cannot coherently partake of both. Aristotle's contrast of corrective and distributive justice does not determine whether the law should treat an incident correctively or distributively. But if the law is to be coherent, any given relationship cannot rest on a *combination* of corrective and distributive justifications. When a corrective justification is mixed with a distributive one, each necessarily undermines the justificatory force of the other, and the relationship cannot manifest either unifying structure. 870

Many scholars adopt an opposite view, maintaining that the two forms of justice can be legitimately combined, or even necessarily interact. Thus, Richard Wright asserts that "contrary to Weinrib's assertion, distributive justice claims and corrective justice claims may not only coexist in the same body of law, but also may apply simultaneously in the same situation." Interestingly, a similar idea has been adopted by Lord Steyn in one of his speeches in the House of Lords:

The truth is that tort law is a mosaic in which the principles of corrective justice and distributive justice are interwoven. And in situations of uncertainty and difficulty a choice sometimes has to be made between the two approaches. In my view it is legitimate in the present case to take into account considerations of distributive justice.⁸⁷³

Referring to Lord Steyn's statement, Justice Crennan of the High Court of Australia remarked:

The Aristotelian backdrop to the notions of "corrective justice" and "distributive justice" was a community whose common good included laws, both reflecting the community's common values and enabling individual members to achieve reasonable objectives. However, there remains a problem in Aristotle's analysis, relevant to this submission. In emphasising "corrective justice," even as added to by his consideration of "distributive justice," Aristotle left unexplored the dependence of "correction" on the prior establishment of principles (footnotes omitted). 874

It is noteworthy, that the Aristotelian distinction—notwithstanding the vast scholarly literature—has been mentioned in relatively very few judicial decisions.⁸⁷⁵

Beneath the scholarly controversy, whether the Aristotelian forms of justice are mutually exclusive or may be legitimately combined, lie a number of different important theoretical and ideological premises and objectives. On the more theoretical level: Purism, formalism, postulates of intelligibility, and

coherence clash with pragmatism and pluralism; on the more ideological, political level: Individualism, right-oriented personal autonomy contrast with instrumentalism, utilitarianism, economic efficiency, and social justice. Some authors rely directly on the Aristotelian distinction in order to buttress their premises and objectives, ⁸⁷⁶ others take it as a mere starting point, and others again contest its very correctness or relevance. ⁸⁷⁷ Our own view is that, whatever may be the exact relationship between the two forms of justice, the reality of law is a pluralistic normative system of contrasting values, combining specifically in tort law distributive and corrective justice considerations. ⁸⁷⁸ However, a critical analysis of all these different theoretical, philosophical, and ideological approaches lies far beyond the scope of this work. ⁸⁷⁹ The amazing fact is the centrality of the Aristotelian forms of justice in this modern controversy. No wonder that it succeeded in provoking a harsh negative reaction by some contemporary scholars. ⁸⁸⁰

As we reach the twenty-first century, however, it seems appropriate we acknowledge that modern corrective justice scholarship with its nine-teenth-century conceptual apparatus is... an anachronism and should be treated as such. It should be relegated to a historical footnote in casebooks and anthologies of tort scholarship. Like a Model T Ford, the corrective justice approach may be interesting for some to look at—or even to tinker with—but few will view it as a way to get anywhere important.⁸⁸¹

Finally, it is noteworthy that Aristotle's notion of *antipeponthos* (reciprocity) has equally been revived in the modern context, and rather surprisingly in relation to globalization. SS2 Based on a short observation of Aristotle, the scholar Giampaolo Azzoni relates that kind of justice, called by him "catallactic justice," to the three Graces. Indeed, Aristotle writes in connection with *antipeponthos* the following:

This is why we set up a shrine of the Graces in a public place, to remind men to return a kindness; for that is a special characteristic of grace, since it is a duty not only to repay a service done one, but another time to take the initiative in doing a service oneself.⁸⁸⁴

Azzoni then goes on to analyze the historical interpretations and iconography of the three Graces. He starts with classic authors of the antiquity, such as Chrysippus and Seneca, 885 continues with Shakespeare and Goethe, 887 and ends with modern scholars. His conclusion is that reciprocity is under

the protection of the Graces and is implemented through the spontaneous initiative of men. It can be applied to persons who are citizens of different states. The normative relationship of justice as reciprocity is a threefold one (like the Graces and according to Aristotle's statement that "proportional requital is effected by diagonal conjunction"888): Person A, who satisfied a need of a second person B, acquires a "claim" that a third person X will satisfy a need of his in the measure of the benefit given by him to B. On his part B, whose need has been satisfied by A, acquires a "duty" to satisfy a need of a third person X, in the measure of the benefit received by him from A. Hence, in case of justice as reciprocity, the relationship is not exhausted bilaterally, but opens itself to third party. In this sense, justice as reciprocity is different from both contract and donation. The image of the Graces seems to be consistent with some of the new requirements of the era of globalization, by being apt to produce some indications for interventions in the world that go beyond the bipolar relationship of the universal-particular. 889

Conclusion

OUR JOURNEY THROUGH THE WRITINGS OF many generations of scholars on the Aristotelian distinction of distributive and corrective justice has reached its final destination. We have seen the enormous and fascinating intellectual efforts to understand, analyze, and apply the classical text. What is the conclusion? We certainly have no intention to determine the "correct" view about the Aristotelian notions of justice. This we leave to the individual reader if such an aspiration lies in his or her mind. The specific interpretations, evaluations, and applications of the two notions of justice are deeply imbedded in the culture and intellectual atmosphere of a given period of time as well as in the personal conviction and ideology of the individual scholar. On the other hand, concepts may shape the intellectual atmosphere and personal convictions. In other words, form and substance interact and intermingle. This insight lies at the basis of the method of Begriffsgeschichte, the history of concepts. We, therefore, will make an attempt to summarize in short the conclusions that derive in this sense from our description of the scholarly views throughout the ages.

Let us start with the revival of the Aristotelian Ethics in the period of Christian High Scholasticism (thirteenth to fourteenth centuries). The central figure is the Dominican Thomas Aquinas, the disciple of Albertus Magnus. Aristotle is viewed as an important authority in philosophy in general, and in ethics in particular. Aquinas analyzed the major problems created by the Aristotelian distinction and his answers defended the classical text. He concluded that retribution is at the basis of corrective justice. However, Aquinas introduced a substantive notion of justice that was oriented toward the common good, conceived ultimately in a religious sense. His theological outlook is also responsible for his view that Divinity cannot be subject to corrective justice. The interesting phenomenon is the subjection of the conceptual notions of justice under the theological premises concerning the absolute nature of Divinity. Another influence of the religious background consisted in the clear separation between the legal and a

merely moral dimension of justice. The latter concerns exclusively the actor's conscience.

The Franciscan John Duns Scotus tended to view punishment as part of distributive justice and affirmed that distributive justice can be in God in an unqualified sense. Finally, the French scholar Jean Buridan denied the difference in kind between the two forms of justice.

The subsequent vast scholastic literature was clearly dominated by the work of Thomas Aquinas. He was considered to be an authoritative source for the right understanding of the Aristotelian distinction. The best legal minds of Dominicans, Franciscans, and, prominently, of Jesuits, as well as of members of some other religious orders, were discussing the right understanding of the Aristotelian distinctions. Since the different views on the formal notions of (human) justice didn't imply any basic theological differences, the ensuing controversy didn't provoke the tensions between Dominicans, Franciscans, and Jesuits that we encounter in some theological disputes.

A major topic of the discussion was the essential elements of the distinction between corrective (commutative) justice and distributive justice. The traditional assumption was that the principal distinctive element was to be found in the difference of proportions, arithmetic versus geometric equality. This assumption was weakened by a number of contrary practical examples: corrective-justice-situations where a geometric proportion is applied, such as contractual distribution of profits among partners according to the proportion of the respective investment; distributive-justice-situation where an arithmetic proportion is applied, such as in relation to a single candidate or benefit.

Though many scholars maintained that in these situations one has to distinguish between an essential and a merely accidental feature, one can discern a shift to an alternative distinctive element: the intensity of the right and the duty under the respective kinds of justice. Accordingly, only under commutative justice there was a perfect duty-right relationship; distributive justice created a much weaker claim against the distributor. This idea originated in the recognition that the prince or ruler, when distributing public honors, functions or benefits, enjoys a great measure of discretion that is beyond legal control.

Moreover, some scholars started from the political thesis that the (absolute) ruler is above the law. Consequently, it was assumed that the violation of distributive justice, as such, does not entail a legal sanction of compensation. The logical result of that view was that in any case where a duty of compensation was to be recognized, its foundation had to be in commutative justice. Another consequence of this approach was that the very dichotomous

character of the distinction was considerably weakened: many scholars saw no problem in defining certain legal situations as a combination of the two forms of justice. Nevertheless, the great majority of scholastic scholars explicitly rejected Jean Buridan's view that denied the difference in kind between the two forms of justice. A few scholars even suggested that the great difference in the intensity and the nature of the respective rights turns the application of the notion of justice to both of them into a mere analogy, since they are not of one identical kind (*species*) of justice.

The classification of punishment was the object of a permanent controversy. The loyal Thomists defended Aquinas's view that it was part of commutative justice; the Scotists tended to view punishment as belonging to distributive justice. Many scholars suggested that the imposition of judicial punishment was a combination of different kinds of justice, some of them maintaining that vindictive (punitive) justice constitutes a separate kind of justice. All these discussions have continued to occupy also neo-scholastic Catholic moralists. It is noteworthy that some modern authors claim—especially when dealing with the notion of social justice—that rights under distributive justice are no less stringent than those under commutative justice. These authors conceive social justice to constitute part of distributive justice.

The Aristotelian distinction played a major role in the theological controversy about the nature of divine justice to which we dedicated a special chapter. The fundamental question was whether between God and the human creatures there could be a justice relationship, and if yes, what was the exact nature of this relationship.

The opinions among the theologians were deeply divided. Most of them assumed—following Aquinas—that God was not subject to commutative justice, since that would imply a strict right-duty relationship. Such a relationship was excluded in the light of God's omnipotence and sovereign dominion over His creatures. In view of the fact that distributive justice did not entail an obligation toward the recipient, it could, according to this view, be applied in relation to Divinity. However, some theologians even denied the possibility of a distributive-justice-relationship between God and human beings. On the other hand, a few theologians took the opposite view: Assuming a specific promise of God—such as eternal life to the just—it could be binding upon Him. Hence, God could be fully subject to both forms of justice. Some theologians adopted a medium way: The justice relationship between God and man was essentially different from that existing between human beings, but it nevertheless had some aspects of distributive and commutative justice.

The theological premise that the absolute perfection of divine justice made it essentially different from human justice accorded the theologians a great measure of flexibility in applying the Aristotelian distinction. It enabled them—each according to his specific theological tenets—to integrate divine justice with the divine attributes of omnipotence, grace, and mercy. It is noteworthy that Reformed scholars continued to rely on these Catholic scholastic discussions—even if in a more critical way—in order to resolve the theological problems connected to the notion of justification. A special theological problem constituted the intertrinitarian relationship between God and Christ; also here the existence of a commutative-justice-right was a matter of controversy.

The chapter on Jewish commentators illustrates the tendency to link the elements of the Aristotelian distinction to the substantive principles of Talmudic sources. However, in view of the enormous quantity of rabbinical legal literature, the barely handful of relevant commentators demonstrates the scanty interest of Jewish scholars in the formal definition of justice. This general tendency against categorial legal thinking was later enhanced by the anti-philosophical attitude of the dominant movement of Jewish mysticism, the Kabbala.

The chapter of post-scholastic writers concentrates on the works of humanists and of some outstanding representatives of the Enlightenment. The Aristotelian distinction constituted still an important topic but less in its theological context. The authors' eyes are turned directly toward the Aristotelian text and the classical sources. Their look became more critical and to some extent more pragmatic. Justice was brought into connection with economic and utilitarian considerations. A major topic was the classification of punishment. The solutions continued to differ: some viewed it as commutative justice, some as distributive justice, and some as a third, separate kind of justice.

An additional trend was the emphasis on Roman law in general, and Ulpian's definition of justice in particular. Among the great names treated in this chapter are: Philipp Melanchton, Jean Bodin, Hugo Grotius, Thomas Hobbes, Samuel Pufendorf, Giambatista Vico, and Gottfried Wilhelm Leibniz. The common denominator of these outstanding scholars was not only a most extraordinary, creative intellectual capacity, but equally an independent, critical mind toward the hitherto considered authoritative classic philosophers, such as Aristotle.

We open the modern age with the middle of the eighteenth century. The modern tendency distanced itself from the notion of justice as a moral virtue in the Aristotelian sense; it inclined to relate justice to law as a public institution. This is most prominent in Kant's philosophical analysis of the classic distinction. An additional consequence was the linkage of the Aristotelian forms of justice to the Roman distinction between public and private law. As a matter of fact, the formal categories lost much of interest in the eyes of the nineteenth-century German Pandectists who concentrated their attention on the Roman law heritage. True, Aristotle's ethical works remained an object of great scholarly interest in the nineteenth and twentieth centuries; but in the spirit of the time, the great intellectual efforts were invested into the philological, textual, and editorial problems of these philosophical writings according to the so-called methods of "higher" and "lower" criticism. A major objective was the correct understanding of Aristotle's original intentions.

In any event, the Aristotelian formal notions of justice lost most of their actual relevance. An amazing change occurred in the early 1980s in U.S. legal scholarship. The immediate trigger was the challenge of the economic approach to tort law that had won important scholarly support in the recent preceding years. It constituted a major attempt to ground tortious liability on instrumentalist foundations that were said to further social utility.

Consequently, it clashed with the traditional view that considered the foundation of tortious liability to be based upon moral blameworthiness. The opponents of the economic approach relied upon the Aristotelian distinction between corrective and distributive justice, arguing that the instrumentalist foundation of liability, by introducing distributive aims, violated its corrective justice foundation. The connotation was that public law penetrated illegitimately into a private law conflict.

Viewed from a historical perspective, the use of the distinction as a normative tool for examining the legitimacy of substantive solutions seems to be quite a novelty. The high scholastics, the late scholastics, and the post-scholastics, all used the positive law as a criterion for the correctness of the distinction, and not the other way around. Their endeavors were aimed at the correct understanding of the Aristotelian notions of justice and of their application in practice. The substantive argument, based on the notion of corrective justice, which was now raised against the instrumental-economic approach in tort law, gained prominence, and provoked a protracted scholarly controversy.

The result was a direct return to Aristotle's original text and its renewed analysis on the background of the actual debate. Apart from very few limited exceptions, the millennial treatment of the Aristotelian distinction was completely disregarded. The intellectual effort was directed to different

aspects of the two forms of justice, depending upon the respective scholar's basic conception concerning tort liability's foundation. The challenge of tort liability's conformity to corrective justice was taken most seriously by many U.S. tort scholars. Hence, the great intellectual effort applied by them to reconcile their suggested substantive solutions with the assumed requirements of corrective justice.

A precondition to this discourse was naturally the right understanding of the two notions of justice and their relationship to the substance of law. The result of these inquiries was a vast literature and a great diversity of views. The age-old questions reappeared and exerted the minds of jurists and philosophers. Among these questions we find the following ones: The correlation between gain and loss in corrective justice; the problem of the autonomous character of corrective justice in relation to distributive justice; the classification of restitutionary duties in relation to the two forms of justice; the question whether the two forms of justice can be applied simultaneously in a given situation.

It is evident that the contrasting answers given to these questions are influenced by the individual scholar's theoretical and ideological premises and objectives. One could define the opposite values involved on the more theoretical level in the following summary way: Purism, formalism, postulates of intelligibility, and coherence clash with pragmatism and pluralism; on the more ideological, political level: Individualism, right-oriented personal autonomy contrast with instrumentalism, utilitarianism, economic efficiency, and social justice. The overriding issue seems to be the relationship between form and substance.

Finally, echoes of the scholarly, modern discussions on the Aristotelian distinction have recently been sounded in the courts in Great Britain, Ireland, Australia, New Zealand, and Israel. In all probability, once the classic distinction has recaptured the minds of legal scholars, it will remain with us for quite a time.

The Iconography of the Aristotelian Distinction

THROUGHOUT THE AGES, the image of justice pervades art in all its variegated manifestations. Its worldwide spread is a sign of justice's centrality in human society. However, the artistic representation of the two Aristotelian forms of justice is relatively rare. We will concentrate on two major examples: 1) The very famous fresco cycle, painted by Ambrogio Lorenzetti in the years 1338–1340, decorating the Sala dei Nove in the Palazzo Pubblico of Siena, the council-room of the Sienese government; and 2) Two illustrated manuscripts, dating from the 1370s, of Aristotle's *Ethics* in French from the library of King Charles V of France. The king commissioned the translations of Aristotle's Latin texts into French from the important scholar Nicole Oresme (ca. 1323–1382).

% Lorenzetti's Frescoes in Siena

Three walls of the council-room in Siena are covered with the fascinating frescoes of Ambrogio Lorenzetti (1295–1348). They represent the allegories of the Good Government (Buon Governo) and the Bad Government (Mal Governo). Under the Bad Government, the bound female figure of Justice

writhes at the feet of the demonic Tyrant, her scales lying on the ground. In the depiction of the Good Government on the northern wall of the room, the figure of Justice appears twice.

To the extreme lefthand side of the enthroned ruler, symbolizing the City of Siena, ⁸⁹¹ sits as a crowned counselor, the cardinal virtue *Iustitia*. Dressed in a red robe, she holds upright in her right hand the sword; below the sword's handle lies on her knee the severed head of a bearded man. In her left hand she holds a crown. As a virtue, Justice appears to relate to the governance of the depicted ruler.

It seems, therefore, that the ruler exercises justice by punishing the delinquents and rewarding the just. ⁸⁹² The severed head and the crown symbolize these two functions. As we will see, these functions are actually carried out in the other, more central figure of justice, by an angel who represents the distributive justice.

The question is, of course, why the double representation of justice in the painting? One author, indeed, notes that he cannot think of any other medieval

work of art or text which contains two Justices, excluding instances involving separation into subcategories, such as commutative and distributive justice. System Moreover, to his knowledge, Justice's attributes of the severed head and proffered crown are not found beyond Ambrogio's mural and its close sphere of influence in Siena. He had author's view, the central figure of Justice, at the right hand of the ruler, is of a higher, celestial order; she is the "santa virtù." The other figure is a lesser, strictly secular Justice.

The intention of introducing two Justices was to separate Heaven's role in civic good government, which was still clearly acknowledged, from that belonging to man. ⁸⁹⁶ According to another view, the central figure illustrates the idea of justice or fairness as the essence of law; the other figure depicts justice as a personal attribute, hence as a separate concept. ⁸⁹⁷ In the same line of ideas, it has been suggested that the great figure of justice symbolizes a value that relates to the whole community, whereas the smaller one concerns the just conduct of the individual citizen or of the magistrate. ⁸⁹⁸

In our view, the interpretation is somewhat different. Since decapitation and crowning in the central figure of justice are specifically designed as acts of distributive justice, the crown in the hand of the smaller figure and the severed head below her sword appear to be equally the elements of distributive justice. Aristotle and Aquinas, distributive justice is basically a function of the ruling authority. Since in Lorenzetti's view, punishment makes part of distributive justice, the virtue of distributive justice—like the other seated virtues in the painting—belongs to the function of the ruler, here symbolizing the community of Siena. This explains, in our opinion, the absence of commutative justice in this figure of justice.

Let us now turn to the central female figure of Justice in Lorenzetti's painting. She sits enthroned at the right hand of the ruler in a way that underlines her independent nature. She is the second largest figure, her open eyes turned upward to the crowned, celestial, winged figure of Sapientia, Wisdom. In a half-circle around Justice's blond head appears a text in golden letters: "Diligite iustitiam qui iudicatis terram"; it reproduces the Latin translation of the opening verse in Greek of the apocryphal Book of Wisdom of Solomon: "Love justice, you who judge the earth."900 A large balance encompasses the figure of Justice. The figure of Heavenly Wisdom holds in her right hand the top of the balance's stem, its bottom is placed on the crowned head of Justice. The thumbs of Justice rest slightly on the sides of two scales keeping them in equilibrium. Each of the scales contains a winged, angel-like figure, both kneeling toward two larger men who are situated on the ground directly before them. Over these figures appear identifying texts; the one on Justice's right side reads "Distributiva," the other on her left side "Commutativa." Below Justice, in a less imposing chair sits the figure of Concordia. On her lap she holds with one hand a large carpenter's plane, signifying the smoothing of differences. Through her other hand runs a cord combining two strings, one coming down from the pan of commutative justice, the other from that of distributive justice. 901 The cord is transmitted to the 24 representatives of the Siena community and is ultimately knotted to the wrist of the ruler who holds upright his sceptre. This connection seems to demonstrate the governing authority's binding commitment to justice.902

Let us now have a closer look at the figures representing the two Aristotelian forms of justice. Their understanding has perplexed many scholars and a variety of contrasting interpretations have been suggested. On Justice's right side—under the title "distributiva"—the angel-like figure in red, kneeling in the pan, deals with two men: the one on her right, turning his back and neck toward her in a bowing position, arms bound behind him, is

about to be decapitated by the sword she holds in her right hand. Blood starts flowing from his neck where touched by the sword. Besides the man lie his weapons. The other man, kneeling and bowing in the direction of the angel, holds in his right hand a palm frond. He is in the course of being crowned by the angel.

On Justice's left side—under the title "commutativa"—the angel-like figure in white, kneeling in the pan, equally deals with two men. They confront the angel in a half-kneeling position, the conventional posture of donors, looking straight into her face. The one man is extending a cylindrical object to the angel, into which the latter puts her right hand. The other man holds two lengthy, stick-like objects, the angel grasping them with her left hand. This basic description of the depicted scenes is practically accepted by all, 903 as well as the portrayal's affinity to Giotto's figure of Justice in the Arena Chapel in Padua, the Cappella degli Scrovegni (1303–1309). 904

However, two major problems have occupied the scholars, provoking a protracted controversy. The one relates to the scene of distributive justice: the inclusion of punishment under this heading has puzzled the scholars, since, as Quentin Skinner observes, "neither in the *Nicomachean Ethics*, nor in Aristotle's later analysis in the *Politics*, nor in any of Aquinas's comments on these texts is it ever suggested that Aristotle's concept of *iustum distributivum* is connected with the infliction of punishment."905 The second problem concerns the simple understanding of the commutative justice scene, namely, what is the exact nature of the objects in the hands of the figures, and what is the significance of their acts? Briefly, what is going on in that scene?

In relation to the first problem, a radical solution has been suggested by Chiara Frugoni: During a restoration process of the painting, the titles of the scenes have

been mistakenly exchanged. Oh As a result, the original commutative justice scene has subsequently been wrongly entitled "Distributiva." This solution is not only historically doubtful, but creates no less serious problems for the understanding of the now exchanged scences of distributive and commutative justice.

Other scholars have looked for early sources that may have induced Lorenzetti to depict punishment as being part of distributive justice. Thus, Quentin Skinner considers, as already mentioned, the pre-humanist encyclopaedic *Li Livres dou tresor*, compiled by Brunetto Latini in the early 1260s, as a major source of inspiration to the painting. The German historian Ulrich Meier is of the opinion that Lorenzetti's motives of distributive and commutative justice are more in accordance with the explications of Albertus Magnus in his vernacular *Augsburger Predigtzyklus* (1257–1263). In our view, the answer to the problem is not too difficult. As our study has shown, there was a broad scholastic trend that classified punishment under the heading of distributive justice, a major source being Duns Scotus (ca. 1265–1321). It is highly probable that this quite common scholastic conception reached Lorenzetti.

The interpretation of the commutative justice scene has equally been controversial. However, most scholars agree that it represents a peaceful

transaction between citizens under the guidance of the angel-like figure. Some assume that the objects, exchanged between a metal worker and a draper, are spears or lances and a bale of cloth. 912 Others identify the cylindrical object as a strongbox filled with money (*forziere*). 913 According to another view, the objects present two official measures of weight and length, namely the cylindrical object a *staio* (bushel) 914 and the two staffs a *canna* and a *passetto*. 915 Though the exact identification of the objects continues to constitute a problem, 916 the scene most certainly presents a commercial exchange. 917

% The Miniatures in Nicole Oresme's French Translation of Aristotle's Nicomachean Ethics

As mentioned, the King of France Charles V ordered from Nicole Oresme (ca. 1323–1382) a vernacular translation of Aristotle's Ethics. In the manuscript (1370–1375), kept at the Royal Library in Brussels, a miniature illustrates the Aristotelian notions of justice. The miniature is divided into two registers; the upper zone depicts Legal or Universal Justice; the lower register illustrates Particular Justice, divided into Distributive and Commutative Justice. The illustrations follow rather closely Aristotle's definitions and are, therefore, not as enigmatic as Lorenzetti's frescoes. Moreover, its context is secular and earthbound. The preponderant, crowned, and upright female figure of Justice

Légale shelters under her spread mantle six daughter-like smaller figures; four are named: Fortitude, Justice Particulière, Mansuétude (Gentleness), and Entrepesie (Conciliation). The kneeling figure of Particular Justice holds upright in her hand a sword.

The representation in the lower half of the miniature of the two forms of particular justice emphasizes their concrete function. On the left side, situated in a tricolor quadrilobe, the female figure of Distributive Justice stands behind a table that is covered with stacks of gold coins, vessels, and documents. These items symbolize the common goods to be distributed according to merit. Identified by the inscription unfurling above her head, she bears a widow-like headdress. Her right hand is upraised in a reflective gesture, her left one placed on the pile of coins in front of her on the table. Her head is turned toward four rectangular measuring rods representing the proportional equality of 6:3 = 4:2. These proportions are marked in (Roman) numbers on the short projecting sides of the proportionate rods. To her right stand four male figures, two of them depicted full length. The one closer to the figure of Distributive Justice holds a pile of coins and a document bearing a red seal. The other man holds a gold chalice.

We have, therefore, here a visual demonstration of the proportions indicated on the measuring rods: two awards (coins and document) as against one object (chalice). The act of distribution does not seem to have been terminated, given the actual attitude of Distributive Justice and the expecting glances of the recipients.

On the lower right quadrilobe, the miniature presents a scene of commutative justice. The female figure at the center appears to be a twin sister of Distributive Justice: She is equally dressed bearing an identical widow-like headdress. But her function is different. She acts as a judge between two litigants. The one to her left appears to be a tonsured cleric, the one to her right a fashionably dressed secular figure. Behind the litigants are bystanders or witnesses. Commutative Justice has her hands crossed in an act of taking something away from the one litigant and giving it to the other. Her position is one of evenhandedness and impartiality. From the expression of the litigants' respective faces, it seems that the secular person is on the receiving, winning side. Justice looks at the cleric with what could be viewed as an expression of compassion. 919 Justice touches the hands of the litigants, but

there is no material object of exchange. Visual instruments of commutative justice are suspended above the figures of the litigants. Over the head of the secular litigant is a balance; on the side of the cleric hang a scourge and a stock, and on the floor between him and Justice rests an axe. These instruments symbolize the function of commutative justice: equality and impartiality in commercial transactions and especially in punishment. By classifying punishment under the heading of commutative justice, the manuscript follows the approach of Thomas Aquinas.

Finally a few remarks on the second manuscript of Oresme's translation, kept at the Rijksmuseum in The Hague, containing a parallel miniature executed by a different illuminator in 1376.920 In the top zone, a non-crowned Justice légale, shelters with her mantle the virtues. This time they are seven, not identified, standing female figures.⁹²¹ Another, more substantial change concerns the scene of distributive justice. Here, Justice apparently adjudicates claims of two parties, one, on the left side, represented by two clerics, the other one on the right side represented by a pair of secular people. Contrary to the first manuscript, on the table there are no gold coins, vessels, and documents to be distributed. On the table before the clerics lies a gold miter and before the secular people a sword. Justice holds a balance in her hand and the inscription at the bottom reads: "departir a chascun selon les merites" ("distribute to each one according to his merits"). Our impression is that there are no directly conflicting claims between the opposite parties, but each asks for a distinct public function; the clerics for the authority of bishopric, symbolized by the miter, and the other people for a secular authority, symbolized by the sword. Justice weighs each side's merits independently.922

In the scene of commutative justice, the figure of Justice sits upright looking straight forward, holding in her left hand a balance and in her right hand a sword. Below her the inscription reads: "rendre a chascun le sien" ("to render

each one his due"). On both sides of her are figures who are described as "advocas et tesmoins" ("lawyers and witnesses"). Above their heads on the left side the inscription reads: "discussion," on the right side: "execucion urgens." The scene depicts, therefore, an actual trial, the lawyers submitting their arguments and awaiting the just and impartial judicial decision of Commutative Justice that will be executed without delay.
